# Report of the Third Committee

Rapporteur: Mr, Wilfried GROLIG (Federal Republic of Germany)

# I. INTRODUCTION

1. At its **3rd** p enary meeting, on 22 September 1989, the General Assembly, on the recommendation of the General Committee, decided to include in its agenda the item entitled:

"Office of the United Nations High Commissioner for Refugees!

"(a) International Conference on the Plight of Refugees, Returnees and Displaced Persons in Southern Africa:

"(b) International Conference on Central American Refugees)

"(c) International Conference on Indo-Chinese Refugees"

and to allocate it to the Third Committee.

2. The Committee considered the item at its 44th to 47th, 49th and 56th meetings, from 15 to 17 and on 20 and 27 November 1989. An account of the Committee's discussion is contained in the relevant summary records (A/C.3/44/SR.44-47, 49 and 56).

4. At the 44th mooting, on 15 November, the Officer-in-Charge of the Office of the United Nations High Commissioner for Refugees and the Under-Secretary-General for Special Political Questions, Regional Co-operation, Decolonisation and Trusteeship made introductory statements (see  $\lambda/C.3/44/SR.44$ ).

5. At the 47th meeting, on 17 November, the Officer-in-Charge of thr Office of the United Nation8 High Commissioner for Refugees made a concluding statement (see  $\lambda/C.3/44/SR.47$ ).

## II. CONSIDERATION GF PROPOSALS

## A . Draft resolution A/C.3/44/L.63

6. At the 49th meeting, on 20 November, the representative of <u>Lesotho</u>, on behalf of the States Members of the United Nation8 that are members of the Group of African States, introduced a draft resolution ( $\lambda/C.3/44/L.63$ ) entitled "International Conference on the Plight of Refugees, Returnees and Displaced Persons in Southern Africa".

7. At its 56th meeting, on 27 November, following a statement by the United States of America, the Committee adopted draft resolution  $\lambda/C.3/44/L.63$  without a vote (see para. 18, draft resolution I).

# B. Draft resolution A / & 3 / 4 4 / -

8. At the 49th meeting, on 20 November, the representative of Finland, on behalf of Austria, Belgium, Canada, Costa Rica, Denmark, El Salvador, Ethiopia, Finland, France, Germany, Federal Republic of, Honduras, Hungary, Iceland, Italy, Netherlands, New Zealand, Norway, Panama, Portugal, Spain, Sweden and the United Kingdom of Great Britain and Northern Ireland, introduced a draft resolution (A/C.3/44/L.67) entitled "Office of the United Nations High Commissioner for Refugees". Subsequently, Cyprus, Greece, Japan, Nicaragua, Pakistan, Rwanda, Somalia, Sudan and Turkey joined in sponsoring the draft resolution.

9. At the 56th meeting, on 27 November, the representative of Finland orally revised the draft resolution as follows:

(a) In preambular paragraph 10, the word "enhancement" was replaced by thr word "promotion";

(b) In operative paragraph 14, the phrase "being fully aware of the catalytic role of the Office of the High Commissioner" was added at the end of the paragraph,

10. At the same meeting, the Committee adopted draft resolution A/C.3/44/L.67, au orally revised, without a vote (see para. 18, draft resolution II).

# C. Lraft resolution A/C.3/44/L.68/Rev.1

11. At the 49th meeting, on 20 November, the representative of Thailand, on behalf of Brunei Darussalam. Chad. China. Costa Rica. Dibouti. Guatemala. Honduras. Indonesia. Japan. Malaysia. Pakistan. the Philippines. Singapore. Somalia. Thailand and Zaire. introduced a draft resolution (A/C.3/44/L.68) entitled "International Conference on Indo-Chinese Refugees". Subsequently, the <u>Sudan</u> joined in sponsoring the draft rerolutioa.

12. At the 56th mooting, on 27 November, the representative of Thailand, on behalf of Brunei Darussalam, Chad, China, Costa Rica, Dilrouti, Guatemala, Honduras, Indonesia. apan, Malaysia, Pakistan, the Philippines, Singapore, Somalia, Thailand end Zaire, introduced the revised draft resolution (A/C.3/44/L.68/Rev.1). Subsequent ly, Viet Nam joined in rponroring the revised draft resolution.

13. The original draft resolution ( $\lambda/C.3/44/L.68$ ) has been revised by adding the Sudan to the original list of sponsors and by deleting operative paragraph 9, which read as follows:

"<u>Calls upon</u> the counttier of origin to undertake effective measures to ensure the safe, orderly and regular departure of their citizens and to stem the outflow of clandestine departures in accordance with the Comprehensive Plan of Action;"

14. At the same meeting, the Committee adopted draft resolution A/C.3/44/L.68/Rev.1 without a vats (are para. 18, draft resolution III).

## D. Draft resolution A/C. 3/44/L.69

15. At the 49th meeting, on 20 November, the representative of Guatemala, on b e h a l f o f Argentina, Brazil, Chile, C o l o m b i a, t h e <u>Dominican</u> <u>Republic, Ecuador, El Salvador, Guatemala, Haiti, Honduras, Irag, Italy, Malaysia,</u> <u>Mexico, Morocco, Nicaragua, Pakistan, Panama, Paraguay, Peru, Thailand, Uruguay</u> and <u>Venesuela</u>, introduced a draft resolution (A/C.3/44/L.69) entitled "International Conference on Central American Refugees". Subrequeatly, <u>Belize, Bolivia, Japan</u>, the <u>Philippines</u> and <u>Spain</u> joined in sponsoring the draft resolution,

16. At the 56th meeting, on 27 November, it was announced that oral revisions to the draft resolution6 were being made on behalf of the sponsors as follows:

(a) In preambular paragraph 15, the word "Gravely" at the beginning of the paragraph was deleted;

(b) In operative paragraph 11, the word "profound" on the first line was deleted.

17. At the same meeting, the Committee adopted draft resolution A/C.3/44/L.69, as orally reviled, without a vote (see pars. 18, draft resolution IV).

## **III.** RECOMMENDATIONS OF THE THIRD COMMITTEE

18, The Third Committee recommends to the General Assembly the adoption of the following draft resolutions:

DRAFT RESOLUTION I

# International Conference on the Plight of Refugees, Returnees and Displaced Persons i n S o -

#### The General Assembly,

<u>Recalling</u> its resolution 43/116 of 8 December 1988 on the International Conference on the Plight of Refugees, Returnees and Displaced Persons in Southern Africa,

<u>Gravely concerned</u> at the constant deterioration of the situation in routhern Africa arising from the domination and oppression of the peoples of South Africa by the minority racist régime of South Africa,

Having examined the report of the Secretary-General on the International Conference on the Plight of Refugees, Returnee6 and Displaced Persons in Southern Africa, 4/

<u>Conscious</u> of its responsibility to provide economic, material and humanitarian assistance to independent States in southern Africa in order to assist them in coping with the situation resulting from the act8 of aggression and destabilization committed by the <u>apartheid</u> régime of South Africa,

Noting with appreciation the consultations undertaken by the Secretary-General to establish within the United Nations system a mechanism to • inure the implementation and overall co-ordination of relief programmer for internally displaced persons,

Noting with indignation that South Africa's policy of apartheid and its direct and indirect acts of aggression, intimidation and destabilization through armed terrorists continue to be the main causes of refugee flows and increasing displacement of persons in southern Africa,

<u>Convinced</u> that there is an urgent need for the international community to extend maximum and concerted assistance to routhern African countries rhsltering refugees, returnees and dirplaced persons and also to highlight the plight of there persons,

1. <u>Takes note with satisfaction</u> of the report of the Secretary-General on the International Conference on the Plight of Refugees, Returnees and Displaced Persons in Southern Africa;

2. <u>Reaffirms</u> the need to continue the implementation of the Oslo Declaration and Plan of Action on the Plight of Refugees, Returnees and Displaced Persons in Southern Africa adopted by the Conference; <u>5</u>/

3. **Expresses its gratitude to the countries and organisations that** have given assistance to the countries in southern Africa to enable them to cope with the situation of refugees, returnees and displaced persons in their countries;

4. <u>Calls upon</u> the international community to provide increased assistance to the countries of southern Africa to enable them to strengthen their capacity to provide the necessary facilities and services for the care and well-being of the refugees, returnees and displaced persons in their countries;

5. <u>Reiterates its appreciation</u> to the Secretary-General for his effortr, on behalf of the international community, to organise and mobilise special programmes of economic assistance for the front-line and other neighbouring States to help them to withstand the effects of the acts of aggression and destabilisation committed by the <u>apartheid</u> régime of South Africa;

6. <u>Notes with appreciation</u> the efforts made by the Secretary-General, the Office of the United Nations High *Commissioner* for Refugees and the Administrator of the United Nations Development Programme to implement those specific tasks and responsibilities attributed to them in the Oslo Declaration and Plan of Action and encourages them to continue their efforts;

7. Endorses the recommendation of the Secretary-General aimed at attributing to the United Nations resident co-ordinators the function of co-ordinating assistance for internally displaced persons, in close co-operation with Governments, lucal representatives of donor countries and United Nations agencies in the field;

8. <u>Urges once again</u> all Member States, organisations of the United Nations system and governmental and non-governmental organizationa to undertake such measures as would be required of them by the Oslo Declaration and Plan of Action;

9. <u>Decides</u> to consider this question at its forty-fifth session on the basis of a report to be submitted by the Secretary-General.

# **DRAFT RESOLUTION II**

#### Office of the United Nations High Commissioner for Refugees

The General Assembly,

Having considered the report of the United Nations High Commissioner for Refugees on the activities of his Office, 6/ as well as the report of the Executive Committee of the Programme of the High Commissioner on the work of its fortieth session, 2/ and having heard the statements made by the Officer-in-Charge of the Office of the High Commissioner on 15 and 17 November 1989,

Recalling its resolution 43/117 of 8 December 1988,

**Reaffirming** the purely humanitarian and non-political character of the activities of the Office of the High Commissioner, as well as the fundamental importance of the High Commissioner's protection function and the need for States to co-operate with the High Commissioner in the exercise of this primary and essential responsibility,

Noting with satisfaction that, following recent accessions, one hundred and six States are now parties to the 1951 Convention <u>8</u>/ and the 1967 Protocol <u>9</u>/ relating to the Status of Refugees,

Noting with concern that, despite developments that offer hope for solutions to refugee problems, refugees and displaced persons of concern to the Office of the High Commissioner continue to face, in certain situations, distressingly serious problems, including problems of protection as a result of expulsion and <u>refoulement</u> of refugees, their unjustified detention and measures that do not recognize their special situation,

Particularly concerned that in various regions the safety and welfare of refugees and asylum-seekers are seriously undermined on account of military or armed attack-1, forced recruitment of refugees into armed force8 and other forms of violence, and noting that further efforts should be made t ensure rescuc and disembarkation of asylum-seekers in distress at see and, in this context, also noting the problems relating to stowaway asylum-seekers,

Noting the effort8 of the Office of the High Commissioner to continue to address the special problems and needs of refugee and displaced women and children, who in many cases are *exposed* to a variety of difficult situations affecting their physical and legal protection as well as their psychological and material well-being,

**Emphasizing** the need for States to  $\bullet$  + +  $\odot \bullet \boxdot$  on as wide a basis as possible, the efforts of the Office of the High Commissioner to search for durable and timely solutions to the problem of refugees based on new approaches that meet current realities and at the same time respect the tasic principles and concerns of protection,

**Realizing** in this context that voluntary repatriation or return remains the most desirable solution to the problems facing refugees and dirplaced performs of concern to the Office of the High Commissioner, and welcoming the fact that it has been possible for significant number8 of them to return voluntarily to their country of origin,

**Recognizing** that the promotion of fundamental human rights is essential to the achievement of self-sufficiency and family security for refugees, as well as to the process of re-establishing the dignity of the human person and realising durable solutions to refugee problems,

**Deeply concerned** by the unprecedented financial crisis that the Office of the High **Commissioner is** currently facing,

Aware that the application of the principle of international solidarity and the search for durable solutions imply a better rharing of responsibilities and arrangements between all the agencies of the United Nations system and other concerned organizations, both governmental and non-governmental for the implementation and the financing of related activities,

<u>Recalling</u> that durable solutions for refugees in developing countries can, in many cases, be achieved through a development-oriented approach and that the heavy burden placed on a host country a8 a result of growing influxes of *refugee6* requires sufficient resource8 to redress the negative impact and the strain on its socio-economic infrastructure in rural and urban areas, and emphasizing the need to ensure the compatibility of refugee aid and national development plans of developing asylum countries,

<u>Melcoming</u> the conclusions and decision8 on refugee aid and development adopted at the fortieth session of the Executive Committee, <u>10</u>/ in particular

its request to the Office of the High Commissioner to continue its catalytic role in the area of refugee aid and development a8 contained therein,

<u>Commending</u> those Staten which, despite severe economic and development problemm of their own, continue to admit large numbers of refugee8 and displaced persons of concern to the Office of the High Commissioner into their territories, and emphasizing the need to share the burden of these State8 to the maximum extent possible through international assistance,

Emphasizing the need for close co-operation between the Office of the High Commissioner and relevant agencies of the United Nation8 system and other international organizations, both intergovernmental and non-governmental, in devising and implementing specific elements of development assistance for solving problems of refugees, returnee8 and areas hosting them,

**Stressing** the need for the international community to continue to **rovide** adequate resettlement opportunities for those refugees for whom no other durable solution may be in sight, and with particular attention to those refugees who have spent an inordinately long period of time in camps and individual8 facing Urgent or emergency protection situations,

Welcoming the valuable support extended by Governments to the Office of the High Commissioner in carrying out its humanitarian tasks, and recognising the *need* for continuing and increasing co-operation between the Office of the High Commissioner and other bodies of the United Nations system and with intergovernmental and non-governmental organizations,

Noting the effort8 of the Office of the High Commirrioner, in co-operation with the Executive Committee, including the establishment of a Working Group, to improve the efficiency and effectiveness of the Office, and the need to further strengthen field activities and responsibilities,

<u>Commending</u> the Office of the High Commissioner and its staff for the dedicated manner in which they discharge their responsibilities, and paying tribute to those staff member8 who have endangered their lives in the course of their duties,

1. <u>Strongly reaffirms</u> the fundamental nature of the function of the United Nations High Commissioner for Refugees to provide international protection and the need for States to co-operate fully with his Office in fulfilling this function, in particular by acceding to and fully and effectively implementing the relevant international and regional refugee instruments;

2. <u>Endorses</u> the conclusions adopted at the fortieth session of the Executive Committee <u>11</u>/ on the implementation of the 1951 Convention and the 1967 Protocol relating to the Status of Refugees; 3. <u>Calls upon</u> all States to refrain from measures that jeopardise the institution of caylum, in partiaular by returning or expelling refugees and asylum-seekers aontrary to fundamental prohibitions against there practices, and urges States to continue to admit and receive refugees pending identification of their status and of appropriate solutions to their plight,

4. <u>Urges</u> all State8 to establish quick and effective procedures for determining refugee rtatur and granting asylum in accordance with internationally accepted criteria and appropriate legal guarantees, in order to deal expeditiously with manifestly unfounded claim8 and to protect refugee8 and asylum-seekers from unjustified or unduly prolonged detention or stay in camps;

5. Notes with deep concern, in this context, that large number8 of refugees and asylum-seekers in different area8 of the world are ourrently subject to detention or similar restrictive measures by reason of their illegal entry or presence in search of asylum, pending resolution of their situation, and reiterate8 the conclusions on detention adopted by the Executive Committee of the Programme of the United Nations High Commirrioner for Refugees a t its thirty-seventh session which ret out the ground8 for detention of such persons; 12/

6. <u>Condemns</u> violation8 of the right8 and safety of refugee8 and asylum-seekers, in particular those perpetrated by military or armed attacks against refugee *camp8* and settlements, forced recruitment into armed forces and other forms of violence;

7. Notes the accomplirhmonts of the Office of the High Commirrioner in the promotion and dissemination of refugee law, including, in particular, thr organisation of training courses on protection directed towards government and other concerned officials, and urger the Office to pursue its activities in this regard, making every effort to • nsure that such protection training courses continue on a significant scale;

8. **Endorses** the conclurionr on refugee children adopted by the Executive Committee at its fortieth session, 13/ and, in particular, the development and dissemination of the "Guidelines on Refugee Children" and the implementation of a work plan concerning refugee children that require8 the active co-operation and collaboration of Governments, United Nations bodies, among them the United Nations Children's Fund, and non-governmental organisations with the Office of the High Commissionerr

9. Fndorges the conclusions on refugee women adopted by thr Executive Committ its fortieth session, 14/ in which, in particular, were recognized the need to emphasize the parti lipatory role of refugee women and the need for a policy framework and organizational work plan for implementation of the next stages in bringing refugee women into the mainstream of the activities of the Office of the High Commissioner;

10. Endorses the conclusion on durable solutions and refugee protection adopted by the Executive Committee at its fortieth session, 15/ in which wan recognised the need for the active promotion of rolutions by the international community and by countries of origin, asylum and resettlement, in accordance with their respective obligationa and responsibilities and the desirability of prevention, including through the observance of human rightr, an the best rolutionr

11. <u>Recognizes</u> the importance of attaining durable solutions to refugee problems and, in particular, the need to address in this process the root causes of refugee movements in order to avert now flows of refugees and to facilitate the solution of existing problems;

12. <u>Approves</u> the decision entitlmd, "Sharing of responsibilities for operational activities relating to refugees", <u>16</u>/ adopted by the Executive Committee at its fortieth session and invites the agencies of the United Nationr system as well as all relevant international organisationa, both governmental and non-governmental, to establish as soon as possible specific mechanisms of co-operation to assure an agreed division of responsibilities and arrangmmrntr for the financing of these activities, while preserving the specific mandate of the High Commissioner to provide protection;

13, Urges the member States of relevant bodies to ensure that their delegates to such bodies as thm Development Assistance Committee of the Organisation for Economic Co-oparstion and Development, the World Bank and regional development banks and multi-tateral agencies such as the United Nations Dmvelopmmnt Programme and the International Fund for Agricultural Development are made aware of the refugee-related conclusions of the Executive Committee at its fortieth session and urges them to use their good officer to ensure thm adoption of policies and the establishment of mechanisms, both institutional and financial, that will provide for co-ordinated and expeditious implementation of development initiatives related to refugees and returnees;

14. <u>Recognizes with appreciation the ongoing work being</u> done by the Office of the High Commissioner to put into practice the concept of development-oriented assistance to refugees and returnees, as initiated at the Second International Conference on Assistance to Refugees in Africa 17/ and reaffirmed in the Oslo Declaration and Plan of Action adopted by the International Conference on the Plight of Refugees, Returnees and Displaced Persons in Southmrn Africa, 18/ au well as in the Quatemala Declaration and the Concerted Plan of Action in favour of Refugees, Repatriates and Displaced Contral Americana of the International Conference on Central American Refugees, 19/ and urges the Office to continue that process wherever appropriate, in full co-operation with appropriate international agencies, and urges Governments to rupport there efforts, ising fully aware of the catalytic role of thm Office of the High Commissioner;

15. <u>Recognizes</u> the importance of the International Conference on Indo-Chinese Refugees, held at Geneva on 13 and 14 June 1989, the International Conference on Central American Refugees, hmld at Quatemala City from 29 to 31 May 1989, and the adoption of the Concerted Plan of Action in favour of Refugees, Repatriates and Displaced Central Americana and the Comprehensive Plan of Action on Indo-Chinese Refugees; <u>20</u>/

16. Urges all States to rupport the Office of the High Commissioner in its efforts to search for durable rolutionr to thm problem of refugees and displaced persons of concern to the Office, primarily through voluntary repatriation or return, including assistance to returnees as appropriate, or, wherever appropriate, through integration into countries of asylum or through resettlement in third countries;

17. Expresses deep appreciation for the valuable material and humanitarian response of receiving countries, in particular those developing countries which, despite limited resources, continue to admit, on a permanent or temporary basis, large numbers of refugees and asylum-seekers;

16. <u>Urges</u> the international community, in accordance with the principle of international solidarity and in the spirit of burden-sharing, to assist the above-mentioned countries in order to mnable them to cope with the additional burden that the care for refugees and asylum-seekers represents;

19, Endorses the conclusions and decisions adopted by the Executive Committee at its fortieth session on assistance activities, which reflect the gravity of the financial crisis that the Office of the United Nations High Commirrioner for Refugees is facing at present;

20, <u>Calls upon</u> all Governments to contribute to the High Commissioner's programmes and, taking into account the need to achieve greater burden-rharing among donors, to assist the High Commissioner in securing additional income from traditional governmental sources, other Government8 and thm private sector in *order* to ensure that the needs of refugees, returnees and displaced persons of concern to the Office of the High Commirrioner are met.

# DRAFT RESOLUTION III

# International Conference on Indo-Chinese Refugees

The General Assembly,

Recalling its resolution 43/119 of 8 December 1988,

<u>Having considered</u> the report of the Secretary-Qenmral on thm International Conference on Indo-Chinese Refugees, held at Geneva on 13 and 14 June 1989, <u>21</u>/ and the Declaration and Comprehensive Plan of Action adopted by the Conference, <u>22</u>/

Noting with satisfaction the active participation of Member States, specialized agencies and regional, intergovernmental and non-governmental organizations at the Conference,

<u>Taking note</u> of the decision on the Conference adopted by the Executive Committee of the Programme of the United Nations High Commirrioner for Refugees at its fortieth session, <u>23</u>/

1. <u>Welcomes</u> the successful conclusion of the International *Conference* on Indo-Chinese Refugees, which was convened by the Secretary-General under the presidency of the Minister for Foreign Affair8 of Malaysia and held *at* Geneva on 13 and 14 June 1989;

2. <u>Takes note with satisfaction</u> of the report of the Secretary-General on the Conference;

3. Expresses its appreciation to the Secretary-General in convening the Conference and to the United Nations High Commirrioner Por Refugees for the valuable assistance and contribution in organising the Conference;

4. <u>Welcomes</u> the adoption of the Declaration and Comprehensive Plan of Action and affirms its belief that the Comprehensive Plan of Action is an important and round basis for a balanced, humanitarian and durable solution to thm problems addressed by the Conference;

5. <u>Stresses</u> that the measures stipulated in thm Comprehensive Plan of Action are interrelated and mutually reinforcing and should be implemented, within the context of national lawr and regulationa and of international rtandardr, by all States concerned in their totality)

6. <u>Takes note</u> of the progress on the implementation of the Comprehensive Plan of Action at the variour bilateral and multilatmral meetings among thm parties concerned, especially those held within thm context of the *Steering* Committee established by the Conference;

7. <u>Calls upon</u> all States concerned and the relevant specialized agencies and regional, intergovernmental and non-governmental organiaationr to undertake the variour measures required of them within the framework and letter of the Comprehensive Plan of Action)

8. Appeals to all States and regional, intergovernmental and non-governmental organisations to provide resources for the General and Special Programmes of the Office of the United Nation8 High Commirrioner for Refugees to enable it to carry out the tarkr prescribed in the Comprehensive Plan of Action;

9. <u>Stresses</u> that the solution of the problem of those seeking refuge in the South-Eart Asian region could contribute positively towards a climate of peace, harmony and good-neighbourliness among States in the region;

10. <u>Requests</u> the Secretary-General to continue to monitor **closely** the **progress** towards implementation of the Comprehensive Plan of Action and to report thereon to the Qeneral **Assembly** at its forty-fifth session.

## DRAFT RESOLUTION IV

#### International Conference on Central American Refugees

#### The General Assembly,

<u>Recalling</u> its resolutions 42/1 of 7 October 1987, 42/110 of 7 December 1987, 42/204 of 11 December 1987, 42/231 of 12 May 1988 and 43/118 of 8 December 1988,

Taking note of the report of the Secretary-General, 24/

Also taking note of the report of the United Nations High Commissioner for Refugees, 25/

Welcoming the Declaration and Concerted Plan of Action in favour of Central American Refugees, Returnees and Displaced Persons <u>26</u>/ adopted by the International Conference on Central American Refugees, held at Guatemala City from 29 to 31 May 1989,

**Bearing in mind** that a concerted effort in favour of lasting rolutionr to the problems of refugees, raturnees and displaced persons requires tho rupport, co-operation and co-ordination of the affected and interested Governments and of the various international organiaationr involved, in particular the Office of the United Nations High Commissioner for Refugees and the United Nations Fevelopment Programme,

<u>Welcoming</u> the establishment of the machinery for follow-up and co-ordination at the national level in compliance with the Concerted Plan of Action and the establishment of priority and preparation of projects within the framework of the strategies defined by each Government,

Taking note with interest of the commencement of the meetings for co-ordination, management and execution with the co-operating countries and the non-governmental organicationr interested in participating in the programmer and projects to assist the returnees, displaced persons and refugees in Central America,

<u>Aware</u> of the need to deal with the serious problem of the refugees in Central America who have found arylum in a number of Central American countries, including Belize and Mexico, and wishing to contribute to the

search for lasting solutions that would benefit the countries and communities of asylum and origin,

**Recognizing** the need to incorporate in the plan8 of assistance to refugees, returnee8 and dirplaced person8 measures to restore the ecological balance and the rational utilisation of the natural resources in the area8 of the countrier affected,

Taking into account that, as rtated in point 8 of the agreement concluded at the Esquipulas II summit meeting, 27/ the Central American countrier have undertaken, a8 a matter of urgency, to address the problem of refugees, including their repatriation and relocation through bilateral and multilateral processes,

<u>Reiterating</u> its determination to continue its efforts and contributions in the contort of the peace agreements, and welcoming the recent agreements adopted at Tela, Honduras, on 7 August 1989, <u>28</u>/ which include aspect8 of voluntary repatriation and relocation,

<u>Emphasising</u> that, among the possible solution8, voluntary repatriation is the most appropriate mean8 of solving the problem8 caused by the massive presence of refugees in the countries and communities of asylum,

<u>Once again reiterating</u> the paramount importance of humanitarian and apolitical considerations, both in dealing with and in solving the problem8 of refugees, returnee8 and displaced persons, and the need to ensure that this approach is strictly observed by the countrier of origin and of asylum and othor interested bodies,

**Recognizing** the work carried out by the Office of the High Commissioner and by the United Nation8 Development Programme with the Government8 of the affected countries in the preparation and convening of the Conference and in the meeting8 at the international level of the Follow-Up Committee of the International Conference on Central American Refugees,

<u>Concerned</u> at the reductions in the budget of the Office of the United Nation8 High Commissioner for Refugees in the region, which seriously affect the beneficiary population8 and the policies for a solution put forward in the context of the Esquipulas II agreement, entitled "Procedures for the establishment of a firm and lasting peace in Central America", <u>29</u>/ and the International Conference on Central American Refugees,

<u>Recognizing</u> the priority assigned to that section of the Special Plan of Economic Co-operation for Central America <u>30</u>/ which, within the emergency programme, is intended to promote activities for solving the problem8 of refugees, dieplaced persona and returneea,

<u>Recognizing</u> that the search for solutions goes further than emergency activitier and is linked with aspects concerning the development of the region and assistance for the displaced population8 in the countries of origin and asylum that are directly affected by the massive presence of refugees,

<u>Recognizing also</u> that the tripartite commissions, composed of representatives of the countries of aaylum, the country of origin and the Office of the High Commissioner, constitute an ongoing mechanism for solving the problem of refugee8 and that they requite rupport in order to continue the current voluntary repatriation programmes in condition8 of personal and material security,

<u>Recognizing further</u> that solutions to the problem8 of refugees, returnee8 and dieplaced persons form an integral part of the efforts for peace, democratisation and development being made in the region by each Government,

1. Expresses its profound satisfaction at the successful outcome of the International Conference on Central American Refugeea, held at Guatemala City from 29 to 31 May 1909, and the adoption by acclamation of the Declaration and Concerted Plan of Action in favour of Central American Refugees, Returnees and Dieplaced Persons;

2. <u>Welcomes</u> the guidelines, goals and objectives of the Concerted Plan of Action as a promising initial basis for future activities, and therefore reaffirms its commitment to contribute to the search for a firm and lasting peace in Central America;

3. <u>Welcomes</u> the establishment of the machinery for follow-up and co-ordination at the national level, in pursuance of the Plan of Action, and the establishment of priority and preparation of projects within the framework of the strategies defined by each Government;

4. <u>Requests</u> the United Nation8 High Commissioner for Refugees to support, in close collaboration with the Government8 of the affected countries and the Follow-Up Committee of the International Conference on Central American Refugees, together with the United Nations Development Programme and the organs, specialized agencies and other organisation8 of the United Nations system, the meeting8 for follow-up of the Plan of Action, so that they may be held at the earliest possible timer

5. <u>Notes with interest</u> that the Follow-Up Committee will hold its first meeting during the first week of March 1990, and urges the co-operating

countrime to respond positively to the assistance project8 submitted by the Central American countrime, including Belize and Mexico;

6. Urges Member States and organs, specialized agencies and other organisations of the United Nations system, as well as the regional and subregional, intergovernmental and non-governmental organizations engaged in the humanitarian task of helping Central American refugees, to continue to provide assistance and aupport to the affected countries in order to implement and follow up the guidelines, goals and objective8 of the Plan of Action;

7. Urges the co-operating countrime and the relevant agencies of the United Nations system to assist in restoring the ecological balance of the areas in the countries of asylum affected by the massive presence of refugees, in order to provide the population8 of those area8 with the condition8 conducive to development;

8. Appeals to the international community to ensure that the co-operation extended for the solution of the problem of refugee8 take8 into account both the sacrifice borne by the countries of asylum in receiving massive flows of refugees and the effort exerted by the countries of origin to create the condition8 which would facilitate the return of their nationals;

9. <u>Also appeals</u> to the international community to increase its assistance to the countries of asylum and of origin of Central American refugees in order to strengthen their capacity to provide the means and services necessary for the solution of the problem of refugees, returneea and displaced persons, in accordance with national development programmes;

10. Expresses its appreciation to the Secretary-General, the Office of the United Nations High Commissioner for Refugee8 and the United Nation8 Development Programme for the assistance rendered for the holding of the Conference;

11. Expresses its concern at the reductions in the budget of the Office of the United Nation8 High Commissioner fat Refugees in the region, which seriously affect the beneficiary populationi and the policies for a solution put forward in the context of the International Conference on Central American Refugee8 and by each Government, and urges that the budget previously allocated be restored;

12, <u>Expresses it 8 gratitude</u> to the people and Government of Guatemala for the hospitality extended for the holding of the International Conference;

13. <u>Requests</u> the Secretary-General, in co-operation with the High Commissioner, to report to the Economic and Social Council at its *second* regular session of 1990 and to the Ceneral Assembly at its forty-fifth session on the implementation of the present resolution.
