RESOLUTION ON **SOUTH AFRICA**

The Council of Ministers of the Organisation of African Unity, meeting in its Fifty-second Ordinary Session in **Addis Ababa**, Ethiopia, from 3 to 7 July 1990,

Having considered the reports of the Secretary-General and the 54th Session of the Liberation Committee, as well as the briefings by AHS and **PAC** on the current developments inside **South Africa**,

Cognisant of the fact that the limited policy measures announced by President **F. W. De Klerk** of the racist Pretoria **Régime** on 2 February 1990 were a direct result of internal and international pressure, especially the armed struggle, economic sanctions and political isolation,

Noting ' deep concern that the institutionalised political pillars of **apartheid** have not been abolished and are still intact,

G-concerned over the growing brutal repression, continued incarceration of political prisoners and political trials of opponents of **apartheid**,

Deeply concerned about the continued murderous activities of hit squads of the racist **régime**, internally and externally, against opponents of **apartheid**,

Noting further with grave concern the growing military co-operation between the racist Pretoria regime and some countries and regions such as Zionist **Israel**, Chile and **Taiwan**,

Indignant at dec' ' ns by some countries to lift or relax sanctions and other forms of pressure against South Africa,

Noting with satisfaction the growing determination of the oppressed and dispossessed People of South Africa to rid themselves of the scourge of **apartheid** and establish a democratic, non-racial and unitary state,

Recalling the **Harare** Declaration on the Question of South Africa adopted by the OAU Ad Hoc Committee of Heads of State and Government on Southern Africa in **Harare**, Zimbabwe on 21 August 1989,

Further recalling the Declaration on **apartheid** and its Destructive Consequences in Southern Africa adopted by the United **Nations** General Assembly at its Sixteenth Special Session in December 1989:

1. CONDEMNS the continued incarceration of political **leaders** and activists, as well as the growing brutal repression perpetrated by the racist **régime**;
2. STRONGLY CONDEMNS the **massacre** of the **Chand** family of the PAC in Botswana and the parcel bomb attack which seriously injured Michael Lapsley of the **ANC** in Zimbabwe;

3. NOTES WITH SATISFACTION efforts by the National Liberation Movements, **internal** and international **progressive** force⁶ to **intensify** the **struggle** and mobilise support for the elimination of **apartheid**;
4. **COMMENDS** the African National Congress for its **statesmanlike** initiative in calling for **talks** with the Pretoria regime aimed at clearing obstacle⁶ to genuine negotiations;
5. CALLS UPON opponents of **apartheid** in South Africa to form a broad united front and demonstrate unity of purpose and concerted action in order to thwart effort⁶ by the racist **régime** to undermine the struggle for the ultimate elimination of **apartheid** and the establishment of a **non-racial**, democratic and unitary South Africa;
6. FURTHER CALLS FOR increased assistance to the National Liberation Movements to facilitate their re-establishment in South Africa and to enhance their pursuit of the struggle;
7. REITERATES **Africa's** preference to end the **apartheid** system through genuine negotiations as provided for in the **Harare** Declaration and the United Nations Declaration on **Apartheid** and its Destructive Consequences on Southern Africa;
8. FURTHER REITERATES Africa's determination, in the **absence** of a negotiated settlement, to continue to support the legitimate struggle of the oppressed People of South Africa, including the armed struggle;
9. STRONGLY URGES the international community to maintain and intensify sanctions and other forms of international pressure against the racist Pretoria regime in order to compel it to eradicate **apartheid** and **AFFIRMS** that any relaxation of pressure now is in violation of the Declaration on **apartheid** and its Destructive Consequences in Southern Africa of the 16th Special Session of the United Nations **General Assembly**;
10. STRONGLY CONDEMNS Hungary for establishing diplomatic relations with the Pretoria regime and CALLS UPON Hungary to urgently re-consider this decision;
11. FURTHER CONDEMNS the migration of some E&stern **Europeans** to **apartheid** South Africa;
12. STRONGLY CONDEMNS the growing military and nuclear co-operation **between** the racist Pretoria regime and Zionist Israel, as well as that **régime's** military co-operation with Chile and Taiwan and accordingly CALLS FOR the strict observance of the United Nations Arms Embargo Against South Africa as demanded in **Security** Council resolution 418 (1977);
13. CALLS ON the OAU Member State⁶ to adopt a united and concerted position and continue with the complete isolation of the racist regime as well as the maintenance of sanction⁶ and other forms of pressure until **apartheid** is eradicated.

CM/Res.1273 (LII)

RESOLUTION ON FRONTLINE AND OTHER NEIGHBOURING STATES

The Council of Ministers of the Organisation of African Unity, meeting in its Fifty-second Ordinary Session in Addis Ababa, Ethiopia, from 3 to 7 July 1990,

Having considered the report⁶ of the Secretary-General and the Fifty-fourth Ordinary Session of the Liberation Committee on the Situation in the Frontline and other Neighbouring States,

Gravely concerned over the continuing volatile situation in Southern Africa engendered by the obnoxious system of apartheid,

Fully aware of the huge sacrifice⁶ which the Frontline States continue to make in the course of the struggle for the total liberation of Africa,

Noting with satisfaction the successful conclusion of the Namibian independence process:

1. WELCOMES Namibia's **independence** as a victory for **Africa's** collective efforts and the struggle of the People of Namibia against colonialism and apartheid and CONGRATULATES His Excellency Dr. Sam Nujoma on his **unanimous election** as first **President** of the Republic of Namibia;
2. COMMENDS the Frontline and other Neighbouring States for their support to Namibia until its accession to **independence** and their continued sacrifice⁶ and support to the People of South Africa in their **legitimate** struggle against apartheid and colonialism;
3. COMMENDS the United Nations for its central role in Namibia's independence **process**, and the international community as a whole for its firm commitment and support;
4. CALLS UPON the United Nations and the international community at large to continue extending all-round assistance to the new **nation** of Namibia to enable it to consolidate the institutions of Government and ensure security and economic **development** in the country;
5. REAFFIRMS that Walvis Bay and the islands off mainland Namibia constitute an integral part of the territory of Namibia whose southern borders extend into the Orange River;
6. CONDEMNS the racist Pretoria Regime for its continued acts of aggression, intimidation, **destabilization** and **blackmail** against the Frontline and other Neighbouring States, and demands an immediate end to the **Pretoria régime's** support to puppet groups in Angola and Mozambique;
7. REITERATES its appeal to the international community to support efforts by the Governments of Angola and Mozambique to bring about **reconciliation** and normalisation of life in the two countries;

8. FURTHER REITERATES its appeal to the international community to **increase** financial and material assistance to the Frontline and other Neighbouring States to enable them to withstand South Africa's acts of aggression, intimidation, blackmail and **destabilization**.

CM/Res.1274 (LII)

RESOLUTION ON THE ROOT-CAUSES OF THE AFRICAN REFUGEE PROBLEM

The Council of Ministers of the **Organization** of African Unity, meeting in its Fifty-second Ordinary Session in **Addis** Ababa, Ethiopia, from 3 to 7 July 1990,

Having considered the Secretary-General's report on the root-causes of the refugee problem in Africa and taking into consideration observations and remarks made by the various delegations during the debate,

Gravely alarmed by the steadily deteriorating refugee situation in Africa,

Noting that both the apartheid policy in South Africa and the **destabilization** activities of the Pretoria regime in Southern Africa, as a whole, continue to be one of the main root-causes of population displacement in the southern part of Africa,

Noting further that human and peoples' rights abuses, inter-state and intra-state conflicts coupled with other manifestations of intolerance in Africa, in general, are among the principal factors behind asylum-seeking,

Recalling that acts of interference in the internal affairs of other Member States can also result in cases of refugee influxes and displacement of **persons**,

Mindful of the fact that Africa's situation of 5 million refugees and 12 million displaced persons is the worst in the world today, especially in the case of women, **children**, the aged and the disabled,

Recognizing that the current gap between the assessed needs of refugees and the resources internationally available for refugee work in Africa is wide,

Convinced that voluntary repatriation constitutes a durable solution to the problem of refugees in Africa,

Convinced further that the elimination of the root-causes of the refugee problem would provide a comprehensive solution to this phenomenon:

1. TAKES NOTE with appreciation of the Secretary-General's report (DOC/CM/1605 (LII) Rev.11 on root-causes of the refugee problem in Africa, and ENDORSES the recommendations contained therein*:

* Somalia entered reservation.

2. REQUESTS the OAU Secretary-General in collaboration with the OAU Commission of Fifteen on Refugees, the United Nations **High Commissioner** for Refugees and any other relevant institution, to promote at regional levels **sensitization** campaigns on the instances of refugees and displaced persons with a view to eliminating the root-causes of refugees;
3. APPEALS to the international community to maintain pressure against South Africa until the **apartheid** system is totally and completely eradicated;
4. CALLS UPON Member States to translate into action their collective and individual commitment to the defence and protection of human and peoples' rights and to the peaceful settlement of internal and inter-state conflicts, and to continue respecting the principle of non-interference in the internal affairs of other states in accordance with the **provisions** of the Charter of the Organisation of African Unity and that of the United Nations;
5. COMMENDS Member States that have so far ratified the 1951 United **Nations** Convention on Refugees and its 1967 Protocol, the 1969 OAU Convention on Refugees, as well as the African Charter on Human and Peoples' **Rights** and APPEALS, once again, to those Member States that have not yet done so to consider ratifying these humanitarian international instruments, as soon **as possible**, and adhere to all their provisions;
6. COMMENDS Member States which have established national commissions and bodies for co-ordinating all assistance to refugees and APPEALS to other Member States to establish **such legal** institutions with a view to further increasing the attention and assistance to refugees;
7. CALLS UPON the international community to redouble its efforts in providing both material assistance and moral support to the **OAU** and its constituent Member States in promoting lasting solutions to the African refugee problem, especially tackling its root-causes and **facilitating** therefore voluntary repatriation.

CM/Res.1275 (LII)

RESOLUTION ON THE PEOPLE'S REPUBLIC OF ANGOLA

The Council of Ministers of the Organization of African Unity, meeting in its Fifty-second Ordinary Session in **Addis Ababa**, Ethiopia, from 3 to 7 July **1990**,

Having considered the report of the **OAU** Secretary-General on the situation in Southern Africa,

Having heard the statement on the Peace and National Reconciliation Process in Angola, made by the Head of the Angola Delegation,

Guided by the principle of the OAU Charter and the common determination of all the Member States to contribute to the promotion of peace, freedom and socio-economic progress of the continent:

1. COMMENDS the Government of the People's Republic of Angola for its peace efforts and EXPRESSES SATISFACTION as new developments in the peace process with the **establishment** of direct contacts between the Government of Angola and UNITA;
2. VEHEMENTLY CONDEMNS the **continued** interference in the internal **affairs** of the People's Republic of Angola, particularly the supply of military equipment and other facilities by the United States of America and South Africa;
3. CALLS ON the international community to **bring** pressure to bear on the Administration of North America and the Government of South Africa to cease all support to UNITA so as to facilitate the on-going direct contacts aimed at creating the conditions conducive to the **establishment** of lasting peace in Angola;
4. APPEALS to all African States and particularly the neighbouring **states** of Angola to assist in promoting the conditions conducive to lasting **peace** in Angola.

CM/Res.1276 (LII)

RESOLUTION ON THE SITUATION IN THE MIDDLE EAST

The Council of Ministers of the Organisation of African Unity, meeting in its Fifty-second Ordinary Session in Addis Ababa, Ethiopia, from 3 to 7 July 1990,

Having considered the report of the Secretary-General of the Organisation of African Unity on the situation in the Middle East as contained in Document CM/1607 (LII), of the Council of Ministers,

Guided by the principles and objectives of the Charters of the OAU and the United Nations, and the common determination of the African and Arab peoples,

Bearing in mind the successive resolutions adopted previously by the Assembly of Heads of State and Government and the Council of Ministers of OAU on the situation in the Middle East,

Noting with deep concern that in spite of the many resolutions adopted by the United Nations General Assembly, the Security Council and the Organization of African Unity urging Israel to withdraw from the Arab territories occupied since 1967, including Jerusalem, not only has Israel persistently refused to comply with these resolutions, but continues to pursue its occupation and expansionist policy,

Reaffirming that the violation by Israel of ~~the~~ territories of its **neighbours** and of the other Arab countries, their airspace and territorial waters poses a threat to international peace and **security**,

Noting with deep indignation that the complicity between the Zionist **régime** of Israel and the **Apartheid** regime of South Africa is aimed at **perpetrating** acts of terrorism and pursuing ~~the~~ repression of Palestinians and Arabs in the occupied territories, on the one hand, and the majority of the black population of **South Africa** on the other:

1. REAFFIRMS all previous resolutions adopted by the Assembly of Heads of State and Government and the Council of Ministers of the OAU and EXPRESSES ITS FULL SUPPORT to the Arab countries, victims of Israeli aggression, and to the Palestinian people in their just struggle to recover their rights and their occupied territory;
2. EMPHASISES the **identity** of the struggle waged by the Arab and **African** peoples and the need for caution against the total collusion between the Tel-Aviv Government and the racist regime of Pretoria, especially as regards nuclear armament and the serious threat to security and **peace**;
3. PAYS A GLOWING TRIBUTE to the Lebanese people for their heroic **resistance** to external aggression; APPEALS to the Lebanese people to effect a reconciliation so as to safeguard the independence and territorial integrity of Lebanon; DEMANDS the withdrawal of Israel forces from South Lebanon, in conformity with Security Council Resolution 425; CALLS FOR the implementation of the Taff Agreement and ENCOURAGES all other **peace** initiatives in Lebanon;
4. CALLS FOR continued efforts for the restoration of a global and lasting peace between Iraq and Iran in conformity with Security Council Resolution 598 (1987) as a comprehensive peace plan;
5. REAFFIRMS the declaration CM/ST.22 (XLIII) and AHG/DEC.2 (XXII) of the Council of Ministers and the Assembly of Heads of State and Government on the American aggression against the Libyan Arab **Jamahiriya** and CONDEMNS the new American threats to use force against Libya, DENOUNCES the economic embargo against it, DEMANDS the lifting of that **embargo** and REAFFIRMS its solidarity with the Libyan Arab **Jamahiriya**;
6. SUPPORTS the initiative of His Excellency **Mohamed Hosni Mubarak**, President of the Arab Republic of Egypt and Current Chairman of the Twenty-fifth Ordinary Session of Assembly of Heads of State and Government to **make** the Middle East a zone free of any weapon of mass destruction;
7. SUPPORTS the efforts exerted to convene the International Conference for Peace in the Middle East, in pursuance of the relevant resolutions adopted by the United Nations General Assembly, with the **participation**, on an equal footing, of the Permanent Members of the Security Council, and the parties concerned, including the PLO, the sole legitimate representative of the Palestinian **People**;

0. DEMANDS the withdrawal of Israel from the occupied Arab territories and CONSIDERS NULL and VOID any measures taken by Israel in the occupied territories aimed at changing their characteristics and over-exploiting their resources:
9. REQUESTS all States, international organizations and investment institutions to refrain from providing Israel with any form of **support** in its practices on those territories and engaging in any co-operation relations with this country, likely to enable it to illegally exploit the resources of these territories and DEMANDS that Israel put an end to its acts of violation:
10. **REQUESTS** the OAU Secretary-General to follow up the evolution of the situation in the Middle East and report thereon to the next Session of the Council of Ministers of the Organization of African Unity.

CM/Res.1277 (LII)

RESOLUTION ON THE QUESTION OF PALESTINE

The Council of Ministers of the Organization of African Unity, meeting in its Fifty-second Ordinary Session in **Addis** Ababa, Ethiopia, from 3 to 7 July 1990,

Having considered the report of the Secretary-General on the Question of Palestine as contained in Document **CM/1584** (LI),

Guided by the principles and objectives of the Charters of the OAU and the United Nations and the joint struggle against Zionism and racism for the attainment of freedom and peace,

Recalling the resolutions adopted by the previous sessions of the Council of Ministers and those adopted by the Assembly of Heads of State and Government on the Question of Palestine,

Further recalling all resolutions of the United Nations and the Non-Aligned Movement on the Question of Palestine,

Reaffirming the legitimacy of the struggle of the Palestinian people under the leadership of the PLC), their sole legitimate representative, in order to recover their territories and exercise their full national rights,

Following with attention the Palestinian popular uprising "INTIFADA", in the occupied territories in order to put an end to the Israeli occupation and **attain** the inalienable national rights for the Palestinian people, including their right to return to their homeland, self-determination and the establishment of their independent State with Jerusalem as its capital,

Commencing the honourable stand taken by the African States, Members of the Security Council at its session held in Geneva,

Noting with deep concern the acts of systematic state terrorism practised by Israel against the Palestinian people and their leaders both in and outside the occupied territories,

Noting further the alliance between the Zionist **Régime** of Israel and the racist **régime** in South Africa, both pursuing a terrorist policy aimed at the liquidation of the Palestinian people in the Palestinian occupied territories on the one hand, and the people of South Africa on the other:

1. REAFFIRMS all previous resolutions and recommendations adopted by various sessions of the Assembly of Heads of State and Government and the Council of Ministers of the OAU on the Question of Palestine;
2. RAILS the resistance of the Palestinian Arab people to Israeli occupation, the intensification of the Palestinian people's uprising in the face of the brutal repression perpetrated by the Israeli authorities as well as the sacrifices made by the Palestinian people under the leadership of their sole legitimate representative, the PLO, in order to recover their inalienable rights to return to their homeland, to recover their property in Palestine, to self-determination without outside interference and the establishment of their independent and sovereign state with Jerusalem as **capital**;
3. DEMANDS that Israel withdraw immediately and unconditionally from all the occupied Palestinian territories, and CALLS ON the UN to take all the necessary measures to put an end to the Israeli occupation of the Palestinian territories, and secure international protection for the people through the presence of international forces to facilitate the return to a global and just peace in the **region**;
4. STRONGLY CONDEMNS the continued inhuman acts perpetrated by Israel against the **citizens** of occupied Palestinian and Arab territories such as mass deportation and detention, slaughter of women and children, destruction of homes, confiscation of lands and property and the desecration of holy places. It exhorts international **organizations** to intervene in order to put an end to tense inhuman acts which constitute a flagrant violation of human rights in **Palestine**;
5. EXPRESSES ITS TOTAL SUPPORT for the legitimate heroic popular uprising of the Palestinian people in the occupied Palestinian **territories**, and CALLS ON Member States to provide the PLO with all forms of assistance to enable it to intensify this popular uprising)
6. SUPPORTS the efforts being made to convene an international Peace **Conference** on the Middle East, under the auspice⁸ of the UN with the participation on equal footing of the Permanent Members of the UN Security Council and all the parties concerned, including the PLO;
7. REAFFIRMS ITS SUPPORT for the Palestinian initiative for the establishment of a just and lasting peace in the Middle **East**;

8. APPEALS to the United States of America to resume the dialogue with PLO, since this catalogue constitutes a vital factor in the peace process in the Middle East;
9. STRONGLY CONDEMNS the expansionist settlement policies pursued by Israel in occupied Palestine, including Jerusalem, and especially the immigration and settlement of Soviet Jews in the occupied Arab territories;
10. EXHORTS all States to refrain from granting credits of any other form of assistance to the Israeli Government likely to facilitate the settlement of migrants in Palestine and occupied Arab territories. It requests that these illegal settlements be stopped, existing settlements be dismantled and an international machinery be set up to monitor and expose Israeli activities in this area;
11. URGES the Soviet Union and the USA, in view of their declared positions, and the international community to do everything possible to prevent the settlement of migrant Jews in the occupied Palestinian and Arab territories;
12. CALLS FOR the convening of an Islam/Christian meeting including the Vatican, oriental churches and others in order to protect and preserve the identity of the Holy city as well as its religious, historical and demographic aspects;
13. CALLS ON the Secretary-General of the Organization of African Unity to follow up the developments of the Palestinian Question and submit a report thereon to the forthcoming Session of the OAU Council of Ministers.

CM/Res.1278 (LII)

RESOLUTION ON THE REFUGEE SITUATION IN AFRICA

The Council of Ministers of the Organisation of African Unity, meeting in its Fifty-second Ordinary Session, in Addis Ababa, Ethiopia, from 3 to 7 July 1990,

Having considered the Activity Report of the OAU Commission of Fifteen on Refugees (CM/1606 (LII)),

Deeply concerned with the persistent problem of refugees in Africa and the alarming deterioration of the living conditions of the refugees, particularly the most vulnerable groups such as women, children, the disabled and the aged,

Aware that the serious situation arising from Africa's problem of refugees and displaced persons, currently estimated at 5 million and 12 million, respectively, places a heavy social and economic burden on the countries affected by the presence of these uprooted persons,

Noting with grave concern the diminishing resources available to refugees in Africa,

Expressing gratitude to the countries of asylum for the great sacrifice they are making in providing asylum for refugees in the spirit of African solidarity and traditional hospitality,

Convinced that Africa, with her current socio-economic problems, cannot solve this distressing problem alone without the assistance of the international community ,

Recognizing that continued efforts of the UNHCR, governmental and non-governmental **organizations** together with other members of the international community, in giving **assistance** to African refugees:

1. COMMENDS the OAU Commission of Fifteen on Refugees and TAKES NOTE with great concern of the useful report presented on the situation of refugees in **Africa**;
2. CONGRATULATES all Member States of the OAU which have been extending assistance and granting asylum to **refugees** in Africa, together with those countries of origin that **have** made possible **and facilitated** the **voluntary** repatriation of their citizens living in exile, in close **collaboration** with international organisations especially UNHCR;
3. APPEALS to other Member States concerned to consider creating the **necessary** conducive political atmosphere in order to **enable** the **voluntary** repatriation of refugees to their countries of origin to take **place**;
4. CALLS UPON UNHCR to continue to promote the voluntary repatriation of refugees in **accordance** with its universal **mandate, principles** and practices whenever conditions permit;
5. CALLS FURTHER UPON Member States, the UNHCR **and** such other **Organizations**, national or international, **as may** be involved in refugee work in **Africa**, to give special attention to the plight of vulnerable **categories** of refugees, namely, **women**, children, the **aged** and the disabled;
6. REQUESTS Member States concerned to consider holding **whenever** possible, meetings and exhibitions at national and regional levels for the purpose of focusing on all issues relating to the presence of refugees in the region, with a view to working out lasting solutions to the **problems at hand**;
7. REQUESTS FURTHER the OAU Secretary-General, in collaboration with the UN High Commissioner for Refugees, the African Groups in Geneva **and** New York, and the OAU Commission of Fifteen on Refugees to explore, **after** evaluating the results of the first two international conferences, the possibility of convening a Third International Conference on Assistance to Refugees in Africa and report back to Council in its Fifty-fourth Ordinary Session;

- A. ACCEPTS, in principle, **and** with profound **gratitude** the kind offer of the Government of the Sudan to host, following consultations with the OAU Commission of Fifteen on Refugees, one of its sessions for the purpose of sensitising the general public of the plight **of** refugees;
9. EXPRESSES ITS HIGH APPRECIATION to the UNHCR for its contribution in alleviating the plight of African refugees and REQUESTS it to give adequate attention to the African region in drawing up and in implementing its programmes of **assistance**;
10. COMMENDS the International Community, for the humanitarian **assistance** it has continued to render to refugees **and** displaced persons as well as to countries of asylum, and APPEALS to the donor community to increase its resources towards assisting refugees in Africa, to match the **magnitude** of the problem.

CM/Res.1279 (LII)

RESOLUTION ON ARREARS OF CONTRIBUTION

The Council of Ministers of the Organization of **African** Unity, meeting in its Fifty-second Ordinary Session, in **Addis** Ababa, Ethiopia, from 3 to 7 July 1990.

Considering the provisions **of** Article XXIII **of** the **Charter**,

Considering the provisions of Articles 96 and 97 of the **Financial Rules and Regulations**,

Paving studied the serious situation engendered by Arrears of **Contribution**,

Aware of the fact that this persistent situation is severely affecting the smooth functioning of the Organization,

Consider- the extreme **gravity of** the situation as reflected in the **Report** of the Sub-Committee on Outstanding Contributions (**Doc. CM/1609 (LII) Rev.1**),

Reaffirming the obligation of all Member States to pay their contribution!::

1. APPEALS to all Member **Stateas** with arrears of contribution to take all necessary and immediate action to honour their commitments to the Organization;
2. ADOPTS the following measures to remedy the serious situation arising from accumulated arrears of contributions:
 - (a) the Secretariat should, during the preparation of its budget, **make** objective, genuine and rational evaluation of the actual expenses of the Organization, so as to ensure that in future the budgets to be **adopted** take into consideration the financial ability of Member **States** and the real absorption capacity of the **Organization**;

- (b) in future, the regular budgets of the **Organization** should be kept within a ceiling growth rate of 10 per cent, in relation to the actual expenditure of the previous financial year, save in exceptional cases of expenditure relating to specific **programmes**, which had not been taken into account when calculating the ceiling growth rate:
- (c) the expenditure of the **1989/90** financial year will serve as a reference for the **implementation of** the above provisions:
- (d) in addition to the application of Article 97 of the Financial Rules and Regulations which stipulates that "Any OAU Member State with an outstanding contribution of the Budget of the **Organization** in accordance with its obligations as enacted in the Charter, shall not participate in either the vote or OAU decisions if the amount of its arrears is equal to **or** in excess **of** the contribution due by such State for the two **(2)** complete financial years ended", defaulting Member States shall be deprived of:
 - the right to speak at OAU meetings;
 - the right to present candidates for OAU Posts (**e.g.** political appointees and other officials):
 - the right to present candidates for OAU decision-making bodies (offices, commissions, committees, etc. . . .);
- (e) for the purpose of applying the above sanctions, a Credentials Committee whose terms of reference and mode of operation will be determined by the Council of Ministers, shall be set up;
- (f) the Advisory Committee on Administrative, Financial and **Budgetary** Matters will submit the Draft Rules **of** Procedure of the Credentials Committee to the Fifty-third Ordinary Session of the Council of Ministers:
- (g) the usual procedure of requesting Member States to honour their commitments by letters from the Secretariat and the **OAU** Current Chairman and by reminders from the Secretary-General **in** the course of his visits to Member States, will be maintained:
- (h) Member States concerned have five years to pay up **their arrears of** contribution as at 31 May 1990:
- (i) Member States concerned have one year as from the **adoption** of these measures by the Fifty-second Ordinary Session of the Council of Ministers to send their payment schedule to the Secretariat.

RESOLUTION ON CIVIL AVIATION SECURITY

The Council of Ministers of the Organization of African Unity, meeting in its Fifty-second Ordinary Session in Addis Ababa, Ethiopia, from 3 to 8 July 1990,

Having considered the Report of the Secretary-General on the activities of the OAU Specialized Agencies, Document CM/1591 (LII) Part IV, Chapter III,

Recalling the Declaration of General Policy in the Field of Civil Aviation adopted in accordance with Resolution CM/Res.304 (XXXV),

Recognizing that the technical progress made in the field of civil aviation has led to the attainment of a high level of security and standardization,

Noting that international civil aviation is threatened by a new form of danger which was not envisaged during the drafting in 1944 of the Convention on International Civil Aviation, namely, act of violence against civil aviation safety, use of force, illegal seizure of aircraft and acts of sabotage,

Convinced that the integrated nature of international air transport accounts for the dimension of the problem posed by the criminal acts of violence which, given their special characteristics, exceed geographical or political limits,

Concerned over the recent events, manifested in the increasing tendency for sabotage of civil aircraft and which therefore requires that the international community accords the greatest attention to all acts of unlawful interference in civil aviation.

Noting with satisfaction the conclusions and the recommendations of the Special Session on the effectiveness of aviation security services in African airports, convened by the African Civil Aviation Commission (AFCAC) in cooperation with the African Airlines Association (AFRAA) in Nairobi, Kenya, in January 1990,

Aware of the role being played by air transport in the social and economic development of each Member State and in the promotion of Inter-African Trade for the achievement of collective self-reliance:

1. DECIDES to endorse the Nairobi Declaration on Civil Aviation Safety which recommends measures to be taken and responsibilities to be assumed by African States, African Organizations involved as well as by the international community and International Organizations;
2. URGES Member States to take the appropriate measures to apply the guidelines contained in the Nairobi Declaration on Civil Aviation Security;
3. CALLS ON the Secretary-General:

- (a) to assist as best as possible AFCAC in achieving the objectives of this Declaration;
- (b) to submit in cooperation with AFCAC, periodic reports on the implementation of this Declaration.

RESOLUTION ON THE MODALITIES FOR IMPLEMENTING THE
OAU/AFCAC AGREEMENT

The Council of Ministers of the **Organization** of African Unity, meeting in its Fifty-second Ordinary Session in **Addis** Ababa, Ethiopia, from 3 to 8 July 1990.

Having considered the report of the Secretary-General on the activities of the Specialized Agencies of the **OAU**, Document CM/1591 (LII), Para. IV, Chapter III concerning the African Civil Aviation Commission,

Recalling its Resolution **CM/Res.439** (XXV) by which the OAU decided to grant AFCAC the status of Specialised **Agency**,

Noting in this regard that an agreement between the Organisation of African Unity and the African Civil Aviation Commission establishing **AFCAC** as an OAU Specialized Agency, was signed in **Addis** Ababa on 11 May 1978,

Considering Resolution **CM/Res.1081** (XLV) relating to extending the range of activities of OAU Specialized Agencies,

Recognizing the specificity of the area of competence of AFCAC and the constraints on African air transport in a world environment that demands better coordination of civil aviation policies and strategies within AFCAC,

Convinced that the provisions contained in the **OAU/AFCAC** Agreement on Budgetary and Financial Arrangements, aimed at the establishment of an autonomous AFCAC Secretariat at the end of a transitional period stipulated in the AFCAC constitution signed in **Addis** Ababa, on 17 January 1969, which would be jointly determined with the International Civil Aviation Organization (ICAO),

Considering that according to the proposals made by the 27th Session of the ICAO General Assembly, this interim phase covers the period January 1990 to December 1995, during which ICAO should transfer to **AFCAC** the responsibility of managing its own Personnel and finances,

Considering also that Article IX of the **OAU/AFCAC** Agreement outlines the modalities for effecting this transfer of authority,

Conscious of the role of AFCAC in the process of integration of the African Air Transport system,

Noting with satisfaction the constant adaptation of AFCAC's means of operation to technological developments and changes in air transport policies and strategies world wide, particularly in view of the establishment of a common internal air space within the European Community in 1993:

1. URGES Member States;

(a) to provide material and human support required for implementing AFCAC's strategies and programmes;

(b) to ensure individually and collectively that the interim budgetary and financial arrangements stipulated in the OAU/AFCAC Agreement are implemented;

2. REQUESTS the Secretary-General

to submit to the Fifty-third Session of the Council appropriate proposals for the establishment of an autonomous AFCAC Secretariat in keeping with Article IX of the OAU/AFCAC Agreement including the financial implications of these proposals for consideration by the Council.

CM/Res.1282 (LII) Rev.1

RESOLUTION ON THE COOPERATION BETWEEN THE ORGANIZATION OF
AFRICAN UNITY AND THE UNITED NATIONS ORGANIZATION

The Council of Ministers of the **Organization of African Unity**, meeting in its Fifty-second Ordinary Session, in **Addis Ababa**, Ethiopia, from **3 to 8 July 1990**,

Having considered the report of the Secretary-General on the cooperation between the OAU and UN, **Doc. CM/1612 (LII)**,

Reaffirming its will and determination to promote and strengthen international cooperation and solidarity,

Aware of the need for the OAU and the UN to ensure the coordination and harmonization of their efforts in all fields to ensure **complementarity and strengthening** of their action in Africa,

Referring to the relevant resolutions adopted by the policy-making bodies of the two Organizations on cooperation between the Organization of African Unity and the United Nations Organization:

1. TAKES NOTE of the Report of the Secretary-General and ENDORSES the conclusions and recommendations of the Fifth meeting between the OAU and the United Nations System, **Doc. CM/1612 (LII)**;

2. PAYS TRIBUTE to the United Nations Secretary-General for his continuous efforts to promote and strengthen cooperation between the OAU and the UN System;
3. EXPRESSES ITS GRATITUDE to all Heads of UN Specialized Institutions, Organizations, Organs and Bodies for their effective participation and contribution to the success of the fifth meeting between the OAU and the UN System;
4. EXPRESSES SATISFACTION to the initiatives taken by the UN General Assembly to lend its support to the OAU in its efforts to promote the economic and social integration of Member States and CALLS UPON the UN Specialized Agencies to direct their respective programmes towards the attainment, in a coordinated manner, of the objective of the establishment of an African Economic Community in conformity with the directives of the appropriate bodies of the OAU;
5. EXPRESSES SATISFACTION with the efforts made by the UN and OAU Secretariats to establish a standing consultative mechanism to monitor and follow up the implementation of cooperation programmes between the OAU and the UN System and URGES them to strengthen this coordination mechanism;
6. CALLS UPON the OAU Secretary-General to pursue the necessary consultations with the UN Secretary-General to update the Cooperation Agreement between the OAU and the UN, signed in 1965;
7. REQUESTS the African Group to the United Nations to continue to play an active role and to take the necessary actions to strengthen the working relations between the OAU and the United Nations;
8. REQUESTS FURTHER the OAU Secretary-General to submit periodic reports on the cooperation between the OAU and the United Nations Organization.

RESOLUTION ON INDUSTRIAL DEVELOPMENT

The Council of Ministers of the Organization of African Unity, meeting in its Fifty-second Ordinary Session, in Addis Ababa, Ethiopia, from 3 to 7 July 1990,

Recalling Resolution AHG/Res.180 (XXV) by which the Assembly of Heads of State and Government inter alia solemnly proclaimed the period 1991 to 2000 as the Second Industrial Development Decade for Africa, and 20 November as the Africa Industrialization Day with effect from 1990,

Recalling further Resolution 44/237 of the United Nations General Assembly and Resolution GC.3110 of the Third General Conference of the United Nations Industrial Development Organization (UNIDO) relating to the proclamation of a Second IDDA,

Highly conscious of the pivotal role of industrialization in promoting African economic integration and development and of the need for all Member States and African Organizations to accord **high** priority to accelerated **industrialization** through intra-African cooperation,

Concerned about the impact of the economic crisis which is still being felt in Africa, and the consequent slow pace of African economic recovery and rehabilitation, despite the effort deployed by African countries!

1. TAKES NOTE of the report of the Secretary-General on the Third General Conference of UNIDO which was held in Vienna in November 1989 (Doc. CM/1613 (LII));
2. EXPRESSES APPRECIATION to the UN General Assembly for proclaiming a Second Industrial Development Decade for Africa; and for providing financial support to ECA, for its preparatory activities;
3. EXPRESSES APPRECIATION to UNIDO for its contribution to Africa's industrialization effort, in particular for its increased technical assistance delivery and for allocating 8.6 million US dollars to the programme for the Industrial Development Decade for Africa;
4. COMMENDS the measures taken by the Director General of UNIDO to strengthen the Co-ordinating Unit for the IDDA and URGES him to provide that Unit with increased financial and human resources so as to enable it to contribute to the success of the Second IDDA;
5. URGES all African countries and intergovernmental organizations to formulate their programmes for the Second IDDA in accordance with the timetable established for that purpose and to prepare activities, with the full involvement of the relevant sectors of the society, in commemoration of the Africa **Industrialization** Day starting from 20 November 1990;
6. REQUESTS the Secretary-General, in cooperation with the Executive Secretary of ECA and Director General of UNIDO to assist African countries and organisations in the preparation of programmes and activities for the Second IDDA, as well as in the commemoration of the Africa **Industrialization** Day; and to monitor closely its implementation;
7. REQUESTS FURTHER the Secretary-General in cooperation with the Executive Secretary of ECA and Director General of UNIDO, to ensure that African preparation for the Fourth UNIDO General Conference starts on time; and to report on the implementation of this resolution at its Fifty-fourth Ordinary Session.

RESOLUTION ON THE SECOND ORDINARY SESSION OF
AFRICAN MINISTERS OF MARITIME TRANSPORT

The Council of Ministers of the **Organization** of African Unity, **meeting in** its Fifty-second Ordinary Session in **Addis** Ababa, Ethiopia, from 3 to 8 July 1990,

Having considered Document CM11614 (LII) on the conclusions of the deliberations of the Second Session of the African **Ministers** of Maritime Transport,

Recalling the ultimate goal of the Lagos Plan of Action and Final Act **as** well as **Africa's** Priority Programme for Economic Recovery,

Recalling further its resolutions **CM/Res.1169 (XLVIII)** on the Development of Maritime **Transport** in Africa and **CM/Res.1227 (I)** on the outcome of the First Special Session of the Conference of African Minister⁶ of Maritime **Transport**,

Convinced that the development of maritime industry and economy in Africa is an essential factor to the overall socio-economic development of the continent,

Recognizing that the United Nations Convention on a Code of Conduct for Liner Conferences has contributed **considerably** to promoting the development of the sub-sector of maritime transport in Africa,

Reaffirming the importance that Africa attache⁶ to the Code of Conduct for Liner Conferences and the Review Conference on **the** Convention of the Code,

Consid ing that close economic relations between the **countries** of the European Economic Community (EEC) and the African countries should be based on equitable principles and practices enabling each group of partners to derive genuine benefit therefrom,

Convinced that only cooperation among African economies including, among others, the **harmonization** of maritime policies and legislation can safeguard the maritime interests of Africa in a world dominated by unfair and inequitable competition,

Convinced further that the Conference of Ministers of Maritime Transport is the appropriate forum for the formulation and adoption of such continental maritime policies and legislations:

1. ADOPTS the conclusions of the Second Session of the Conference of Minister⁶ of Maritime Transport;
2. ENDORSES **Resolutions MT/MIN/Res.5 (II), MT/MIN/Res.6 (II) and MT/MIN/Res.7 (II)** adopted by the Conference;
3. RECOMMENDS that the **Assembly** of Heads of State and Government adopt the draft amendments to the United Nations Convention on a Code of Conduct for Liner Conferences:

4. EARNESTLY REQUESTS all Member States to apply all the resolutions of the first two sessions of the Conference of Ministers of Maritime Transport and take all appropriate measures to safeguard the continent's collective maritime interests;
5. APPEALS to Groups B, D, Asia, Latin America and China to take into consideration, the peculiar economic situation of the African continent in their relations with African countries;
6. FURTHER APPEALS URGENTLY to the EEC countries to resume negotiations with their ACP partners, in particular, the African States, with a view to establishing a mechanism in the field of maritime transport that would ensure a more rapid and sustained development of maritime industry and economy in the ACP countries, particularly in Africa, by allowing them, inter alia, to increase their participation in the carriage of the cargo generated by their foreign trade;
7. REQUESTS the Secretary-General of the OAU in co-operation with African regional maritime organizations and the concerned UN Organizations to undertake all the necessary studies with a view to assisting Member States in harmonizing their maritime policies and regulations;
8. CALLS UPON the Secretary-General of the OAU to take into account the interests of African land-locked countries in the studies to be carried out as well as in the negotiations and consultations to be conducted with all the concerned parties;
9. REQUESTS the Secretary-General to submit a report to its Fifty-fourth Ordinary Session on the implementation of this resolution.

RESOLUTION ON THE REPORT OF THE UNITED NATIONS SECRETARY-GENERAL'S
EXPERT GROUP ON AFRICAN COMMODITY PROBLEMS

The Council of Ministers of the Organization of African Unity, meeting in its Fifty-second Ordinary Session in Addis Ababa, Ethiopia, from 3 to 8 July 1990,

Recalling resolution AHG/177 (XXIV) of the Assembly of Heads of State and Government of the OAU adopted in May 1988, which requested the Secretary-General of the United Nations to establish a High-level Expert Group to examine the problem of African commodities,

Bearing in mind that the General Assembly of the United Nations adopted resolution 43/27 by which the Secretary-General of the UN constituted the Expert Group under the Chairmanship of Hon. Malcolm Fraser, former Prime Minister of Australia,

Noting that the Group has completed its assignment and that its report will be subsequently forwarded to the Forty-fifth Session of the United Nations General Assembly for consideration,

Having noted the said report entitled "African Commodity Problems: Towards a Solution".

Further noting the other relevant documents made available by the Secretariat of the OAU:

1. EXPRESSES ITS GRATITUDE **to** the Secretary-General of the UN, for setting up the Expert Group on African Commodity Problems as requested by the Assembly of Heads of State and Government and NOTES that the Group **has** completed its assignment;
2. DIRECTS the Permanent Steering Committee with the participation of the Drafting Committee of the Whole, during its next meeting in August 1990, to carry out an in-depth assessment of the said report of the Experts' Group on African Commodity Problems, and all other related documents to be made available by the OAU Secretariat, in order to formulate a comprehensive African Common Position on the Report;
3. DECIDES that the expected African Common Position should constitute the stand to be adopted by the African Group during the Forty-fifth Session of the United Nations' General Assembly when the Report, "African Commodity Problems - Towards a Solution" would be considered and during the Paris Conference on the Least Developed Countries to be convened in September 1990 where commodities will also be discussed.

CM/Res.1286 (LII)

RESOLUTION ON THE AFRICAN CHARTER FOR POPULAR PARTICIPATION IN **DEVELOPMENT** AND TRANSFORMATION*

The Council of Ministers of the **Organization** of African Unity, meeting in its Fifty-second Ordinary Session in **Addis** Ababa, Ethiopia, from 3 to 8 July 1990,

Recalling United Nations General Assembly resolution S-13/2 on the United Nations Programme of Action for Africa's Economic Recovery and Development, 1986-1990 (UN-PAAERD),

Recalling also resolution 664 (XXIV) of the Twenty-fourth Session of the Economic Commission for Africa and Fifteenth Meeting of the Conference of Ministers on the International Conference on Popular Participation in the Recovery and Development Process in Africa,

* Ghana and Gabon entered reservations on this resolution.

Aware of the fact that people have a fundamental right to **participate fully** in the making of policy decisions which affect their lives at all levels,

Noting with interest the decisions and recommendations arrived at by the International Conference on Popular Participation in the Recovery and **Development** Process in Africa, held from 12 to 16 February 1990 in **Arusha, United Republic of Tanzania**, and in particular resolution 2 of the same title whose operative paragraphs resolve **inter alia** that the eleventh day of February each year **should** be proclaimed Popular Participation Day in Africa:

1. EXPRESSES ITS APPRECIATION to the Government of the United Republic of Tanzania for generously hosting the Conference;
2. ADOPTS the African Charter for Popular Participation in Development and Transformation (Arusha 1990) as a statement of the strategy that **should** be **incorporated** in development policies adopted by African Governments, with a view to promoting popular participation in development and by encouraging people and their **organizations** to undertake self-reliant development initiatives;
3. RECOMMENDS that the Government of the United Republic of Tanzania **should** submit the present Charter to the Forty-fifth Regular Session of the General Assembly of the United Nations for its information and **necessary** action;
4. REQUESTS the Secretary-General of the Organisation of African Unity and the Executive Secretary of ECA to disseminate the **contents** of the Charter widely, and to set up a mechanism for implementing and monitoring the follow-up of activities contained in the Charter at sub-regional and regional levels and submit regular reports to the Council.

**RESOLUTION ON THE FINAL REVIEW AND EVALUATION OF THE
IMPLEMENTATION OF THE UNITED NATIONS PROGRAMME OF
ACTION FOR AFRICAN ECONOMIC RECOVERY AND DEVELOPMENT
1986 - 1990**

Expressing concern that the commitment of the international community to increase official development assistance to Africa, improve its quality and effectiveness, and its commitment to making every effort to support and supplement the African development efforts have not been honoured,

Concerned by the continued deterioration in socio-economic **conditions** in **Africa**, a trend which is already manifesting itself at the beginning of the **decade** of the 1990s:

1. RECOMMENDS that the mechanism for the final review and evaluation of **the** implementation of UN-PAAERD should be under-taken within the **framework** of an **Ad Hoc** Committee of the Whole of the United Nations **General Assembly**;
2. REQUESTS the Secretary-General of OAU, the Executive Secretary of **ECA** and the President of **ADB** to prepare the necessary **technical** studies on the implementation of UN-PAAERD so as to facilitate the work of **the Permanent Steering committee** in its evaluation of the implementation of UN-PAAERD;
3. CALLS ON the OAU Permanent Steering Committee to devote one of its Sessions during the first half of 1991 to the review and evaluation of the implementation of UN-PAAERD with a view to recommending a co-ordinated African position of the matter,

Bearing in mind the relevant provisions of the Lagos Plan of Action, particularly **Chapter X** concerning the African Least Developed Countries (LDCs),

Recalling the Substantial New Programme of Action (SNPA) adopted by the **first** United Nations Conference in Paris in 1981, as an international development strategy for the LDCs during the **1980s**,

Noting with resolution A/Res/42/117 adopted by the 42nd Session of the United Nations General Assembly on the Second United Nations Conference on the Least Developed Countries,

Recalling its resolutions CM/Res.887 (XXXVII) and CM/Res.917 (XXXVIII) adopted at its 37th and 38th Ordinary Sessions respectively,

Bearing in mind the Declaration adopted by the Ministers of the African LDCs, at their 9th Conference in April 1989, as well as the Statements, resolutions and recommendations adopted at their 10th Conference, held from 14 - 15 May 1990, in Tripoli, Libya,

Noting with serious concern the increasing socio-economic deterioration in the African Least Developed Countries and the alarmingly growing number during the decade of the 1980s,

Noting further the Proposed Draft programme of Action for the LDCs in the 1990s prepared by the Inter-Governmental Group on the LDCs,

Having considered the recommendations of the Permanent Steering Committee on the preparations for the Second United Nations Conference on the LDCs to be held in Paris from 3 - 14 September 1990 as contained in Doc. PSC (XX):

1. TAKES NOTE of the recommendations of the Permanent Steering Committee on the preparations for the Second United Nations Conference on the LDCs;
2. ENDORSES the declarations, decisions and recommendations adopted by the 9th and 10th Sessions of the Conference of Ministers of African LDCs held in April 1989 and 1990 respectively;
3. STRESSES that the Second United Nations Conference on the LDCs should, on the basis of global comprehensive review of the SNPA implementation during the 1980s, formulate and adopt a new development strategy for the LDCs during the 1990s, in accordance with priorities and long-term development objectives defined by the LDCs themselves;
4. URGES all aid donors, Member States of the United Nations and international organizations to make firm commitments during the Conference and to take necessary measures in order to launch immediately after the Conference, a new comprehensive Development Programme for the LDCs;
5. REQUESTS all OAU Member States to take an active part in the preparation of the Conference and to ensure their attendance at high levels;
6. ENDORSES the recommendations of the Ministers of the African LDCs urging the Twenty-sixth Assembly of Heads of State and Government of the OAU to address the issue and for its Current Chairman to make the required arrangements to address the Second United Nations Conference on the LDCs;

7. **EXPRESSES** ITS APPRECIATION to UNCTAD, UNDP and other United Nations Specialised Agencies for the assistance they have provided to the African Least Developed Countries in the review process of the SNPA implementation:

3. URGES Member States that have not yet done so to take the necessary measures to accelerate the ratification processes of the United Nations Convention on the Rights of the Child;

5. URGES Member States to provide the necessary human, financial and technical resources to ensure the effective functioning **of** the above-structures;
6. REAFFIRMS the commitment to achieve the objective of the universal immunization of children by the end of 1990, and APPEALS to Member **States** which have not yet attained this objective to make special effort **to** this end;
7. APPEALS to Member States to ensure that the universal immunization **of** children continues beyond 1990;
8. RECOGNIZES that the Bsmako Initiative and the Special Fund for Health in Africa which has just been **launched** are important factors of the **strategy** for revitalising the systems of health of African countries, at the **level** of the community and the periphery;
9. REQUESTS Member States to accelerate, with the assistance of UNICEF, **WHO** and other specialised agencies, the process to be set in motion under the Bamako Initiative, cornerstone of health programme;

Recalling Resolution **CM/1153 (XLVIII)** on Dumping of Nuclear and Industrial Wastes in Africa, and **CM/Res.1199 (XLIX)** on the Global Convention for the Control of Transboundary Movements **of** Hazardous Wastes,

Bearing in mind Resolution CM/Res.1261 (LI) relating to co-operation in the field of Environment especially as regards ways and means of ensuring Africa's effective participation in the activities of the Preparatory Committee on the 1992 Brazil Conference,

Noting that these resolutions addressed the grave concerns of Member States of the OAU over the dumping of hazardous wastes including radioactive wastes in Africa, as well as the shortcomings of the Basel Convention with respect to adequately preventing such dumping in Africa,

Recognizing that CM/Res.1225 (L) called for the establishment of a Working Group composed of legal and technical environment experts to draw up a Draft African Convention, the chief aims of which include the effective prohibition of the import of hazardous, including radioactive wastes into Africa, as well as to lay the foundation for addressing hazardous wastes produced in Africa to ensure an effective protection of Africa's land and territorial waters,

Having considered the report of the Secretary-General of the OAU on the implementation of CM/Res.1225 (L) on the Control of Transboundary Movements of Hazardous Wastes and their Disposal in Africa, and taking note of the results of the Second Meeting of the Working Group drafting the African Convention which convened in May 1990 pursuant to CM/Res.1260 (L):

1. COMMENDS the Secretary-General for efforts so far exerted in the implementation of CM/Res. 1225 (L) ;

Recognizing the continuing efforts of OAU Member States to eliminate armed conflicts,

Noting with concern that as a result of these continuing conflicts, African children and women continue to suffer and die in disturbingly large numbers from causes directly or indirectly related to such conflicts,

Considering the effects of the widespread externally-supported destabilization of countries continued practices of forced removal of peoples, and the consequences of apartheid and bantustan policies for child survival, health and well-being within the region,

Concerned about the use of children for military purposes wherever this may occur,

Aware of the fact that children and women make up more than 80% of the victims of these armed conflicts throughout the African continent,

Reaffirming the moral and legal obligations of African governments to put an end to the current suffering and deaths among children and women due to armed conflicts affecting their respective countries,

Reiterating the determination of African governments to take effective and timely steps, to protect the lives and promote the physical and psychological rehabilitation of children and other vulnerable groups affected by such conflicts:

1. CONDEMNS the deatlabieation acts of the countries of the Southern region, the inhuman practices **exercised** on peoples as well as the **consequences** of the **apartheid** and bantustan policies for the survival, protection and well-being of children in the region;
2. DENOUNCES the use of children for military purposes, **wherever** such practices occur;
3. INVITES every State to provide children and vulnerable groups, **living** on a territory, with all possible and timely protection and **assistance** in conflict areas;
4. CALLS UPON all parties involved in **conflicts** in Africa to negotiate and secure Areas and Corridors **of** peace wherever, and as long as **necessary**, to allow unhindered access of relief and rehabilitation workers to civilian **populations** affected by conflicts, in particular children and women, and to neutrally effect the provision of relief and **humanitarian** supplies and services needed to protect life, alleviate sufferings and promote rehabilitation;
5. REQUESTS the international community to prevail upon the Government of South Africa to put an end to all support extended from its territory to force6 **destabilizing** other countries in the region, and to stop forthwith the forcible removal of populations and destruction of **dwellings** within its borders, in order to reduce the sufferings and homelessness of children and women;
6. CALLS UPON the OAU **Secretary-General** to:
 - (a) monitor progress in alleviating the **sufferings** of children and women through **initiatives** in favour of Areas and Corridors of peace and other related measures;

1. TAKES NOTE of the report of the Secretary-General on the Declaration of the African Year of the Environment, 1991;

2. URGES the Secretary-General to put additional ~~effort~~ within the Secretariat to sufficiently be involved in the problems of the environment;
3. **DECIDES** to entrust to the Working Group in-charge of drafting the African Convention on the control of the Transboundary **Movement** of Hazardous Wastes and their disposal in Africa, as stipulated in Resolution **CM/Res.1225 (L)**, the task of ensuring the co-ordination, follow-up and evaluation of the implementation of projects relating to the Cairo programme at **continental** level;
4. REQUESTS the Secretary-General to alert the international community to the urgent need to give priority to assistance to Member States **directly** affected by drought and desertification to enable them implement their national programmes to control these scourges;

Considering Resolution **AFR/RC 38/R 14** on the Special Fund for Health in Africa adopted by the 38th Session of the WHO Regional Committee for Africa held in Brazzaville from 7 to 14 September 1988, particularly its sub-paragraph 4 which confers a specific mandate on the WHO Regional Director for Africa,

Bearing in mind the practical measures taken by the WHO Regional Director for Africa to ensure the effective launching of the Fund,

Aware of the crucial role which the Fund can play in the implementation of Health Programmes in the most under-privileged African Communities, especially in

terms of the provision of hard currency for the requisition of modern equipment and materials:

1. EXPRESSES SATISFACTION at the launching of the Fund by OAU Secretary-General;
2. COMMENDS the WHO Regional Director for Africa on the practical and realistic steps taken to implement the Declaration of the OAU Heads of State and Government and EXTENDS its gratitude and appreciation to him;
3. REQUESTS Member States to set up national mechanisms necessary for the mobilization of funds and their distribution to needy communities;
4. URGES urban and rural communities to establish mutual assistance or solidarity fund for health which could be supplemented by the Special Fund;
5. CALLS UPON the international community and more particularly African executives to participate in the mobilisation of resources for the Fund;
6. CALLS UPON Member States to launch fund-raising campaigns both at the national and international levels;

RESOLUTION ON THE IMMUNIZATION OF CHILDREN IN AFRICA

The Council of Ministers of the Organisation of African Unity, meeting in its Fifty-second Ordinary Session in Addis Ababa, Ethiopia, from 3 to 8 July 1990,

Having considered the Report of the Secretary-General on the implementation of Declaration AHG/Decl. 1 (XXIII) adopted by the OAU Heads of State and Government on "Health - the Basis for Development", Doc. CM/1623 (LII),

Considering that there can be no socio-economic development on the Continent without the provision of sound health facilities for our peoples,

Aware of the fact that this phenomenon is a result of a very high infant mortality rate, malnutrition, premature death, chronic health problems and inability to work during years of active life,

Considering that most of these health problems are caused by diseases that could be prevented,

Firmly convinced that health for all can only be achieved through multi-sectoral co-operation among Ministers of Members States, international inter-governmental and non-governmental organisations,

Considering the Extended Programme of Immunisation (EPI) launched, in the WHO African Region within the Primary Health Care Programme to combat the 6 childhood diseases for which a vaccine has been discovered, namely; tuberculosis, **diphtheria**, whooping cough, tetanus, poliomyelitis, and measles!

1. **COMMENDS** the OAU Secretary-General, the WHO Regional Director for Africa and the UNICEF Executive Director for the **initiative** taken to implement the EPI in Africa:
2. **RECOMMENDS** that these efforts be pursued through regular vaccination campaigns organised by the National Health Services which offer to **each** child, during his early years as well as to women of child bearing **age**, suitable and appropriate vaccinations:
3. **RECOMMENDS** that:
 - A. Member do everything possible to:
 - (i) improve EPI **management to cover** their entire national territories:
 - (ii) train the majority of local **EPI** personnel or auxiliary EPI staff (supervisors, workers responsible for preserving vaccines, providing logistic support and maintenance of equipment . . .) ;
 - (iii) introduce methods for ensuring maximal **community** participation:
 - (iv) eliminate neo-natal **tetanus** by the year 1995 and eradicate poliomyelitis by the year 2000:
 - B. The International Community pools its efforts in order to:
 - (i) improve EPI management activities:
 - (ii) initiate and implement training and refresher **courses**;
 - (iii) co-ordinate **operational research activities**;
4. **REQUESTS** the OAU Secretary-General, the WHO Regional Director for Africa and the UNICEF Executive Director to take appropriate steps to evaluate, during the course of 1993, the support given to the EPI programme and the progress made in the elimination of neo-natal tetanus and the eradication of poliomyelitis.

RESOLUTION ON THE PREVENTION AND CONTROL OF AIDS IN AFRICA

The Council of Ministers of the Organisation of African Unity, meeting in its Fifty-second Ordinary Session in **Addis** Ababa, Ethiopia, from 3 to 8 July 1990,

Considering the progress report of the Secretary-General in **Document** CM/1623 (LII) on Health: Basis for development,

Recalling Resolution **CM/Res.6** (LII) of the Conference of African Ministers of Health of the OAU, meeting in its 3rd Ordinary Session in Keunpala, Uganda in May 1989,

Commending the resolute support of Member States to the anti-AIDS campaign strategy and for the implementation of the activities at regional and national levels,

Noting with satisfaction the wide ranging efforts made by the international community in strong spirit of solidarity in the fight against AIDS disease,

Considering the rapid increase in the prevalence of AIDS which has transformed it into one of the major health problems of the world in general and of Africa in particular,

Concerned with the distinctive threat to the youths and its adverse impact on the socio-economic development and population equilibrium of Member States,

Acknowledging the importance of **integration** into other Primary Health Care activities, decentralisation and research for the success of the anti-AIDS campaign:

1. CALLS ON Member States to:

- (i) further intensify and accelerate the process of integration and include the AIDS campaign as one of the priorities in their socio-economic and health development programmes;
- (ii) promote and develop information flow, education and communication systems in order to increase public awareness;
- (iii) enhance their collaboration with WHO, UNICEF and other international organizations as well as with other OAU Member States in a spirit of genuine dialogue and free exchange of information;
- (iv) pay special attention to the protection of children, adolescents and nationals in rural areas;
- (v) strengthen their anti-AIDS programmes with special emphasis on blood transfusion services, uses of sterile instruments, personal hygiene, water supply and integration with other Primary Health Care activities as well as decentralisation, training and research:

- (vi) protect the rights and dignity of nationals with HIV infection or suffering from AIDS;
2. EXPRESSES ITS **GRATITUDE** to the WHO and the international community for their support to the campaign against AIDS and the attempts made to **decentralize** the **campaign** activities in accordance with the principles of Primary Health Care;

- (b) to act as a servicing institution for its Member States with respect to integrated rural development, by providing them with technical support, by fostering the exchange of ideas and experience and by encouraging such joint or collaborative activities as may benefit those States individually or collectively;

Noting that the application submitted by CIRDAFRICA meets the criteria for granting OAU Observer Status as adopted by the Assembly of Heads of State and Government;

1. TAKES NOTE of the report of the Secretary-General on the application for OAU Observer Status submitted by the Centre on Integrated Rural Development for Africa (CIRDAFRICA), Document. CM/ 1625;
2. DECIDES to grant OAU Observer Status Category "B" to CIRDAFRICA.

Resolutions adopted by the Assembly of Heads of State and
Government of the Organization of African Unity at its
twenty-sixth ordinary session

AHG/Decl.1 (XXVI)

DECLARATION OF THE ASSEMBLY OF HEADS OF STATE AND GOVERNMENT
OF THE ORGANIZATION OF AFRICAN UNITY ON THE POLITICAL AND
SOCIO-ECONOMIC SITUATION IN AFRICA AND THE FUNDAMENTAL
CHANGES TAKING PLACE IN THE WORLD

We, the Heads of State and Government of the Organisation of African Unity, meeting at the Twenty-sixth Ordinary Session of our Assembly in Addis Ababa, Ethiopia, from 9 to 11 July 1990, have undertaken a critical review of the political, social and economic situation of our continent, in the light of the rapid changes taking place in the world and their impact on Africa, as presented in the Report of the Secretary-General on the Fundamental Changes taking place in the World and their Implications for Africa: Proposals for an African Response.

2. In particular, we have noted the changing East-West relations from confrontation to cooperation, the socio-economic and political changes in Eastern Europe, the steady move towards the political and monetary union of Western Europe, the increasing global tendency towards regional integration and the establishment of trading and economic blocs, as well as the advances in science and technology. These, we found, constitute major factors which should guide Africa's collective thinking about the challenges and options before her in the 1990s and beyond in view of the real threat of marginalisation of our continent.

3. We noted with satisfaction, the achievements of Africa, in the struggle for the decolonization of the continent and, in the fight against racism and apartheid, as well as the positive role played by the OAU in this respect. The independence of Namibia has pushed further Africa's frontier of freedom.

4. We took note of the measures taken by Mr. de Klerk, which provide ground for optimism. We cautioned however, that these changes fall far short of our common objective of totally dismantling apartheid. Unless and, until the racist minority government is irreversibly committed to the eradication of this anachronistic system, the international community must continue to exert all forms of pressure including in particular, economic sanctions against South Africa. This, our collective view, is also the demand of the National Liberation Movements of that country. We wish at the same time to reaffirm our solidarity with the oppressed people of South Africa and to assure them of our undivided support at this crucial phase in their struggle. At the same time we urge them to close their ranks and unite their forces.

5. The socio-economic situation in our continent remains precarious today despite the many efforts made by our countries, individually and collectively. At our

Second Extra-ordinary Assembly in Lagos, Nigeria in April 1980, we adopted the Lagos Plan of Action for the economic development of Africa up to 2000 and the Final Act of Lagos. At the Twenty-first Ordinary Session of our Assembly held here in Addis Ababa in July 1985, we also adopted Africa's Priority Programme for Economic Recovery 1986-1990. Equally, in the face of the excruciating external debt burden, we convened the Third Extraordinary Session of our Assembly and adopted the African Common Position on Africa's External Debt Crisis. In all these endeavours, we were guided by the principle of collective self-reliance and self-sustaining development.

6. These represented our collective attempt, to institute measures to arrest, and reverse the steady decline in Africa's economic performance. Despite these attempts and strong political commitment to them, it has not so far, been possible to achieve our objective of laying a firm foundation for self-sustained development of our countries. On the contrary, throughout the decade of the 1980s most of our productive and infrastructure facilities continued to deteriorate. The per capita incomes of our peoples fell drastically and so did the volumes of our exports as well as imports. There has been sharp decline in the quality of life in our countries, as spending on public health, housing and education and other social services had to be severely curtailed. Food production has also fallen, in proportion to the expanding population. All this contrasted sharply with the alarming rise in Africa's external debt stock which shot up from about 50 billion US Dollars in 1980 to about 257 billion US Dollars by the end of 1989. As a result of this combination of acute economic problems and external indebtedness, the number of African Member States classified as least developed rose from 21 to 28 during the same period.

7. Our countries have made serious efforts to cope with the most adverse consequences of this difficult economic situation. Most of our countries have entered into structural adjustment programmes with the international financial and monetary institutions - mostly at heavy political and social costs. But we realize that these are short term measures and are by themselves insufficient to completely restore our economies to sound footing and lay firm foundation for future growth. We are very much concerned that, in addition to these problems, there is an increasing tendency to impose conditionalities of political nature for assistance to Africa.

8. We reaffirm that Africa's development is the responsibility of our governments and peoples. We are now more than ever before determined to lay solid foundation for self-reliant, human-centered and sustainable development on the basis of social justice and collective self-reliance, so as to achieve accelerated structural transformation of our economies. Within this context, we are determined to work assiduously towards economic integration through regional cooperation. We are also determined to take urgent measures to rationalize the existing economic groupings in our continent in order to increase their effectiveness in promoting economic integration and establishing an African Economic Community.

9. These are objectives we set for ourselves in Lagos in 1980. We reaffirm their continued validity as well as the fundamental principles of the Lagos Plan of Action and Africa's Priority Programme for Economic Recovery, including the

sectoral priorities contained in them in particular, the urgent need to attain self-sufficiency in food production, to promote science and technology for development and, to establish a viable industrial base on the continent. In this context, we commit ourselves to the pursuit of sound population and **environmental** policies conducive to economic growth and development of our continent.

10. We are fully aware that in order to facilitate this process of **socio-economic** transformation and integration, it is necessary to promote popular **participation of our peoples** in the processes of government and development. A permitting **political** environment which guarantees human rights and the observance of the rule of law, would ensure high standards of probity and accountability, particularly on the part of those who hold public office. In addition, popular-based political **processes** would ensure the involvement of all including in particular women and youth in the development efforts. We accordingly recommit ourselves to the further democratisation of our societies and to the consolidation of democratic institutions in our countries. We reaffirm the right of our countries to determine, in all sovereignty, their system of democracy on the **basis** of their socio-cultural values, taking into account the realities of each of our **countries** and the necessity to ensure development and **satisfy the basic** needs of our peoples. We therefore assert that democracy and development should go **together** and should be mutually reinforcing.

11. We realise at the same time that the possibilities of achieving the **objectives** we have set will be constrained as long as an atmosphere of lasting peace and Stability does not **prevail** in Africa. We therefore renew our determination to work together towards the peaceful and Speedy resolution of all the conflicts on our continent. The resolution of conflicts will be conducive to the **creation of peace** and stability in the Continent and will also **have** the effect of reducing expenditures on defence and security, thus releasing additional resources for socio-economic **development**. We are equally determined to make renewed effort to eradicate the root causes of the refugee problem. It is only through the **creation of stable conditions** that Africa can fully harness its human and **material resources** and direct them to development.

12. At this crucial juncture when our continent is emerging with difficulty, from a phase in its history, that focused mainly on political liberation and nation building, and is about to embark on a new era laying greater emphasis on **economic** development, we need to strengthen the **Organization** of African Unity so that it may also become a viable instrument in the service of Africa's economic **development** and integration. Consistent with this goal, we rededicate ourselves to the principles and objectives enshrined in its Charter! to our faith in ourselves and to our continent, with greater determination to be masters of our destiny. In this spirit, we reaffirm our commitment to revive the ideals of Pan-Africanism and commit ourselves, individually and collectively, on behalf of our governments and peoples to maintain and strengthen our unity and solidarity and, to **pool** our resources and wisdom in order to face the challenges of the decades of the 1990s and beyond, change the bleak *socio-economic* prospects of our **continent** and guarantee a better life for all our peoples and future generations yet unborn. These objectives are well **within** our capabilities. We, therefore, **pledge** to apply ourselves fully to the achievement of these objectives.

13. The achievement of these objectives will also require an international cooperation and solidarity, as well as fundamental changes in ~~the~~ international economic system. The continuing plummeting of the prices of Africa's ~~commodities~~, skyrocketing of ~~prices~~ of manufactured goods and the growing burden of external debt and the attendant reverse flow of ~~resources~~ constitute external factors which severely constrain our efforts for economic ~~recovery~~. The developed countries bear a major responsibility for the transformation of the present inequitable international system. On our part, we will continue to strive for the establishment of a just and equitable international economic system. In this connection, a revitalised Non-Aligned Movement can play a decisive role.

14. We recommit ourselves to strengthen the South-South Cooperation and to play a lead role in this ~~regard~~. We also wish to express our readiness to work in concert with other countries and regions of the developing world, to reactivate North-South dialogue and cooperation. We do believe that an increasingly inter-dependent world calls for greater international solidarity and that peace and prosperity ~~should~~ be shared ~~for~~ the common ~~good~~ of humanity.

15. We request the Secretary-General to monitor the implementation of this ~~Declaration~~ and to take all necessary actions in this respect, in ~~collaboration~~ with the United Nations Economic Commission for Africa, African Development Bank and other African and International Institutions. We also request him to ~~ensure~~ the widest possible dissemination of this Declaration and to ~~sensitize~~ African public opinion and the international community on its content.

DECLARATION ON THE SITUATION IN THE MIDDLE EAST

The Assembly of Heads of State and Government of the Organisation of African Unity, meeting in its Twenty-sixth Ordinary Session in Addis Ababa, Ethiopia, from 9 to 11 July 1990,

Having discussed the situation in the Middle East and Palestine, views with deep concern the dangers threatening the future of peace and security in the region and the escalation of tension which leads the region to the verge of war as a result of Israel's intransigence and the continued occupation of the Palestinian and Arab territories,

The Assembly followed with grave concern the Developments resulting from the Israeli expansionist settlement policy in the process of transfer of Soviet Jews to occupied Palestinian and other Arab occupied territories,

The Assembly considered the process of transfer of Soviet Jews and their illegal settlement in these occupied territories and the measures accompanying it as a prelude to the deportation of the Palestinian people from their homeland, and the confiscation of their properties to accommodate the newly coming Soviet Jews,

The Assembly calls upon the State concerned in this transfer of population in particular, and the International Community in general to put an urgent end to this dangerous process and calls for the guarantee of the Palestinian people's national rights,

Furthermore, the Assembly calls upon the USA to resume the dialogue with the Palestine Liberation Organization in order to achieve serious progress in the peace process in the Middle East, and reaffirms the necessity of convening the International Conference for Peace under the auspices of the UN with the participation of all concerned parties including the PLO on equal footing.

DECISION ON THE SCHEDULING OF THE ORDINARY SESSIONS OF THE ASSEMBLY OF HEADS OF STATE AND GOVERNMENT ON A FIXED DATE

The Assembly of Heads of State and Government of the Organization of African unity, meeting in its Twenty-sixth Ordinary Session, in Addis Ababa, Ethiopia, from 9 to 11 July 1990,

Having heard the report of the Secretary-General on his congratulations on the proposal of the principle of holding the Ordinary Sessions of the Assembly of Heads of State and Government on a fixed date,

Taking note of the unanimity of agreement on the principle of a fixed date,

Taking note also of the consensus on the date of first Monday of every June as the fixed date for the commencement of the Ordinary Session of the Assembly of Heads of State and Government,

Convinced that a fixed date will facilitate the scheduling of these meetings, in the work programmes of the Heads of State and Government and ensure greater rationalization of the activities of the Organization:

1. DECIDES to adopt the first Monday of June as a fixed date for the holding of the Ordinary Sessions of the Assembly of Heads of State and Government of the OAU;
2. FURTHER DECIDES that in the event that this date coincides with an important religious holiday observed by many Member States, appropriate date adjustments will be made through consultations.

**DECISION ON THE REPORT OF THE CURRENT CHAIRMAN ON THE ACTIVITIES
OF THE CONTACT GROUP ON AFRICA'S EXTERNAL DEBT CRISIS**

The Assembly of Heads of **State** and Government of the Organisation of **African** Unity, meeting at its Twenty-sixth Ordinary Session in **Addis Ababa**, Ethiopia, from 9 to 11 July 1990,

Having considered the report. of the Current Chairman on the activities **of** the Contact Group on Africa's Debt Crisis,

1. DECIDES to:

- (a) mandate the Current Chairman to **continue with the effort already made** and explore all **possible** avenues for solving *Africa's debt crisis*;
- (b) *renew* the mandate of the Contact Group of the **Current Chairman on Africa's External Debt Crisis**;
- (c) convene a seminar to be attended by experts to evaluate the debt relief **measures** so far taken to tackle the debt problem and **propose** new strategies for the implementation of the **African Common Position on Africa's Debt Crisis**;
- (d) request the Contact Group to prepare and **organize** the seminar with the support of the joint Secretariat **of** OAU, ECA, **ADB** and **ACMS**.

2. ACCEPTS with appreciation the kind offer **of** the Government of Uganda to host the **seminar**;

3. EXPRESSES ITS APPRECIATION to **H.E. President Hosni Mubarak**, the Out-going Chairman of the QAU for his untiring effort to find **a** lasting **solution to** Africa's debt crisis.

RESOLUTION ON THE ESTABLISHMENT OF THE AFRICAN ECONOMIC COMMUNITY

The **Assembly** of Heads of **State** and Government of the Organisation of **African** Unity, meeting in its Twenty-sixth Ordinary Session in **Addis Ababa**, Ethiopia, from 9 to 11 July 1990,

Recalling the relevant provisions of the Lagos Plan of Action and, more particularly, of the Final Act of Lagos, adopted in April 1980,

Recalling further its Resolutions **AHG/Res.161 (XXIII)** and **AHG/Res.179 (XXV)** adopted respectively by the **Twenty-third** and **Twenty-fifth Ordinary Sessions** of the **Assembly** of Heads of State and Government, as well as other relevant **decisions and** declarations,

Having considered the **conclusions** and the recommendations adopted by the OAU Permanent Steering Committee *in* its Eighteenth, Nineteenth and Twentieth **Ordinary Sessions**, on the proposed **establishment** of the **African Economic Community** (Doc. AHG/174 (XXVI)):

1. APPROVES the conclusions and recommendations of the Eighteenth, **Nineteenth** (Doc. CM/1585 (LI)) and Twentieth (Doc. CM/1610 (LII)) **Ordinary Sessions** of the Permanent Steering Committee endorsed by the Fifty-first and Fifty-second Ordinary **Sessions** of the Council of Ministers, and, in particular, the principle of **merging** the OAU and the Community into a **single** Organisation with the Secretariat, in accordance with the **policy** decisions already taken by the appropriate organs of the **Organization**;
2. EXPRESSES SATISFACTION with the excellent work done by the Permanent Steering Committee under the supervision of the Current Chairman, **in** preparing and finalising the Draft Treaty in accordance with the **indicative** time-table adopted by the Assembly in July 1989;
3. **ENDORSES** the decisions of the Fifty-first Ordinary Session of the Council to set up the **Ad Hoc** Drafting Committee of the Whole to prepare the **Draft** Treaty and INSTRUCTS the latter to complete its task as soon as possible, so that the final text can be submitted through the Permanent **Steering** Committee to the Fifty-third session of the Council, for its **adoption** and signature by the Assembly of Heads of State and Government;
4. MANDATES **the** Current Chairman to undertake the necessary consultations with his peers, with a view to determining the **most** appropriate time and identifying the conditions necessary for the *signing* of the Treaty, before or during the Twenty-seventh Ordinary Session of **the Assembly** of Heads of State and Government;
5. URGES all Member States to take the necessary measures, through their national press, to alert the **African** populations to the importance and scope of the proposed establishment of the African Economic **Community**;

REQUESTS the OAU Permanent Steering Committee, with the technical and financial assistance of the OAU, ECA, ADB and UNDP secretariats, to speed up the technical studies in order to identify the operational aspects and modalities for the early take-off of the activities and programmes of the Community, bearing in mind, **inter alia**:
 - (a) the technical, legal, structural and institutional implications of the merger of the OAU with the Community;
 - (b) the stages and procedure for the early and gradual **establishment** of the Community;
 - (c) the functional and structural links between the Pan-African Community and Regional Economic Communities;
 - (d) the establishment of a Pan-African **Assembly**.

7. FURTHER REQUESTS the Permanent Steering Committee to **continue**, with the technical and material assistance of the Joint **OAU/ECA/ADB Secretariats** as well as that of appropriate African Organizations, **the preparation and finalisation of the Protocols**, Priority will be given to Protocols that would accelerate the **realization** of the Community's objectives;
8. FURTHER REQUESTS the **OAU Ad Hoc**, Charter Review Committee to **accelerate** its work taking into account the relevant provisions of the Treaty Establishing the African Economic Community, with a view **to ensuring the gradual realization of the economic and political integration of the Continent**;
9. FURTHER REQUESTS the OAU Secretary-General to submit periodic report! on the implementation of this resolution.

Convinced that intra-African tourism constitutes a significant instrument for ensuring understanding **among** the African peoples, peace and socio-cultural and political integration of the continent,

Aware of the Resolution **CMT/2/89/2** on the "African Year of Tourism" **adopted** by the Conference of African Ministers of Tourism, convened in November 1989 **under** the auspices of the UN Economic Commission for Africa (**ECA**), requesting the **African** Heads of State and Government to endorse their recommendations;

1. DECIDES to Proclaim 1991.: **"AFRICAN YEAR OF TOURISM"**;
2. CALLS UPON all Member States to closely co-operate in the field of tourism and request the Secretary-General to **sensitize** and assist **them** in this endeavour;

RESOLUTION ON THE WORLD SUMMIT ON CHILDREN

Aware that well-being, in general, and good health, in particular, constitute vital factors in the socio-economic development of Africa,

1. EXPRESSES ITS APPRECIATION for the action of the Governments of Mali, Egypt, Canada, Pakistan, Mexico and Sweden in calling for a World Summit for Children to be held at the United Nations in New York, 29-30 September 1990;
2. FURTHER EXPRESSES APPRECIATION for the work of the Planning Committee and the Secretariat services provided by the United Nations Children's Fund (UNICEF) ;
3. CALLS UPON Member States to participate in the World Summit for the Children and to support the adoption and implementation of the decisions, particularly, those aimed at ensuring a more promising and brighter future for children in the 90s;
4. REQUESTS the Secretary-General of the OAU to submit a report to the Twenty-seventh Ordinary Session of the Assembly of Heads of State and Government of the OAU on the progress made in the implementation of this resolution.

RESOLUTION ON THE QUESTION OF THE COMORIAN ISLAND OF MAYOTTE

The Assembly of Heads of State and Government of the Organisation of African Unity, meeting in its Twenty-sixth Ordinary Session in Addis Ababa, Ethiopia, from 9 to 11 July 1990,

Noting the report of the Secretary-General, CH/1591 (LII), Part II,

Recalling the relevant **OAU** resolutions on the Question of the Comorian Island of **Mayotte**, **in** particular Resolution **CM/Res.1152 (XLVIII)**,

Recalling further the relevant resolutions and decisions of the UN, the Movement of the Non-Aligned Countries, the Islamic Conference and the League of Arab States,

Also recalling the Programme of Action recommended by the **OAU Ad Hoc** Committee of Seven, in **Doc./Cttee.7** (Mayotte) Res.1-9 (II), adopted in **Moroni in** November 1981,

Reiterating the legitimacy of the Comorian Government's claims for the re-integration of the Comorian Island of **Mayotte** into the Federal Islamic Republic of Comoros,

Noting with satisfaction the willingness of the new authorities of Comoro:: and the French Government to pursue the dialogue, with a view to finding a just solution to the Question of the Comorian Island of **Mayotte**:

1. TAKES **NOTE** of the report contained in **Document** CM/1591 (LII), Part II:
2. REAFFIRMS the Sovereignty of the Islamic Federal Republic of the **Comoros** over the Comorian Island of **Mayotte**;
3. APPEALS to the **French** Government to satisfy the legitimate claims of the Comorian Government, as indicated in the relevant **OAU** and UN resolutions, those of the Government of Non-Aligned Countries, of the Islamic Conference and of the League of **Arab States**;
4. REAFFIRMS ITS SOLIDARITY with the Comorian people in their determination to recover their political integrity and defend their sovereignty and territorial integrity;
5. INVITES the **OAU Member States** to extend utmost efforts, individually and collectively, in order to inform and **sensitize** the French and international public opinion about the Comorian Island of **Mayotte** with a view to inducing the French Government to put an end to this **situation**;
6. APPEALS to all OAU Member States and the international community to condemn and categorically reject any form of consultation that **could be** organised by France on the Comorian Island of Mayotte, on the legal international status of the Island, since the referendum for self-determination held on 22 December, remains the only valid consultation applicable to the entire archipelago;
7. APPEALS FURTHER to **all** the **OAU** Member States and to the international community to **condemn** any initiative that could be taken by France to bring about **participation** of the Comorian Island of **Mayotte** in manifestatio. **which** the island would be distinguished from the Islamic Federal **Republic** of the Comoros;

8. REQUESTS the Ad Hoc Committee of **Seven** on the Question of the **Comorian** Island of Mayotte as well as the **OAU** General Secretariat to resume the dialogue with the French Authorities to exert further efforts with a view to restoring, as early as possible, the Comorian Island of Mayotte to the Islamic Federal Republic of the Comoros;
9. REQUESTS that the Question of the Comorian Island of Mayotte remains on the agenda of all the OAU meetings, on those of the Movement of Non-Aligned Countries, the Islamic Conference and the League of Arab States until the Comorian Island of Mayotte is restored to the Islamic Federal Republic of the Comoros;
10. ALSO REQUESTS the OAU General Secretariat to report to the Council of Ministers at its next Session.

4. REQUESTS the OAU Secretary-General to submit a report to the Twenty-seventh Ordinary Session of the OAU Assembly of Heads of **State** and Government.

RESOLUTION ON THE ESTABLISHMENT OF A COMMITTEE ON CONFERENCES

The Assembly of Heads of State and Government of the Organization of African Unity, meeting in its Twenty-sixth Ordinary Session in Addis Ababa, Ethiopia, from 9 to 11 July 1990,

Having heard the Report of the Secretary-General on the establishment of a Committee on Conferences,

In adopting the said schedule, the Committee shall determine the priorities considering the importance of the meetings and resources of the Organization. It shall also follow-up the implementation of the schedule and report to the Council of Ministers;

RESOLUTION ON INTERNATIONAL CO-OPERATION FOR AFRICAN ECONOMIC AND SOCIAL RECOVERY AND DEVELOPMENT

The Assembly of Heads of State and Government of the Organization of African Unity, **meeting** in its Twenty-sixth Ordinary Session in Addis Ababa, Ethiopia, from 3 to 11 July 1990.

I?? African Priority Programme for Economic Recovery and Development adopted by the Twenty-first Session of our Assembly,

Recalling further its Resolutions AHG/Res.185 (XXV) concerning external debt and AHG/Res.187 (XXV) concerning resource flows,

Noting the recent international consensus on the profound and long-term nature of the African Crisis and the way to deal with it, which was manifested at the African Conference held in Maastricht, Netherlands on July 2-4, 1990, calling for continued African efforts to be supported by adequate and sustained external finance,

Further noting with satisfaction the conclusions of the Summit Conference of the Group of 15 on South-South Co-operation held in Kuala Lumpur, Malaysia from 1st to the 3rd June 1990,

Noting further that in response to the crisis, and shocks of the 1980s most African Governments have adopted far-reaching adjustment programmes at high social costs for African peoples and governments,

Noting the efforts of the IFIs, the AFDB and the international community to support African recovery, especially the World Bank/AFDB/UNDP initiative on SDA which has come in the last two years as a welcome complement to necessary economic adjustments,

Concernedtheless, that the prospects for the 1990s may well be affected by the continuation of:

unfair international trade practices;

reverse resource flows to Africa against a background of competing claims for scarce resources; and

inadequate relief from the excruciating burden of external debt:

and that such factors could threaten African recovery and wreak havoc with the well-being of African populations:

1. CALLS UPON the World Bank and other development partners in the international community to provide all possible support to the resolutions and the conclusions of Africa Conference held from 2 to 4 July 1990 in Maastricht (Netherlands) with a view to creating a global coalition for Africa which would represent a new international partnership for the coming decade, giving due recognition to the long-term nature of the African Crisis;
2. REQUESTS the World Bank to take the lead, along with the African Development Bank in a world-wide effort to mobilize additional concessional resource flows for Africa, including but not limited to:
 - (i) a second three-year Special Programme of Assistance for Africa for the period 1991-1993;
 - (ii) replenishing the Africa Development Fund (ADF) at levels significantly exceeding the present levels of ADF-5;
 - (iii) allocating 50 per cent of IDA-S resources to African countries;
 - (iv) developing suitable instrumentalities for the financing needs of the African middle-income countries,
 - (v) supplementing the current paucity of private capital flows to Africa;

3. REQUESTS the **IFIs** along with the African Development Bank, to **redouble** international efforts at obtaining **more** far-reaching debt relief including:
 - (i) reviewing the Toronto approach with a view to expanding its **scope** and its coverage to include middle-income countries;
 - (ii) **extending** the World Bank Group's IDA-financed debt-buyback **facility** to cover **more** countries²
 - (iii) exploring further means of **rationalizing** debt service, relating it to need and ability to pay (refer to **AHG/Res.181** (XXV)).
4. REAFFIRMS the determination of African countries to promote **South-South** Co-operation through the deepening of consultations and the **development** of trade among developing countries;
5. REAFFIRMS the will of **our** Member States and the **OAU** to **work closely** with all the parties concerned to ensure that the Uruguay Round of trade negotiations takes adequate cognizance of the special circumstances of **African** economies that **have suffered** such profound **terms of trade shocks** and APPEALS to the other contracting parties to co-operate in this regard;
6. REQUESTS the Secretary-General of the OAU to collaborate with the **AFDB**, **ECA** and the **IFIs** in ensuring that adequate actions are taken to promote economic integration in Africa (refer to **AHG/Res.179** (XXV)).

AHG/Res. 197 (XXVI)

RESOLUTION ON THE ADOPTION OF THE AFRICAN CHARTER ON THE
RIGHTS AND WELFARE OF THE AFRICAN CHILD

The **Assembly** of Heads of State and Government of the Organisation of **African** Unity, meeting in its Twenty-sixth Ordinary Session in **Addis Ababa**, Ethiopia, from 9 to 11 July 1990,

Recalling Declaration **AHG ST.4** (XVI) Rev.1 on the Rights and Welfare of the African Child;

Noting the progress made towards, in the universal vaccination of **children**,

Inspired by the implementation of the **Bamako** Initiative and the establishment of the Special Health Fund for Africa,

Conscious of the important place children occupy in **our** societies and especially the fact that the future of the continent depends on the active **forces** represented by healthy and well developed children;

Convinced of the need to drastically reduce the rate of infant **mortality** in Africa through an adequate health policy;

Bearing in mind the importance of the World Summit on the Child scheduled for New York, 29 - 30 September 1990;

Also bearing in mind the importance of this Summit and the need for high-level representation of the African Continent:

Convinced that Africa, the youngest continent in the world, should spearhead activities in favour of the child;

1. REAFFIRMS its unflinching commitment to the cause of children and other categories of vulnerable persons;
2. DECIDES to adopt the African Charter on the Rights and the Welfare of the Child and to present it to the World Summit on the Child as Africa's contribution to the cause of its children;
3. APPEALS to all Member States to take the necessary measures to implement the African Charter on the Rights and Welfare of the Child;
4. REQUESTS the Secretary-General to present, each year, a report on the activities carried out within the framework of this resolution.

AHG/Res.198 (XXVI)

RESOLUTION ON THE AFRICAN COMMISSION ON HUMAN AND PEOPLES' RIGHTS

The Assembly of Heads of State and Government of the Organisation of African Unity, meeting in its Twenty-sixth Ordinary Session in Addis Ababa, Ethiopia, from 9 to 11 July 1990,

Having considered the Annual Activity Report of the African Commission on Human and Peoples' Rights, submitted by the Commission's Chairman, Prof. U. O. UMOZURIKE, pursuant to Article 54 of the African Charter on Human and Peoples' Rights,

Considering that the respect of Human and Peoples' Rights is a condition and a factor for the development of individuals and peoples:

1. TAKES NOTE WITH SATISFACTION of the Activity Report of the Commission on Human and Peoples' Rights and AUTHORIZES that it should be published;
2. ENCOURAGES the Commission to intensify its activities for a better awareness and a wider dissemination of human rights in Africa.

AHG/Res.199 (XXVI)

RESOLUTION ON THE MAURITANIA/SENEGAL DISPUTE

The Assembly of **Heads** of State and Government of the Organisation of **African** Unity, meeting in its Twenty-sixth Ordinary Session, in **Addis** Ababa, Ethiopia, from 9 to 11 July 1990,

Having heard the report of the outgoing Chairman of the Organisation of **African** Unity, President Hosni Mubarak, on the Mauritania/Senegal dispute,

Considering the basic principles **shrined** in the Charter of the **Organization** of **African** Unity,

Recalling Resolution CM/1217 (L) on the dispute between **Mauritania** and **Senegal**,

Taking note of the sustained **efforts** exerted by H.E. President Hosni Mubarak, in co-operation with the **CAU** Committee on Mauritania/Senegal dispute, in order to reach a peaceful and lasting settlement of the dispute,

Noting further that Mauritania and Senegal have expressed the **will** to pursue their negotiations, with a view to arriving at a peaceful settlement of their **dispute**, and their confidence in the inter-African Ministerial Committee of the OAU in the latter's mediation **efforts**,

Noting further the determination of the members of the said Committee to carry out the task assigned to them:

1. APPROVES the report of the outgoing Chairman of the Organization of African Unity;
2. CONGRATULATES President Hosni Mubarak and all the Committee Members on their sustained efforts with the view to arriving at a Peaceful and lasting settlement of the Mauritania/Senegal dispute;
3. EXPRESSES its satisfaction at the contacts established between **Mauritania** and **Senegal** and at their determination to maintain these **contacts** under the auspices of the OAU inter-African Ministerial Committee;
4. RENEWS the mandate of the African Inter-Ministerial **Committee** on the Mauritania/Senegal dispute, composed of Egypt, Niger, **Nigeria**, Togo, Tunisia and Zimbabwe and chaired by Uganda;
5. APPEALS to the two sides to promote a climate of confidence which will lead, as early as possible, to negotiations on the issues which constitute the core of their dispute;
6. REQUESTS the Current Chairman of the OAU to submit a report on the issue to the Twenty-seventh Ordinary Session of the Assembly of **Heads** and State and Government.

AHG/Res.200 (XXVI)

RESOLUTION ON THE CHAD/LIBYA TERRITORIAL DISPUTE

The Assembly of Heads of State and Government of the Organization of African Unity, meeting in its Twenty-sixth Ordinary Session in **Addis** Ababa, Ethiopia, from 9 to 11 July, 1990,

Having heard the report of the OAU Ad hoc Mediation **Committee** on the Chad/Libya Territorial Dispute,

Considering decision **AHG/Dec.108** (XVI) establishing the Ad Hoc Mediation Committee on the Chad/Libyan Territorial Dispute,

Considerins further Resolution **AHG/Res.158** (XXII) reactivating the said Committee.

Considering the basic principles of the OAU Charter,

Recalling the relevant resolutions relating to the settlement of disputes among African States, in particular, resolution **AHG/Res.16** (1) on the inviolability of borders inherited from colonialism,

Recalling further the OAU resolutions, decisions and recommendations on the Chad/Libya question,

Also recalling resolution **AHG/Res.134** (XXV) on the Chad/Libya Territorial Dispute,

Noting the laudable efforts deployed by H.E. President El Hadj Omar **BONGO** in the search for a just and lasting solution to the Chad/Libya Territorial Dispute,

Noting further the goodwill of the two parties, Chad and Libya, to settle peacefully, their difference:

1. ADOPTS the report of the Chairman of the OAU Ad Hoc Mediation Committee on the Chad/Libya Territorial Dispute:
2. COMMENDS President El Hadj Omar BONGO, Chairman of the OAU Ad Hoc Mediation Committee on the Chad/Libya Territorial Dispute, particularly, for the laudable efforts he has constantly deployed to find a peaceful and, ~~note~~ especially, a political solution to the dispute and REAFFIRMS its full confidence in him:
3. EXPRESSES SATISFACTION at the signing on 31 August, 1989, in Algiers, of the framework agreement on the peaceful settlement of the territorial dispute between Chad and Libya, as well as the contacts established between the two parties with a view to implementing the said **agreement**;

4. INVITES the two parties to pursue these contacts in order to achieve a peaceful **settlement** of the difference in the shortest possible time, duly taking into account the issues left in abeyance at the end of the Third Tripartite Meeting in Libreville, and to continue to co-operate **closely** with the **OAU Ad Hoc** Mediation Committee on the Chad/Libya Territorial Dispute;
5. REQUESTS the Chairman of the Committee to report to the **Twenty-seventh** Ordinary Session of the Assembly of Heads of State and Government.
