I would like to take this opportunity to draw your attention to the letter of the representative of Azerbaijan circulated on 21 December 2010 (A/65/601-S/2010/615). It represents, once again, an example of an ongoing, unacceptable smear campaign by Azerbaijan against my country.

By spreading totally groundless information and scenarios authorized by its Ministries of Foreign Affairs and Defence, the Azerbaijani representative to the United Nations hinders the proceedings of the annual session of the General Assembly and the Security Council.

It is truly disappointing that, given the important agenda of the sixty-fifth session of the General Assembly, which should be the main focus, the Azerbaijani side instead continues to abuse its privilege of being a Member State of the United Nations by using every opportunity presented to it as such to falsely and unabashedly discredit Armenia and Nagorno Karabakh.

Although responding to the above-mentioned letter, the conclusions and falsity of which are simply preposterous, may give it credence, I find it necessary to note that this circulated propaganda paper amounts to a highly irresponsible attempt at the State level to undermine the ongoing mediation efforts of the Organization for Security and Cooperation in Europe (OSCE) Minsk Group Co-Chairs to find a comprehensive and lasting solution for the Nagorno Karabakh issue.



In contradiction of the spirit of the Minsk Group negotiation process, as well as contrary to basic international documents such as the Charter of the United Nations and the Helsinki Final Act, the Azerbaijani Government, the President himself and his representatives for a long time have been developing and implementing a large-scale propaganda campaign against Armenia and Armenians. Such behaviour of the Azerbaijani authorities creates a serious threat to regional peace and stability.

Armenia, along with the OSCE Minsk Group Co-Chairs, continues to be alarmed by the growing wave of the Azerbaijani incursions across the Nagorno Karabakh-Azerbaijan line of contact and its ceasefire violations throughout 2010, resulting in tragic and unnecessary loss of life of both Armenian and Azerbaijani soldiers. Numerous deliberate provocations on the line of contact this year serve as concrete examples of Azerbaijan's insistence on seeking militaristic ways to deal with the Nagorno Karabakh issue.

Furthermore, Azerbaijan continues to reject calls from the Minsk Group Co-Chairs and the United Nations Secretary-General (the most recent made on the sidelines of the OSCE Summit in Astana on 1 December 2010) for the removal of snipers from the line of contact.

In this context, upon instructions from my Government, I draw your attention to the ongoing violations of the ceasefire by the armed forces of Azerbaijan, as recorded for the months of November and December 2010 (see annex). Such actions by Azerbaijan put in question its commitment to its obligations under international humanitarian and human rights law and finding a peaceful solution to the Nagorno Karabakh issue.

I should be grateful if you would have the present letter and its annex circulated as a document of the General Assembly, under agenda items 34, 39, 66 and 75, and of the Security Council.
