Land violations committed in June 2022

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
1 June	—	Landmines left behind by the Israeli enemy were detonated as follows: 23 in Yarun, 7 in Marwahin, 23 in Amra, 18 in Markaba, 65 in Arab al-Luwayzah, 4 in Mays al-Jabal, 13 in Naqurah and 2 in Alma al-Sha'b.
	0820–0930	The sound of explosions, the cause of which is unknown, emanated from inside the occupied Shab'a Farms.
	0849	In occupied Palestinian territory, opposite the town of Bustan, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory until 1145 hours.
	0906	In occupied Palestinian territory, opposite the town of Bustan, Israeli enemy soldiers pointed the cannons of three Merkava tanks towards Lebanese territory until 2015 hours.
	0955	As the civilian Ali Abdul'al was grazing a herd of livestock in the area of Majidiyah, outside the town of Kafr Shuba, an Israeli enemy Humvee vehicle approached from the occupied Shab'a Farms. Two soldiers disembarked and fired two bullets into the air over the herd, in order to intimidate the shepherd. No one was harmed. At 1000 hours, the shepherd and his herd left the area, heading towards the town of Halta, and the enemy vehicle headed towards the occupied Shab'a Farms.
	1030	In occupied Palestinian territory, opposite the town of Kafr Kila, at the Israeli enemy Jabal al-Tayyarah position, a group consisting of 70 individuals in civilian clothing approached. They scouted the area and photographed the Lebanese side. The group left at 1120 hours in the direction of occupied territory.
	1100	In occupied Palestinian territory, opposite the town of Kafr Kila, near point B82, an Israeli enemy group consisting of 35 individuals in civilian clothing approached. They scouted the area and photographed the Lebanese side. The group left at 1143 hours in the direction of occupied territory.
	1530	In occupied Palestinian territory, opposite the town of Udaysah, near point TP36(2), the cannon of an Israeli enemy Merkava tank was pointed towards Lebanese territory until 1715 hours.
	1830	Several Lebanese youths were present in Lebanese territory when an Israeli enemy patrol approached from occupied Palestinian territory, opposite the town of Blida. Patrol members fired one round into the air towards Lebanese territory.
2 June	—	Landmines left behind by the Israeli enemy were detonated as follows: 26 in Yarun, 15 in Marwahin, 1 in Duhayrah, 22 in Amra, 2 in Markaba, 44 in Arab al-Luwayzah and 15 Naqurah.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
	0100	Opposite the town of Udaysah, near point TP35, an enemy Israeli patrol consisting of two Merkava tanks and a D9 bulldozer approached from occupied Palestinian territory. Patrol members opened the gate in the technical fence and entered occupied Lebanese territory. At 0230 hours, the patrol left in the direction of occupied territory, opposite point TP36.
	1000–1030	The sound of explosions, the cause of which is unknown, emanated from inside the occupied Shab'a Farms.
	1100	An Israeli enemy Defender vehicle approached from the enemy's position opposite Sahl al-Khiyam. A soldier pointed the machine gun mounted on the vehicle towards Lebanese territory until 1130 hours.
	1430	As the civilian Mahir Hamdan was tending a herd of livestock on the outskirts of Shab'a town, Qahwanah district, a 10-person Israeli enemy patrol detained him and took him to occupied territory.
	1702	In occupied Palestinian territory, opposite the town of Udaysah, the cannon of an Israeli enemy Merkava tank was pointed towards Lebanese territory until 1706 hours.
3 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 28 in Yarun, 22 in Marwahin, 2 in Duhayrah, 10 in Amra, 10 in Markaba, 40 in Arab al-Luwayzah, 18 in Naqurah and 2 in Alma al-Sha'b.
	0630	In occupied Palestinian territory, opposite the town of Aytarun, Israeli enemy soldiers fired three rounds from military weapons into the air towards Lebanese territory.
	1030	An Israeli enemy foot patrol of consisting of 19 individuals in military clothing approached from occupied Palestinian territory. The patrol members opened the steel gate and crossed the technical fence. They then searched the area, installed camouflage netting and deployed themselves behind some earthen berms, taking up combat positions and pointing their weapons towards Lebanese Army soldiers. At 1340 hours, the camouflage netting was removed and the patrol left in the direction of occupied territory.
	2325	Opposite the town of Markaba, Israeli enemy soldiers fired two flare shells, one of which fell in the occupied territories and the other in Lebanese territory, near the landfill on the outskirts of the town of Udaysah. The shell caused a fire to break out at the site, but no one was harmed. Civil defence personnel extinguished the fire.
4 June	0700	An Israeli enemy foot patrol of consisting of 17 individuals in military clothing approached from occupied Palestinian territory, opposite the town of Mays al-Jabal, at point B64. The patrol members crossed the technical fence and searched the area between the fence and the Blue Line, without violating the former. At 0930 hours, an enemy soldier fired a round into the air towards Lebanese territory in order to intimidate several civilians who were on the Lebanese side. No one was harmed. At 1005 hours, the enemy patrol left in the direction of occupied territory and the civilians in Lebanese territory departed.

	0827	In occupied Palestinian territory, opposite point BP31, Israeli enemy soldiers pointed their weapons and the cannon of a Merkava tank towards Lebanese territory until 1108 hours.
	1000	In occupied Palestinian territory, opposite the town of Kafr Kila, at the Israeli enemy Jabal al-Tayyarah position, a Defender vehicle approached. A soldier pointed the machine gun mounted on the vehicle towards Lebanese territory until 1140 hours.
	1500	As members of the Lebanese civil defence were putting out a fire on the outskirts of the town of Hula, opposite point B71, an Israeli enemy patrol consisting of two military four-wheel-drive vehicles and a Humvee vehicle approached from occupied Palestinian territory. Four individuals in military clothing disembarked and fired four rounds from their weapons into the air towards Lebanese territory and over the civil defence personnel. No one was harmed. At 1650 hours, the fire was extinguished and the enemy patrol left in the direction of occupied territory.
	2000	On the outskirts of the town of Mays al-Jabal, near point B71(1), Israeli enemy soldiers fired six rounds into the air in order to intimidate several farmers who were near the Blue Line. No one was harmed.
	2200	In occupied Palestinian territory, opposite the town of Udaysah, the cannon of an Israeli enemy Merkava tank was pointed towards Lebanese territory until 2230 hours.
5 June	0800	An Israeli enemy foot patrol of consisting of 16 individuals in military clothing approached from occupied Palestinian territory, opposite the town of Mays al-Jabal, at point B64. The patrol members crossed the technical fence and searched the area between the fence and the Blue Line, without violating the former. At 0930 hours, an enemy soldier fired a round into the air towards Lebanese territory in order to intimidate several civilians who were on the Lebanese side. No one was harmed. At 1005 hours, the enemy patrol left in the direction of occupied territory and the civilians in Lebanese territory departed.
	1000–1100	The sound of an explosion was heard emanating from occupied Shab'a Farms, between the Sammaqah and Ramta positions.
6 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 37 in Yarun, 11 in Marwahin, 18 in Amra, 30 in Arab al-Luwayzah, 13 in Naqurah and 2 in Alma al-Sha'b.
7 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 35 in Yarun, 14 in Marwahin, 31 in Amra, 5 in Markaba, 5 in Mays al-Jabal, 14 in Naqurah and 42 in Arab al-Luwayzah.
	0808	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of six soldiers approached. They conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, took up positions inside the emplacement situated at the site and pointed the cannon of a Merkava tanks towards Lebanese territory.

	1730	In occupied Lebanese territory, opposite the town of Wazzani, Israeli enemy soldiers pointed their weapons towards Lebanese territory.
8 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 30 in Yarun, 21 in Marwahin, 3 in Mays al-Jabal and 14 in Naqurah.
	0800	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of 13 individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon seven patrol members took up positions inside the emplacement situated at the site, while the other 8 took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	0835	In the occupied Shab'a Farms, in the vicinity of the Israeli enemy's Ruwaysat al-Alam position, the cannon of a Merkava was pointed towards Lebanese territory. In addition, military vehicles were observed moving about and some 15 soldiers deployed in the area. They proceeded to fire rounds from light military weapons in order to intimidate shepherds who were on the Lebanese side.
	0945	In the occupied Shab'a Farms, a patrol consisting of a GMC four-wheel-drive vehicle and a Defender vehicle stopped at an area south of the Israeli enemy's Sammaqah position. Patrol members fired several rounds into the air.
	1630–1700	The sound of explosions, the cause of which is unknown, emanated from inside the occupied Shab'a Farms.
	1820	From inside occupied Palestinian territory, opposite points B29(1) and B29, Israeli enemy soldiers pointed their weapons towards civilians who were in Lebanese territory.
9 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 33 in Yarun, 52 in Marwahin, 42 in Amra, 24 in Markaba, 37 in Arab al-Luwayzah, 18 in Mays al-Jabal, 6 in Hula, 16 in Naqurah and 3 in Alma al-Sha'b.
	0700	Opposite the town of Mays al-Jabal and points BP31 and B64, an enemy Israeli patrol consisting of 15 individuals in military clothing and a Merkava tank approached from occupied Palestinian territory. Several of the patrol members opened the metal gate in the technical fence located opposite point B64 and passed through it. They then deployed behind some earthen berms, taking up combat positions and pointing their weapons towards some Lebanese Army soldiers. The patrol left in the direction of occupied territory at 0830 hours.
	0800	In occupied Lebanese territory, opposite the town of Udaysah, near point TP36(2), Israeli enemy soldiers pointed their weapons towards Lebanese territory.
	0830	In occupied Lebanese territory, opposite the town of Udaysah, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
10 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 49 in Yarun, 16 in Marwahin, 31 in Arab al-Luwayzah, 14 in Amra, 4 in Markaba, 18 in Hula, 5 in Mays al-Jabal and 20 in Naqurah.
11 June	–	Some 92 landmines left behind by the Israeli enemy in Marwahin were detonated.
12 June	0830	In occupied Palestinian territory, opposite the town of Ramiya and points BP9 and BP10, Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.
	1345	In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy group consisting of five individuals in military clothing approached. They scouted the area and photographed the Lebanese side. Meanwhile, the cannon of a Merkava was pointed towards Lebanese territory. The individuals left in the direction of occupied territory at 1510 hours.
13 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 21 in Yarun, 7 in Duhayrah, 13 in Amra, 15 in Markaba, 65 in Arab al-Luwayzah, 2 in Hula, 6 in Mays al-Jabal and 16 in Naqurah.
	0950	In occupied Palestinian territory, opposite the town of Hula, at the Israeli enemy Shaykh Abbad position, a group consisting of 25 individuals in military clothing approached. They scouted the area and photographed the Lebanese side. The group left at 1030 hours in the direction of occupied territory.
	1400	A shepherd named Isma'il Zahrah was grazing a herd of livestock in Sha'b al-Suwayd, on the outskirts of the town of Shab'a. As he approached the line of withdrawal, he saw nine Israeli enemy soldiers who had taken up combat positions behind the rocks. He fled towards the town of Shab'a, but he fell to the ground and sustained some wounds. The herd returned towards the town and the patrol left towards the occupied Shab'a Farms.
14 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 42 in Yarun, 5 in Marwahin, 26 in Amra, 20 in Markaba, 44 in Arab al-Luwayzah, 3 in Hula, 19 in Mays al-Jabal and 15 in Naqurah.
	0630	In occupied Palestinian territory, opposite the town of Markaba, an Israeli enemy group consisting of five individuals in military clothing approached. They scouted the area and photographed the Lebanese side. Meanwhile, the cannon of a Merkava was pointed towards Lebanese territory. The group left at 0740 hours in the direction of occupied territory.
	1030	In occupied Palestinian territory, opposite the town of Kafr Kila, at the Israeli enemy Jabal al-Tayyarah position, a group consisting of 40 individuals in civilian clothing approached. They scouted the area and photographed the Lebanese side. The group left at 1115 hours in the direction of occupied territory.
	1030–1130	The sound of explosions, the cause of which is unknown, emanated from inside the occupied Shab'a Farms.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
	1800	As Ali Sarhan was on his land in the locality of Sahl al-Khiyam, in Lebanese territory, opposite point AP505, a Humvee vehicle approached from the other side. Two individuals in military clothing disembarked and cursed at him in Arabic, with a view to driving him away from the location. The soldiers left in the direction of occupied territory at 1810 hours.
15 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 43 in Yarun, 93 in Marwahin, 4 in Duhayrah, 25 in Amra, 17 in Markaba, 38 in Arab al-Luwayzah, 2 in Hula, 14 in Mays al-Jabal and 16 in Naqurah.
	0720	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an Israeli enemy patrol consisting of seven individuals in military clothing approached and conducted a patrol along the dirt road from the aforementioned point to point TP37. Then, several of the patrol members opened a metal gate in the technical fence, whereupon two patrol members took up positions inside the emplacement situated at the site, while the other five took up positions along the dirt road and pointed their weapons towards Lebanese territory.
	0800	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), Israeli enemy soldiers pointed the cannon of a Merkava tank towards Lebanese territory.
	1005	As a group of farmers were in Sahl al-Khiyam, near point B90, an Israeli enemy Humvee vehicle approached from the other side came. Three individuals in military clothing disembarked and fired six rounds from their weapons into the air toward Lebanese territory. The patrol left in the direction of occupied territory at 1020 hours.
	1750	In occupied Palestinian territory, opposite pillar No. 40, the cannon of a Merkava tank was pointed towards Lebanese territory as enemy soldiers carried out a foot patrol.
16 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 35 in Yarun, 1 in Marwahin, 28 in Duhayrah, 28 in Amra, 22 in Markaba, 25 in Arab al-Luwayzah, 18 in Mays al-Jabal and 17 in Naqurah.
17 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 36 in Yarun, 37 in Marwahin, 15 in Duhayrah, 8 in Amra, 21 in Markaba, 65 in Arab al-Luwayzah, 9 in Mays al-Jabal and 15 in Naqurah.
19 June	1500	An Israeli enemy patrol comprising three military vehicles and two civilian vehicles approached from occupied Palestinian territory, opposite the town of Wazzani, at the Maysat point. Some 15 patrol members in military clothing disembarked, opened the metal gate in the technical fence and proceeded about 20 m beyond it. They patrol the area near gate and photographed the Lebanese side. The patrol left at 1520 hours in the direction of occupied territory.

	1520	In occupied Palestinian territory, opposite Sahl al-Khiyam, near point B90, an Israeli enemy group consisting of 25 individuals in military clothing approached. They scouted the area and photographed the Lebanese side. The group left at 1550 hours in the direction of occupied territory.
20 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 48 in Yarun, 15 in Marwahin, 10 in Duhayrah, 39 in Amra, 37 in Markaba, 10 in Mays al-Jabal and 14 in Naqurah.
	1415	In occupied Palestinian territory, opposite Sahl al-Khiyam, near point B90, an Israeli enemy group consisting of 10 individuals in military clothing approached. They scouted the area and photographed the Lebanese side. The group left at 1435 hours in the direction of occupied territory.
21 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 39 in Yarun, 20 in Marwahin, 21 in Duhayrah, 1 in Amra, 24 in Markaba, 11 in Arab al-Luwayzah and 21 in Mays al-Jabal.
	2040–2110	The sound of explosions, the cause of which is unknown, emanated from inside the occupied Shab'a Farms.
22 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 56 in Yarun, 24 in Duhayrah, 20 in Markaba, 2 in Arab al-Luwayzah and 7 in Mays al-Jabal.
	0730	On the outskirts of the town of Shab'a, Birkat al-Naqqar district, an Israeli enemy patrol consisting of two four-wheel-drive vehicles, a pickup truck carrying robotic construction vehicles, a troop carrier, an M113 armoured personnel carrier and a Humvee vehicle approached from occupied Lebanese territory. Some 25 individuals in military clothing disembarked and opened the gate. They then guided a silver-coloured robotic construction vehicle towards Lebanese territory, to a point where there was a flag belonging to a Lebanese party hanging on a barbed wire fence. At 1245 hours, the flag was taken down and taken by the robotic construction vehicle to occupied territory. Meanwhile, patrol members pointed their weapons towards Lebanese Army troops and a Merkava tank stopped at Tallat al-Saddanah and its cannon was pointed towards Lebanese territory. The patrol and the tank left in the direction of occupied territory at 1420 hours.
	1915	In the town of Khiyam, near point B90, as several farmers were in their fields in Lebanese territory, a patrol consisting of a Humvee vehicle and a civilian four-wheel-drive vehicle approached from the other side. Four individuals in military clothing disembarked and hurled insults and made vulgar gestures at the farmers. The patrol left in the direction of occupied territory at 2020 hours.
	2100–2215	In occupied Palestinian territory, opposite the town of Ayta al-Sha'b, at the Israeli enemy's Tall al-Rahib position, Israeli enemy personnel directed a searchlight towards Lebanese territory.

23 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 45 in Yarun, 30 in Marwahin, 34 in Arab al-Luwayzah, 35 in Mays al-Jabal and 18 in Naqurah.
	2330	In occupied Lebanese territory, opposite the town of Udaysah and point TP36(2), an enemy Israeli patrol consisting of 12 individuals in military clothing approached. Patrol members opened a steel gate in the concrete wall and passed through it, and then conducted a foot patrol as far as TP35 in occupied Lebanese territory. A Merkava tank then arrived near point TP35 and crossed the technical fence, whereupon its cannon was pointed towards Lebanese territory.
24 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 68 in Yarun, 13 in Marwahin, 18 in Duhayrah, 1 in Amra, 36 in Markaba, 17 in Arab al-Luwayzah, 2 in Mays al-Jabal and 13 in Naqurah.
	0730	In occupied Palestinian territory, opposite the town of Mays al-Jabal, an Israeli enemy patrol consisting of some 26 soldiers crossed the technical fence and took up positions behind some earthen berms. Meanwhile, the cannon of a Merkava tank was pointed towards Lebanese territory and Lebanese Army soldiers.
25 June	1030	An enemy vehicle approached as the civilian Ibrahim Abdul'al was grazing a herd of goats on the outskirts of the town of Majidiyah–Hasbaya, opposite the Israeli enemy's Ayn al-Tinah position. A soldier disembarked from the vehicle and fired a round into the air towards the herd, in order to intimidate the shepherd. No one was harmed. The vehicle then left in the direction of occupied territory.
	1530	An enemy vehicle approached as the civilian Rabi' Qasim was grazing a herd of goats in the Sahl al-Khiyam–Marja'yun district, near point B90. Six individuals in military clothing disembarked and hurled insults and directed vulgar gestures at the shepherd, in order to drive him away from the location. The personnel and the vehicle left in the direction of occupied territory at 1610 hours.
27 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 3 in Arab al-Luwayzah, 41 in Mays al-Jabal and 15 in Naqurah.
	1100	Opposite the town of Mays al-Jabal, an Israeli enemy soldier pointed his weapon at two Lebanese civilians who were situated opposite point B63.
	2045	Opposite the town of Ayta al-Sha'b, the Israeli enemy fired three flare shells over the Shetula position, one of which violated the Blue Line and fell in Lebanese territory.
	2100–2135	In occupied Palestinian territory, opposite the town of Markaba, Israeli enemy soldiers directed searchlights towards Lebanese territory.
28 June	–	Landmines left behind by the Israeli enemy were detonated as follows: 52 in Yarun, 38 in Marwahin, 16 in Duhayrah, 1 in Amra, 21 in Markaba, 2 in Arab al-Luwayzah, 34 in Mays al-Jabal, 1 in Hula and 15 in Naqurah.

<i>Date</i>	<i>Time</i>	<i>Nature of violation</i>
	0750	In occupied Palestinian territory, opposite the town of Hula, at the Israeli enemy's Shaykh Abbad position, a patrol consisting of 12 individuals in military clothing approached. Patrol members opened a gate in the technical fence and passed through it, after which they conducted a foot patrol near point BP33. In addition, the enemy positioned two Merkava tanks, the first in the vicinity of the aforementioned position and the second opposite the town of Markaba, and pointed their cannons towards Lebanese territory.
	0900	In the occupied Shab'a Farms, Jabal al-Shahl district, opposite observation point 2 (OP2) of the Indian contingent of the United Nations Interim Force in Lebanon (UNIFIL), a 25-person Israeli enemy foot patrol, accompanied by two Merkava tanks, approached and took up combat positions in the hills opposite the location. In addition, the sound of gunfire was heard.
	1000	In occupied Lebanese territory, opposite the town of Udaysah, near point TP36(2), an Israeli enemy group consisting of 70 individuals in military clothing approached. They scouted the area and photographed the Lebanese side. The group left at 1100 hours in the direction of occupied territory.
	1215	In occupied Lebanese territory, opposite Ra's Naqurah, two individuals in civilian clothing installed two cameras on the steel tower located opposite point M1.
