Background paper prepared by the Secretariat

1. The recommendations adopted by the Working Group on Trafficking in Persons at each of its meetings to date are set out in the reports of the Working Group on those meetings and currently number more than 1,250.
2. At its fifth meeting, in 2013, the Working Group requested the Secretariat to prepare and maintain a consolidated record of all of the recommendations adopted by the Working Group ([CTOC/COP/WG.4/2013/5](#), para. 45). At the same meeting, the Working Group proposed that States parties continue to do their best to implement the pertinent recommendations of the Working Group as adopted by the Conference of the Parties (*ibid.*, para. 46). The recommendations were previously consolidated by the Secretariat for consideration by the Working Group at its sixth meeting (see [CTOC/COP/WG.4/2015/5](#) and [CTOC/COP/WG.4/2015/5/Add.1](#)).
3. For consideration by the Working Group at its ninth meeting, the Secretariat has prepared an index of all recommendations adopted to date, organized by topic (see table).
4. In some cases, recommendations fall under more than one subject area, with the purpose of assisting States parties in identifying the pertinent recommendations on any topic previously discussed by the Working Group.
5. In addition, the Secretariat has prepared a background paper in the six official languages of the United Nations setting out all of the recommendations adopted to date by the Working Group ([CTOC/COP/WG.4/2019/5](#)).
