The Vice-President of the Council, His Excellency Daffa-Alla Elhag Ali Osman (Sudan), opened the segment and made a statement.

Regional cooperation [item 10]

The Council began its consideration of the agenda item.

The Executive Secretary of the Economic and Social Commission for Asia and the Pacific (ESCAP) and current Coordinator of the Regional Commissions introduced the report of the Secretary-General, contained in documents E/2013/15, E/2013/15/Add.1 and E/2013/15/Add.2.

Dialogue with the Executive Secretaries of the regional commissions on the theme "Regional perspectives on the post-2015 development agenda"

The dialogue was chaired by the Vice-President of the Council (Sudan) and moderated by Ms. Noeleen Heyzer, Executive Secretary of the Economic and Social Commission for Asia and the Pacific, and current Coordinator of the Regional Commissions.

Following the introductory statement by the moderator, presentations were made by Ms. Rima Khalaf, Executive Secretary of the Economic and Social Commission for Western Asia; Mr. Carlos Lopes, Executive Secretary of the Economic Commission for Africa; Ms. Noeleen Heyzer, Executive Secretary of the Economic and Social Commission for Asia and the Pacific; Mr. Antonio Prado, Deputy Executive Secretary of the Economic Commission for Latin America and the Caribbean; and Mr. Andrey Vasilyev, Deputy Executive Secretary of the Economic Commission for Europe. An interactive discussion ensued, during which the Executive Secretaries of the regional commissions responded to comments made and questions posed by the representatives of the Russian Federation, Ethiopia, the Sudan, Belarus, Gabon and South Africa, as well as by the observer for Jordan.
