RESOLUTIONS ADOPTED BY THE COUNCIL DURING ITS RESUMED THIRTY-FOURTH SESSION

926 (XXXIV). Annual report of the Economic Commission for Africa

The Economic and Social Council

1. *Takes note* of the annual report of the Economic Commission for Africa¹ for the period 19 February 1961 to 3 March 1962 and of the recommendations and resolutions contained in parts II and III of that report;

2. *Endorses* the programme of work and priorities contained in the report.

927 (XXXIV). Terms of reference of the Economic Commission for Africa

The Economic and Social Council,

Recalling its resolution 671 A (XXV), of 29 April 1958, establishing the Economic Commission for Africa,

Having examined resolution 42 (IV), of 24 February 1962, of the Economic Commission for Africa² and, in particular, draft resolution III proposed by the Commission for adoption by the Council,³

Taking note of the memorandum⁴ submitted to the Economic and Social Council by the Permanent Rep-

resentative of Spain to the United Nations and the statements in which the Spanish Government indicated that it was prepared to comply with the provisions of General Assembly resolution 1466 (XIV) of 12 December 1959 and of resolution 24 (III) of 16 February 1961 of the Economic Commission for Africa,⁵

Taking note also of the statements⁶ made by the representatives of France and of the United Kingdom of Great Britain and Northern Ireland to the effect that the delegations of those States to the Economic Commission for Africa would in general refrain from voting against proposals relating mainly to the region and supported by the majority of the countries of the region,

Desiring to ascertain the views of the Commission on the new situation created by that memorandum and those statements,

Decides to send to the Economic Commission for Africa, for further study, the above-mentioned draft resolution in so far as it concerns the status of Spain, France and the United Kingdom in the Commission, taking into account the memorandum from the Permanent Representative of Spain to the United Nations, the statements made by the representatives of France and the United Kingdom and the discussions on this question at the thirty-fourth session of the Council.⁷

OTHER DECISIONS TAKEN BY THE COUNCIL DURING ITS RESUMED THIRTY-FOURTH SESSION

Basic programme of the Council for 1963

At its 1237th and 1238th meetings, held on 18 and 19 December 1962 respectively, the Council approved its basic programme for 1963 and considered the provisional agenda for its thirty-fifth session. The Council decided to request the Secretariat to establish, after consultation with members of the Council and with the specialized agencies concerned, the dates of the opening of the debates on the items allocated to the thirty-fifth session.

Place of meeting of the 1963 summer session of the Technical Assistance Committee

At its 1237th meeting, on 18 December 1962, the Council decided to accept the invitation of the Government of Denmark that the Technical Assistance Committee hold its 1963 summer session in Copenhagen.

Transmittal of section IV of the report of the Administrative Committee on Co-ordination

At its 1237th meeting, on 18 December 1962, the Council decided that section IV of the report of the Administrative Committee on Co-ordination (E/3695), dealing with the implementation of recommendations of the *ad hoc* Committee established under Council resolution 851 (XXXII), should be transmitted to the *ad hoc* Committee of Ten for further consideration.

Cancellation of the meeting of the United Nations Consultative Group on the Prevention of Crime and the Treatment of Offenders

At its 1237th meeting, on 18 December 1962, the Council decided to cancel the meeting of the United Nations Consultative Group on the Prevention of Crime and the Treatment of Offenders scheduled to be held in Geneva from 2 to 13 December 1963.

Conference on International Travel and Tourism

At its 1237th meeting, on 18 December 1962, the Council confirmed its decision to convene the Conference on International Travel and Tourism in August-September 1963, as scheduled.

Review of the composition of the United Nations/FAO Inter-Governmental Committee on the World Food Programme

At its 1237th meeting, on 18 December 1962, the Council decided to defer to its thirty-fifth session the agenda item concerning the review of the composition of the United Nations/FAO Inter-Governmental Committee on the World Food Programme.

Enlargement of the membership of the Committee on Housing, Building and Planning

At its 1238th meeting, on 19 December 1962, the Council decided to increase the membership of the Committee on Housing, Building and Planning from eighteen to twenty-one members.

Enlargement of the membership of the Preparatory Committee of the United Nations Conference on Trade and Development

At its 1238th meeting, on 19 December 1962, the Council decided to increase the membership of the Preparatory Committee of the United Nations Conference on Trade and Development from eighteen to thirty members and to elect the additional twelve members at the current session.

Election of six members of the Technical Assistance Committee

At its 1240th meeting, on 20 December 1962, the Council elected the following States members of the Technical Assistance Committee to serve for a term of office of two years: BRAZIL, DENMARK, FEDERAL REPUBLIC OF GERMANY, NIGERIA, POLAND and the UNITED ARAB REPUBLIC.

Election of four members of the Committee for Industrial Development

At its 1240th meeting, on 20 December 1962, the Council elected the following States members of the Committee for Industrial Development to serve for a term of office of three years: ALGERIA, BRAZIL, CENTRAL AFRICAN REPUBLIC and SWEDEN.

Election of members of the Council Committee on Non-Governmental Organizations

At its 1240th meeting, on 20 December 1962, the Council elected the following States members of the Council Committee on Non-Governmental Organizations to serve for the calendar year 1963: AUSTRIA, FRANCE, JAPAN, SENEGAL, UNION OF SOVIET SOCIALIST REPUBLICS, UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND and the UNITED STATES OF AMERICA.

Election of members of the Special Committee on Co-ordination

At its 1240th meeting, on 20 December 1962, the Council elected the following States members of the Special Committee on Co-ordination to serve for a term of office of one year: COLOMBIA, DENMARK, ETHIOPIA.

FRANCE, JAPAN, JORDAN, NETHERLANDS, UNION OF SOVIET SOCIALIST REPUBLICS, UNITED KINGDOM OF GREAT BRITAIN AND NORTHERN IRELAND, UNITED STATES OF AMERICA and YUGOSLAVIA.

Election of members of the Committee on Housing, Building and Planning

At its 1241st meeting, on 20 December 1962, the Council elected the following States members of the Committee on Housing, Building and Planning and decided by drawing of lots that the term of office of COLOMBIA, IRAN, ISRAEL, JAPAN, MADAGASCAR, NIGERIA and the UNITED STATES OF AMERICA would be for three years; that of ARGENTINA, FRANCE, GREECE, ITALY, ROMANIA, TANGANYIKA and the UNITED ARAB REPUBLIC, for two years; and that of CANADA, CHILE, COSTA RICA, DENMARK, HUNGARY, INDONESIA and the UNION OF SOVIET SOCIALIST REPUBLICS, for one year.

Election of twelve additional members of the Preparatory Committee of the United Nations Conference on Trade and Development

At its 1241st meeting, on 20 December 1962, the Council elected the following States members of the Preparatory Committee of the United Nations Conference on Trade and Development: ARGENTINA, AUSTRIA, CANADA, CZECHOSLOVAKIA, LEBANON, MADAGASCAR, NEW ZELAND, NIGERIA, PAKISTAN, PERU, TUNISIA and the UNITED ARAB REPUBLIC.

Appointment of two additional members of the *ad hoc* Committee established under Council resolution 851 (XXXII)

At its 1241st meeting, on 20 December 1962, the President of the Council, in accordance with Council resolution 900 A (XXXIV), designated Indonesia and Jordan as the two additional members of the *ad hoc* Committee.
