Addendum

Introduction

1. This addendum supplements and updates the information available at the current session of the Commission on Human Rights, which is to be found in the annual report of the Secretary-General to the General Assembly (A/48/520) and the annual report of the Secretary-General to the Commission on Human Rights (E/CN.4/1994/29). A list of all contributions and pledges made from the establishment of the Fund up to 10 February 1994 is contained in the annex; the Fund secretariat will duly correct any errors Governments may find and draw to its attention.

New contributions received

2. The following contributions for 1993/94 have been registered since the publication of document E/CN.4/1994/29 on 5 October 1993:

3. The above table calls for the following comments:

(a) Cyprus, Germany, Iceland, Japan, Liechtenstein, Luxembourg and Switzerland contribute to the Fund regularly, thus responding to the appeal made by the Commission on Human Rights in resolution 1993/38, paragraph 3, which appealed to all Governments to respond favourably to requests for contributions to the Fund, on a regular basis if possible, in order, inter alia, to prevent the interruption of programmes in the continuation of which the Fund played an instrumental role; the General Assembly, in resolution 47/109, had made a similar appeal, adding that to make contributions to the Fund on a regular basis would enable it to provide continuous support to projects that depended on recurrent grants. The other regular donor States which made a contribution or pledge between the twelfth session of the Board of Trustees, in April 1993, and 5 October 1993 are: Brazil (there is a mistake in document A/48/520, para. 19: the sum of \$43,824 was intended for the payment of Brazil's contribution to the work of the Committee Against Torture; Brazil's latest contribution to the Fund is \$5,000, which was paid on 26 April 1993), Denmark (see A/48/520, para. 19), Finland (idem), France (idem), Greece (idem), Ireland (idem and E/CN.4/1994/29, para. 13), Italy (A/48/520), the Netherlands (see para. 5 below, concerning pledges, and E/CN.4/1994/29), New Zealand (A/48/520),

Sweden (see para. 5 below and E/CN.4/1994/29), Tunisia (see para. 5 below, E/CN.4/1994/29 and A/48/520), the United Kingdom of Great Britain and Northern Ireland (biennial contribution, the last one having been made in 1991, for the years 1991 and 1992) and the United States of America (A/48/520);

(b) Australia has doubled its contribution;

(c) Bhutan, the Czech Republic, Hungary and Mauritius are new donor States.

6. For 1991 and 1992, the United States of America pledged an annual contribution of \$100,000. On 7 February 1992, the Centre for Human Rights received a cheque in the amount of \$98,000 for 1991 and \$90,000 for 1992. There is thus an outstanding pledge of \$12,000 for those two years which has not been paid.

New individual contribution

7. An individual contribution of Sw.F 50 has been received from Mrs. Zuppirou (Switzerland).

Use of contributions

8. It will be recalled that information on the use of contributions received up to the twelfth session of the Fund's Board of Trustees (19-28 April 1993) is contained in the report of the Commission on Human Rights (E/CN.4/1994/29, paras. 15-16) and in the latest report to the General Assembly (A/48/520, in particular annexes IV and VI, for the action taken following the Secretary-General's decision to approve the Board's recommendations at its twelfth session, and annex I, for the Fund's first 10 years of activity, 1982-1992).

Funds needed up to 17 May 1994

9. At its twelfth session the Fund's Board of Trustees was able to allocate a little over US\$ 2 million of voluntary contributions received in 1992/93, while requests amounted to \$4 million.

10. The total contributions received since the twelfth session and available for allocation at the thirteenth session, to be held from 17 to 27 May 1994, amount to \$839,735, as against requests already totalling \$4,240,386.
