Note by the secretariat

I. MANDATE

1. This document, mandated by THE PEP Steering Committee, reports on the use of financial and in-kind resources made available by donor countries and the UNECE and WHO/Europe secretariats (hereafter referred to collectively as "the secretariat") for implementation of the work programme and workplan of THE PEP until the end of 2007.

2. For 2008, it is estimated that, as a minimum, additional resources in the order of US\$ 30,000 are required to facilitate the participation of countries of Eastern Europe, Caucasus and Central Asia (EECCA) at the forthcoming Third High-level Meeting in November 2008 and in its preparatory process.

3. This report complements the information submitted by the secretariat at previous sessions of the Steering Committee covering the years 2004–2006 (ECE/AC.21/2004/7 - EUR/04/5045236/7; ECE/AC.21/2005/12 - EUR/05/5046203/12; ECE/AC.21/2006/8 - EUR/06/THEPEPST/8; ECE/AC.21/SC/2007/9 - EUR/07/5068055/9).

II. EXTRABUDGETARY RESOURCES PLEDGED, RECEIVED AND USED IN 2007

- 4. The following <u>in-kind</u> contributions were pledged and received in 2007:

III. RESOURCES USED FOR ADMINISTRATION OF THE PEP

7. In addition to the above resources received from donors and provided by the UNECE and WHO/Europe secretariats, both secretariats have, in accordance with their mandates, used substantial budget allocations to administer THE PEP and to service the activities of its Steering Committee and Bureau.

8. In 2007 and in line with its programme of work, the UNECE secretariat made available two regular professional staff for the activities of THE PEP as well as general service support and mission costs, which were provided by the UNECE Transport Division and Environment, Housing and Land Management Division. In addition, UNECE provided, through the United Nations Office in Geneva (UNOG), for the translation and reproduction of all official documents and for the required interpretation services for the 2007 session of the Steering Committee. UNECE also provides the required conference room facilities whenever sessions of the Steering Committee are held in the Palais des Nations in Geneva.

9. In line with its programme of work, in 2007 the WHO/Europe secretariat made available 1.2 staff (consisting of approximately 30% senior professional staff; 50% medium-level professional staff; 15% Web and communication staff; and 25% administrative staff). WHO also provided the required conference room facilities at WHO premises in Geneva (for Steering Committee sessions held at WHO) and in Rome (for THE PEP Bureau meetings), and covered the costs of travel by secretariat personnel when hosting organizations or donors did not cover these.

IV. EXTRABUDGETARY FUNDING REQUIREMENTS FOR 2008

10. At the third session of the Steering Committee, the key priorities of THE PEP were confirmed as still valid. In adopting its work programme for 2005–2007, the Steering Committee agreed that the focus should remain on the activities currently being implemented. It recommended caution in launching new activities unless the availability of appropriate resources for their implementation was assured.

11. A complete list of projects to be completed before the Third High-level Meeting is contained in the annex to this report. Based on the approved document on resources of 2007 (ECE/AC.21/SC/2007/9-EUR/07/5068055/9), the secretariat has elaborated details of these projects and transmitted them on 31 July 2007 through official channels to UNECE and WHO/Europe member countries. The currently pledged and available resources as contained in the tables above should allow the secretariat to complete at least four of the seven projects. Additional resources are still required to complete project No. 3 "THE PEP Clearing House", project No. 6 "Toolbox on transport related health impacts, costs and benefits", and project No. 7 "Participation of EECCA country experts at THE PEP meetings".

12. In particular, with a view to assisting EECCA countries to participate at the forthcoming Third High-level Meeting and in its preparatory process, additional resources estimated in the order of US\$ 30,000 are required within the next few months.

V. GUIDELINES FOR THE TRANSFER OF VOLUNTARY CONTRIBUTIONS

13. The secretariat provides below bank information for the transfer of contributions to UNECE and WHO/Europe to ensure the effective implementation of THE PEP workplan and the adequate participation of experts from EECCA countries in its meetings. Contributions should be transmitted to the UNECE THE PEP Trust Fund and/or to WHO/Europe.

14. For administrative reasons, funds for personnel and IT infrastructure for THE PEP Clearing House should be made available to the UNECE Trust Fund, while support for additional services to be provided by the Clearing House can be made available to either organization. In general, resources made available through the UNECE Trust Fund would mainly support activities that have a strong transport and environment component. Funds promoting primarily health-related objectives could be directed to WHO/Europe.
