At the twenty-third session, the UN/LOCODE Advisory Group Mandate and Terms of Reference was approved (ECE/TRADE/C/CEFACT/2017/17). This group aims to ensure the maintenance and further develop the UN/LOCODE standard and to further enhance the network of UN/LOCODE Focal Points. The group requests the renewal of its mandate for the period 2019-2020 with a revised Mandate and Terms of Reference (ECE/TRADE/C/CEFACT/2017/17/Rev.1). At the twenty-third session, the "Sustainable Fisheries Team of Specialists Mandate and Terms of Reference" were approved (ECE/TRADE/C/CEFACT/2017/16) and was subsequently approved, with minor modifications, by the UNECE Executive Committee (EXCOM), during its ninety-second meeting (ECE/TRADE/C/CEFACT/2017/16/Rev.1) for a two-year mandate. The group requests the renewal of its mandate for 2019-2020 with a revised Mandate and Terms of Reference (ECE/TRADE/C/CEFACT/2017/16/Rev.2). This group aims to support the implementation of the Fisheries Language for Universal eXchange (FLUX) standard as well as other standards on sustainable fisheries on a global scale. Invited speakers, delegation and the Bureau will have an opportunity to provide their perspectives on emerging requirements and developments in the field of trade facilitation and electronic business.

UN/CEFACT has been working on traceability for several years, especially in the agriculture, agri-foods and fisheries domain. The application of traceability to the garment and footwear area provides added value in order to ensure sustainable, economically friendly and social responsible value chains which is becoming an increasingly important topic for consumers. This is outlined in the Briefing note on sustainable textile value chains in the garment and footwear domain for SDG12 (ECE/TRADE/C/CEFACT/2019/26).

UN/CEFACT plays a critical role in electronic data exchange and its standardization. In effect, it has proposed to play the role of 'semantic hub' for all data requirements of all organizations. This semantic base is essential in order to ensure the good functioning of new technologies such as Blockchain, Internet of Things, Artificial Intelligence, or any electronic data exchange. This can also support the targets of the UN Sustainable Development Goals (SDGs) as described in the Briefing note on the importance of semantics (ECE/TRADE/C/CEFACT/2019/27).

UN/CEFACT continues to aim to be relevant in the evolving environment of trade facilitation and electronic business. The goal of this session is to brainstorm on how to build on progress in key projects and activities and on those areas that might be given priority in the future.
