# **Proposal for Supplement 12 to the 01 Series of Amendments to UN Regulation No. 43 (Safety glazing)**

#### Submitted by the Working Party on General Safety Provisions\*

The text reproduced below was adopted by the Working Party on General Safety Provisions (GRSG) at its 127<sup>th</sup> session (ECE/TRANS/WP.29/GRSG/106, para. 10). It is based on ECE/TRANS/WP.29/GRSG/2024/19, as amended by para. 10 to the report a. It is submitted to the World Forum for Harmonization of Vehicle Regulations (WP.29) and to the Administrative Committee (AC.1) for consideration at their November 2024 sessions.

Paragraphs 10.1.to 10.3., amend to read:

- "10.1. Procedures for the conformity of production shall conform to the general provisions defined in Article 2 and Schedule 1 of the 1958 Agreement (E/ECE/TRANS/505/Rev.3) and meet the following requirements:
- 10.2. A vehicle approved pursuant to this Regulation shall be so manufactured as to conform to the type approved by meeting the requirements of paragraphs 6. and 7. above shall also comply with the requirements of Annex 23 to this Regulation.
- 10.3. The Type Approval Authority which granted the approval may at any time verify the conformity of control methods applicable to each production unit. The normal frequency of such inspections shall be once every year."
