## **Report of the meeting of the Bureau of the Thirty-Fourth Meeting of the Parties to the Montreal Protocol on Substances that Deplete the Ozone Layer**

### **I. Opening of the meeting**

1. The first meeting of the Bureau of the Thirty-Fourth Meeting of the Parties to the Montreal Protocol on Substances that Deplete the Ozone Layer was held at the headquarters of the United Nations Environment Programme, in Nairobi, on 21 October 2023.
2. The meeting was opened at 4.05 p.m. by the President of the Bureau, Hasan Ali Mubarak (Bahrain).

### **II. Adoption of the agenda**

6. The provisional agenda for the meeting, set out in document UNEP/OzL.Pro.34/Bur.1/1, was adopted as follows:

### **III. Work to date on the implementation of the decisions of the Thirty-Fourth Meeting of the Parties to the Montreal Protocol on Substances that Deplete the Ozone Layer**

7. Introducing the item, the representative of the Ozone Secretariat drew attention to the note by the Secretariat on issues for discussion by and information for the attention of the Bureau of the Thirty-Fourth Meeting of the Parties to the Montreal Protocol (UNEP/OzL.Pro.34/Bur.1/2). Noting that the actions taken in response to the 24 decisions adopted by the Thirty-Fourth Meeting of the Parties were presented in the annex to the note, she provided further updates on a number of those decisions. The decisions had been adopted on the following issues: recognition of the achievements of Paul Jozef Crutzen, Mario José Molina and Frank Sherwood Rowland, winners of the Nobel Prize in Chemistry in 1995; terms of reference for the study on the 2024–2026 replenishment of the Multilateral Fund for the Implementation of the Montreal Protocol; enabling enhanced access and facilitating the transition to energy-efficient and low- or zero-global-warming-potential technologies; illegal import of certain refrigeration, air-conditioning and heat pump products and equipment; identification of gaps in the global coverage of atmospheric monitoring of controlled substances and options for enhancing such monitoring; ongoing emissions of carbon tetrachloride; strengthening institutional processes with respect to information on HFC-23 by-product emissions; strengthening Montreal Protocol institutions, including for combating illegal trade; critical-use exemptions for methyl bromide for 2023; stocks and quarantine and pre-shipment uses of methyl bromide; the composition, balance and workload of the Technology and Economic Assessment Panel and its technical options committees; updating the information on relevant safety standards; collecting data to understand potential impacts of the coronavirus disease (COVID-19) pandemic on hydrofluorocarbon consumption for Group 1 parties operating under paragraph 1 of Article 5 of the Protocol; data and information provided by the parties in accordance with Article 7 of the Protocol; the status of the establishment of licensing systems under Article 4B, paragraph 2 bis, of the Protocol; revision of the baseline data for Madagascar; enhancing participation in the work of the Executive Committee of the Multilateral Fund for the Implementation of the Montreal Protocol through co-option; changes in the membership of the Technology and Economic Assessment Panel; the membership of the Implementation Committee; the membership of the Executive Committee of the Multilateral Fund; the Co-Chairs of the Open-ended Working Group of the Parties to the Montreal Protocol; and the status of ratification of the Kigali Amendment to the Montreal Protocol. Other decisions adopted by the parties addressed issues related to the Thirty-Fifth Meeting of the Parties and the financial reports and budgets for the Montreal Protocol.

8. The Bureau took note of the information provided.

### **IV. Review of the agenda of the Thirty-Fifth Meeting of the Parties to the Montreal Protocol, presentation of a road map for the conduct of the meeting, and overview of the working documents prepared for the meeting**

9. The Executive Secretary drew attention to the list of documents prepared for the Thirty-Fifth Meeting of the Parties (UNEP/OzL.Pro.35/INF/8) and to the agenda of that meeting (UNEP/OzL.Pro.35/1). The agenda of the preparatory segment, to be held from Monday, 23 October to Wednesday, 25 October 2023, included important and sensitive issues, such as the replenishment of the Multilateral Fund for the period 2024–2026 and a proposal on reclassification of developing countries. The sensitive nature of some topics meant that the preparatory segment would not be live streamed, and she expressed the hope that political statements would be limited to the high-level segment, to be held on Thursday and Friday, 26 and 27 October 2023. Parties might wish to discuss some matters further in contact groups or informal groups. The intention was to present all the agenda items on Monday and Tuesday, leaving time for the various contact or informal groups to conclude their deliberations during the remainder of the week. A note by the Secretariat (UNEP/OzL.Pro.35/2) and its addendum (UNEP/OzL.Pro.35/2/Add.1) presented issues for discussion by and information for the attention of the parties. On Friday afternoon, the parties would consider for adoption the draft decisions and the report of the meeting, which would be followed by the closure of the meeting.

10. The Bureau took note of the information provided.

## **V. Other matters**

11. In response to a query about the failure of a region to reach consensus on a candidate for the Implementation Committee, the representative of the Secretariat said that the Secretariat could provide support for the conduct of an informal and unofficial poll within the region to agree on a consensus candidate. If that approach did not lead to agreement within the region, then either several members of the regional group acting together or individual members of the group could submit nominations, including – in the case of individual members – self-nominations. If there was more than one candidate for a position, the Thirty-Fifth Meeting of the Parties could conduct an election by secret ballot to fill the position.

12. The President of the Bureau said that it would be preferable to reach a decision by consensus rather than embark on the use of processes unfamiliar to the Montreal Protocol.

13. No other matters were discussed.

## **VI. Adoption of the report of the meeting**

14. The Bureau agreed to entrust the Secretariat with the preparation of a draft report for circulation to the Bureau members for their comments. The report would then be finalized and presented to the Bureau members for their approval.

## **VII. Closure of the meeting**

15. The President declared the meeting closed at 4.40 p.m. on Saturday, 21 October 2023.
