The evaluation covers the period 2005-2012 and focuses on the following countries/territories in the CEE/CIS region: Armenia; Bosnia and Herzegovina; Kosovo (under United Nations Security Council resolution 1244 [1999]); Kyrgyzstan; the former Yugoslav Republic of Macedonia; and the Republic of Moldova. It assesses the extent to which system-level changes have contributed to young children's increased access to early childhood education programmes and whether there have been any reductions in equity gaps. The evaluation further reviews UNICEF support to system-level changes and assesses the support provided to countries/territories by the Regional Office.
