The report is accompanied by the revised results framework of the Strategic Plan (E/ICEF/2016/6/Add.2); an addendum on the implementation of the quadrennial comprehensive policy review of operational activities for development of the United Nations system and achievements against the Integrated Results and Resources Framework of the Strategic Plan (E/ICEF/2016/6/Add.1); a scorecard and data companion; and a paper on lessons learned in the first two years of the Strategic Plan.
