## **Position of the State of Libya on the recommendations made during the twenty-second session of the Working Group on the Universal Periodic Review**

1. The State of Libya reaffirms its respect for and commitment to human rights and its firm commitment to the universal periodic review, which is a mechanism for assessing progress in human rights and which provides national authorities with the opportunity to exchange best practices in that regard.
2. The acceptance by the State of Libya of a large number of recommendations reflects those commitments and the fact that the recommendations in question do not conflict with the transitional Constitutional Declaration or with Islamic sharia law. It should also be borne in mind that Libya is passing through a transitional phase involving the building of State institutions, particularly those responsible for ensuring the protection of and respect for human rights, and involving the completion of the final draft of the Constitution.
3. The following table shows the country's position on the recommendations made during the consideration of its second national report under the universal periodic review procedure. The recommendations are either accepted, partially accepted, noted or not accepted.
