Concluding remarks and responses of Burundi to the recommendations of the third cycle of the universal periodic review on 18 January 2018

1. Burundi expresses its warm thanks to the 96 delegations that participated in the third cycle of its universal periodic review on 18 January 2018.
2. It welcomes the 242 recommendations made, particularly those relating to improving the human rights of groups that require special protection, such as women and children, persons with disabilities and indigenous peoples.
3. As stated during the interactive dialogue, Burundi has already made significant efforts in introducing major changes at both the normative and institutional levels with a view to promoting and protecting human rights, particularly in the implementation of international standards in each of the Government's areas of action.
4. As part of its commitment to ensuring that its citizens enjoy the broadest and most effective exercise of their fundamental rights, Burundi amended its Constitution (Basic Law) through a Government-funded referendum held on 17 May 2018, in which the Burundian people exercised their inalienable right as a matter of national sovereignty, in accordance with the basic principles of human rights, with a record turnout of 96 per cent and 73 per cent in favour of the amendments.
5. The people of Burundi continue to demonstrate their political maturity in order to secure and sustain institutional stability and social cohesion, which augurs well for free, transparent and peaceful elections to the institutions of the Republic in 2020.
6. In the following paragraphs, Burundi presents its position on the recommendations made and reaffirms its commitment to working in line with the shared goal of the universal human rights system to guarantee full enjoyment of their fundamental rights for all Burundians.
