## انتخاب أعضاء اللجنة الاستشارية لمجلس حقوق الإنسان\*

### مذكرة من الأمين العام

1- وفقاً لقرار مجلس حقوق الإنسان 1/5، ينتخب المجلس أعضاء اللجنة الاستشارية لمجلس حقوق الإنسان، المؤلفة من 18 خبيراً يعملون بصفتهم الشخصية وترشحهم الدول الأعضاء في الأمم المتحدة عقب مشاورات الدول مع المؤسسات الوطنية لحقوق الإنسان ومنظمات المجتمع المدني، بالاقتراع السري من قائمة المرشحين الذين قُدمت أسماؤهم وفقاً للشروط المتفق عليها.

2- ويكون التوزيع الجغرافي للأعضاء كما يلي:

- (أ) خمسة أعضاء من مجموعة الدول الأفريقية؛
- (ب) خمسة أعضاء من مجموعة دول آسيا والمحيط الهادئ؛
- (ج) عضوان من مجموعة دول أوروبا الشرقية؛
- (د) ثلاثة أعضاء من مجموعة دول أمريكا اللاتينية والكاريبي؛
- (هـ) ثلاثة أعضاء من مجموعة دول أوروبا الغربية ودول أخرى.

3- واعتمد مجلس حقوق الإنسان، في دورته السادسة، المقرر 102/6 المتعلق بمتابعة تنفيذ قرار المجلس 1/5 الذي حدّد فيه المتطلبات التقنية والموضوعية لتقديم أسماء المرشحين، ومن ضمنها ما يلي:

- (أ) كفاءة وخبرة مشهود بهما في مجال حقوق الإنسان؛
- (ب) الخلق الرفيع؛
- (ج) الاستقلال والنزاهة.

\* يعمّم مرفق هذه الوثيقة كما ورد وباللغة التي قُدم بها فقط.



4- ويُطلب من الدول الأعضاء أن تطبق، عند اختيار مرشحها، المبادئ التوجيهية المتعلقة بالمتطلبات التقنية والموضوعية لتقديم مرشحها، وهي كما يلي:

(أ) الكفاءة والخبرة:

'1' دراسات أكاديمية في مجال حقوق الإنسان أو في مجالات ذات صلة، و/أو خبرة ودراية فيما يتعلق بأداء أدوار قيادية في مجال حقوق الإنسان على الصعيد الوطني أو الإقليمي أو الدولي؛

'2' خبرة كبيرة (لا تقل عن خمس سنوات) وإسهامات شخصية في مجال حقوق الإنسان؛

'3' معرفة بمنظومة الأمم المتحدة والولايات والسياسات المؤسسية ذات الصلة بالعمل في مجال حقوق الإنسان، فضلاً عن المعرفة بالصكوك والقواعد والضوابط الدولية لحقوق الإنسان؛ ويحبذ الإلمام بنظم قانونية وحضارات مختلفة؛

'4' إجادة لغة واحدة على الأقل من اللغات الرسمية للأمم المتحدة؛

'5' توافر الوقت الكافي لدى المرشح لأداء عمل اللجنة الاستشارية على نحو فعال، بهدف حضور دورات اللجنة والاضطلاع بالأنشطة التي تصدر بها تكليفات في الفترات التي تتخلل الدورات؛

(ب) الخلق الرفيع؛

(ج) الاستقلال والنزاهة: الأفراد الذين يشغلون مناصب صنع القرار في الحكومة أو في أي منظمة أو كيان آخر، بما قد يسفر عن تضارب في المصالح مع المسؤوليات الأساسية الملائمة للولاية، يجري استبعادهم؛ وسيصرف أعضاء اللجنة الاستشارية المنتخبون بصفتهم الشخصية؛

(د) اعتبارات أخرى: احترام مبدأ عدم الجمع بين عدة مهام في مجال حقوق الإنسان في

آنٍ واحد.

5- وعند انتخاب أعضاء اللجنة الاستشارية، ينبغي أن يولي مجلس حقوق الإنسان الاعتبار الواجب للتوازن بين الجنسين ولتمثيل النظم القانونية والحضارات المختلفة تمثيلاً مناسباً.

6- وأجرى مجلس حقوق الإنسان، في دورته السابعة، أول الانتخابات لتعيين أعضاء اللجنة الاستشارية البالغ عددهم 18. وانتُخب أربعة أعضاء لولاية مدتها سنة واحدة وسبعة أعضاء لولاية مدتها سنتان وسبعة أعضاء لولاية مدتها ثلاث سنوات.

7- وسيجري مجلس حقوق الإنسان، في دورته الحادية والخمسين، وفقاً لبرنامج عمله السنوي، ثلاثة انتخابات لتعيين تسعة أعضاء في اللجنة الاستشارية، وهي كما يلي:

(أ) انتخابات عادية لتعيين سبعة أعضاء يعوضون أولئك الذين تنتهي مدة ولايتهم في 30

أيلول/سبتمبر 2022<sup>(1)</sup>، من قائمة المرشحين الذين تسميهم الدول الأعضاء (انظر الفرع أولاً أدناه)؛

(1) من بين هؤلاء الأعضاء السبعة، استقال عضو واحد من مجموعة الدول الأفريقية، السيدة منى عمر، في كانون الثاني/يناير 2022، عقب انتخابها في كانون الأول/ديسمبر 2021 من قبل الجمعية العامة في المنتدى الدائم المعني بالمنحدرين من أصل أفريقي، وتوفي عضو واحد من مجموعة دول أوروبا الشرقية، السيد يوري كوليسنيكوف، في نيسان/أبريل 2022. ولذلك فإن هذين المقعدين شاغران حالياً.

(ب) انتخابات فرعية لملء شاغر طارئ ناجم عن وفاة عضو في اللجنة الاستشارية لمجلس حقوق الإنسان في أيار/مايو 2022، من قائمة المرشحين الذين تسميهم الدول الأعضاء (انظر الفرع ثانياً أدناه)؛

(ج) انتخابات فرعية لملء شاغر طارئ ناجم عن استقالة عضو في اللجنة الاستشارية لمجلس حقوق الإنسان في تموز/يوليه 2022، من قائمة المرشحين الذين تسميهم الدول الأعضاء (انظر الفرع ثالثاً أدناه).

8- وعملاً بأحكام الفقرة 71 من قرار مجلس حقوق الإنسان 1/5، تُغلق قائمة المرشحين قبل تاريخ الانتخاب بشهرين، وتُتبع الأمانة قائمة المرشحين والمعلومات ذات الصلة للدول الأعضاء وللجمهور قبل تاريخ الانتخاب بشهر واحد على الأقل.

## أولاً- الأسماء الذين رشحتهم الدول الأعضاء ليحلوا محل الأعضاء السبعة الذين تنتهي مدة ولايتهم في 30 أيلول/سبتمبر 2022

9- في 21 نيسان/أبريل 2022، وجهت أمانة مجلس حقوق الإنسان مذكرة شفوية إلى المنتسبين الإقليميين المعنيين، تحث فيها على اقتراح مرشحين وتبلغهم بأن الموعد النهائي لتقديم الترشيحات هو 8 حزيران/يونيه 2022.

10- ومن هذه المناصب السبعة الشاغرة، يعود منصبان للدول الأفريقية، ومنصبان لدول آسيا والمحيط الهادي، ومنصب واحد لدول أوروبا الشرقية، ومنصب واحد لدول أمريكا اللاتينية والكاريبي، ومنصب واحد لدول أوروبا الغربية ودول أخرى.

11- وفي 8 حزيران/يونيه 2022، وجهت أمانة مجلس حقوق الإنسان مذكرة شفوية إلى المنتسبين الإقليميين المعنيين لإبلاغهم بأنه جرى تمديد الموعد النهائي لتقديم الترشيحات إلى غاية 24 حزيران/يونيه 2022.

12- وفي أعقاب ذلك، تلقت الأمانة أسماء سبعة مرشحين لانتخاب أعضاء في اللجنة الاستشارية في عام 2022 من حكومات إسبانيا وأنغولا وأوروغواي والجزائر وسلوفينيا والصين وقطر.

13- وفيما يلي الترشيحات المقدمة؛ وترد بيانات السير الذاتية للمرشحين في المرفق.
