## Elección de los miembros del Comité Asesor del Consejo de Derechos Humanos\* \*\*

### Nota del Secretario General

1. Conforme a la resolución 5/1 del Consejo de Derechos Humanos, el Comité Asesor del Consejo de Derechos Humanos está compuesto por 18 expertos que actúan a título personal y cuyas candidaturas son propuestas por los Estados Miembros de las Naciones Unidas tras la celebración de consultas con sus instituciones nacionales de derechos humanos y con organizaciones de la sociedad civil, que serán elegidos por el Consejo, en votación secreta, de la lista de candidatos que se hayan propuesto con arreglo a los requisitos acordados.

2. La distribución geográfica de los miembros será la siguiente:

- a) Cinco de Estados de África;
- b) Cinco de Estados de Asia y el Pacífico;
- c) Dos de Estados de Europa Oriental;
- d) Tres de Estados de América Latina y el Caribe;
- e) Tres de Estados de Europa Occidental y otros Estados.

3. En su sexto período de sesiones, el Consejo de Derechos Humanos adoptó la decisión 6/102 sobre el seguimiento de su resolución 5/1, en la que expuso los requisitos técnicos y objetivos para la presentación de candidaturas, que incluyen:

- a) Competencia y experiencia reconocidas en la esfera de los derechos humanos;
- b) Gran integridad moral;
- c) Independencia e imparcialidad.

4. Al seleccionar a los candidatos, los Estados deben aplicar las siguientes directrices sobre los requisitos técnicos y objetivos para la presentación de sus candidatos:

- a) Competencia y experiencia:
  - i) Estudios académicos en derechos humanos o esferas conexas y/o experiencia y conocimiento de las funciones de liderazgo en materia de derechos humanos a nivel nacional, regional o internacional;
  - ii) Experiencia sustancial (por lo menos cinco años) y contribuciones personales en la esfera de los derechos humanos;
  - iii) Conocimientos del sistema de las Naciones Unidas y de los mandatos y las políticas institucionales relacionados con la labor en la esfera de los derechos humanos, así como conocimiento de los instrumentos, las normas y las disciplinas internacionales relativos a los derechos humanos; será preferible que el candidato tenga familiaridad con los distintos ordenamientos jurídicos y las distintas culturas;
  - iv) Dominio de por lo menos uno de los idiomas oficiales de las Naciones Unidas;
  - v) Tiempo suficiente para cumplir la labor del Comité Asesor de manera efectiva, asistiendo a sus períodos de sesiones y desarrollando las actividades encomendadas entre períodos de sesiones;
- b) Gran integridad moral;
- c) Independencia e imparcialidad: quedarán excluidas las personas que ocupen cargos de decisión en Gobiernos o en cualquier organización o entidad que pudieren dar lugar a un conflicto de intereses con las responsabilidades inherentes al mandato; los miembros elegidos del Comité Asesor actuarán a título personal;
- d) Otras consideraciones: se respetará el principio de no acumulación simultánea de funciones de derechos humanos.

5. Al elegir a los miembros del Comité Asesor, el Consejo de Derechos Humanos prestará la debida atención al equilibrio de género y a una adecuada representación de las diferentes culturas y sistemas jurídicos.

6. En su séptima sesión, el Consejo de Derechos Humanos celebró las primeras elecciones de los 18 miembros del Comité Asesor: 4 miembros fueron elegidos por un mandato de 1 año, 7 por un mandato de 2 años y 7 por un mandato de 3 años.

7. En su 57º período de sesiones, de conformidad con su programa de trabajo anual, el Consejo de Derechos Humanos elegirá a los miembros del Comité Asesor que ocuparán los 4 puestos vacantes. De las 4 vacantes, 1 corresponde a Estados de África, 1 a Estados de Asia-Pacífico, 1 a Estados de América Latina y el Caribe y 1 a Estados de Europa Occidental y otros Estados.

8. De conformidad con el párrafo 71 de la resolución 5/1 del Consejo de Derechos Humanos, la lista de candidatos se cerrará dos meses antes de la fecha de la elección, y la Secretaría pondrá dicha lista y la información pertinente a disposición de los Estados miembros y del público por lo menos un mes antes de la elección.

9. El 11 de abril de 2024, la Secretaría del Consejo de Derechos Humanos dirigió una nota verbal a los coordinadores regionales interesados para alentar a la presentación de propuestas de candidaturas, y les informó de que la fecha límite para la presentación de candidaturas era el 6 de junio de 2024.

10. En respuesta, la secretaría recibió cinco candidaturas para las elecciones de 2024 a los puestos de miembro del Comité Asesor, procedentes de los Gobiernos del Brasil, Ghana, Grecia, la Arabia Saudita y Sudáfrica. Posteriormente, mediante nota verbal de 6 de agosto de 2024, Ghana informó a la secretaría del Consejo de Derechos Humanos de que retiraba la candidatura que había presentado.

11. Las candidaturas recibidas figuran a continuación; los datos biográficos relativos a los candidatos figuran en el anexo.

### **II. Summary of professional skills /expertise**

I am an admitted advocate of the High Court of South Africa. I have practical legal experience as a public prosecutor in the magistrates' court and as State Advocate at the then Witwatersrand Division of the Supreme Court of South Africa. I have from time to time engaged with legal practice, including appearing in the country's highest court, and I also worked as advisor to the Centre for the Study of AIDS Paralegal Advice Centre, Hammanskraal, Tshwane.

In my work as academic, I have focused on regional human rights protection, with particular attention to the African Court on Human and Peoples' Rights. I acted as founding academic coordinator of the Master's programme in Human Rights and Democratisation in Africa, introduced in 2000, by the Centre for Human Rights, bringing together students from across Africa for postgraduate studies focused on the African regional human rights system. I am the author of one of the leading texts on the African human rights system, *International human rights law in Africa*, published by Oxford University Press in 2007 (first edition) and in a reworked and revised edition (2012). I have researched and published numerous articles and chapters in books on the African human rights system generally, and the African Commission and Court on Human and Peoples' Rights, specifically. I have supervised doctoral theses on different aspects of the African human rights system, including: "The impact of the recommendation of the African Commission on Human and Peoples' Rights" (J Biegong); "State compliance with and influence of reparations orders by international human rights tribunals in five selected African states" (V Ayeni); and "The East African Court of Justice: Towards effective protection of human rights in the East African Economic Community" (A Possi). I am the founding editor of the leading journal on human rights in Africa, the *African Human Rights Law Journal*, and lead the editorial team of the *African Human Rights Yearbook/Annuaire africain des droits de l'homme*.

I was the Director of the Centre for Human Rights from 2007 to 2023. In that capacity, I led a number of teams that supported aspects of the mandate of special mechanisms of the African Commission, in particular the Special Rapporteur on the Rights of Women in Africa (through the development of reporting guidelines under the Protocol to the African Charter on the Rights of Women in Africa, and General Comments); and the Special Rapporteur on the Right to Freedom of Expression and Access to Information in Africa (through the development of the Model Law on Access to Information in Africa). I oversaw research and advocacy Units on the rights of children, women, persons with disabilities and on freedom of expression and access to information; and oversaw the introduction of Master's programmes on "Sexual and Reproductive Rights in Africa" and "Disabilities Rights in Africa".

I am still closely involved in Centre activities, including the planning and organising of two international Moot Court Competitions. Since 1992, the Centre for Human Rights organises the African Human Rights Moot Court Competition in partnership with a host university, in

a different African country each year. Teams of students argue a hypothetical case before benches of law lecturers and human rights experts as if they were before the real African Court on Human and Peoples' Rights.

In 1999, together with the late Professor Christof Heyns, I conducted a study on the impact of the United Nations human rights treaties on 20 selected countries. At the time of his sad and untimely death earlier this year, we were in the process of completing a follow-up study, to trace the impact in the subsequent 20 years. This study has been completed in 2024 (with Professor Rachel Murray added as co-editor).
