

Election of 12 members of the Subcommittee on Prevention of Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment

Note by the Secretary-General*

- 1. In accordance with articles 7 and 9 of the Optional Protocol to the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, the tenth meeting of the States parties to the Optional Protocol will be held at the United Nations Office at Geneva on 24 October 2024, for the purpose of electing 12 members of the Subcommittee from a list of persons nominated by States parties (sect. II), to replace those whose terms of office will expire on 31 December 2024 (sect. I). Thirteen members will continue to serve on the Subcommittee until 31 December 2026 (sect. III).
- 2. In addition, in compliance with paragraph 12 of General Assembly resolution 68/268, the current situation with respect to the composition of the Subcommittee, reflecting the balance in terms of geographical distribution, gender representation and different legal systems, as well as the tenure of current members, is contained in sections I and III of the present document; the biographical data, including in respect of professional background, of current members can be found on the web page of the Subcommittee.¹
- 3. In paragraph 13 of its resolution 68/268, the General Assembly encouraged States parties, in the election of treaty body experts, to give due consideration, as stipulated in the relevant human rights instruments, to equitable geographical distribution, the representation of the different forms of civilization and the principal legal systems, balanced gender representation and the participation of experts with disabilities in the membership of the human rights treaty bodies.

I have been in public service since 1997 and became one of the first two female judges of the Maldives upon appointment to the bench of the Civil Court in 2007. In 2019, I was elected as a member of the Executive Committee of the first ever Bar Council of Maldives, on which I served until my appointment as one of the first ever two female judges appointed to the Supreme Court. I was elected to represent the Justices of the Supreme Court at the Judicial Service Commission until 2024 and also worked on the boards of the Maldives Judicial Academy and the Faculty of Shariah and Law of the Maldives National University. I served on the SPT from 2011–2018, during which was the Vice-Chairperson for Jurisprudence and SPT Rapporteur. I was re-elected to the SPT in 2020 and currently serve as the treaty body's Vice-Chairperson for National Preventative Mechanisms (NPMs) and serve as the SPT's focal point to GANHRI and the UN's treaty body strengthening process.

During my time at SPT, I have assisted in developing its jurisprudence and advised numerous States Parties and NPMs, in addition to contributing to the UN's treaty body strengthening process and engaging with partners working in torture prevention. I have also contributed to developing the criminal justice system, assisted in developing the Prisons and Parole Act, advised the government on basic minimum standards that are required in prisons, provide training to judges on human rights and constitutional law, including on the subject of torture prevention and prohibition. Further, I assisted in the drafting of the Juvenile Justice Act and provided multiple rounds of training on its rollout. Additionally, I was one of three people who established the Maldives Detainee Network, one of the first organisations that worked to improve treatment of prisoners.
