Annex III

INTRODUCTION

1. In the course of its fifty-first session, the Commission on Human Rights adopted four resolutions that have programme budget implications for the biennium 1994-1995. Those resolutions relate to new mandates or existing mandates which have been significantly expanded in scope.

2. Before taking a decision on these resolutions, and in accordance with regulation 13.1 of the Financial Regulations of the United Nations and rule 28 of the rules of procedure of the functional commissions of the Economic and Social Council, the Commission was informed through oral statements of the preliminary additional resources that would be required to implement the new and expanded mandates. The Commission was also informed that the full statements on the programme budget implications would be submitted to the Economic and Social Council in the context of the Council's consideration of the report of the Commission.

3. The statements on the administrative and programme budget implications of the four resolutions adopted by the Commission on Human Rights at its fifty-first session as submitted for the consideration of the Council may be found below.

4. The programme budget implications of those resolutions are summarized in the following table.

I. PROGRAMME BUDGET IMPLICATION STATEMENTS

Resolution 1995/17. The right to development

A. Requests contained in the resolution

5. In paragraph 9 of resolution 1995/17, the Commission on Human Rights decided that the Working Group on the Right to Development would hold two sessions, each for a two-week period, in April and September 1995 respectively, to formulate its recommendations for submission to the Commission at its fifty-second session.

B. Relationship of requests to the programme of work

6. The activities referred to above fall under programme 35 (Promotion and protection of human rights), subprogramme 2 (Elimination and prevention of discrimination and protection of minorities and vulnerable groups) of the medium-term plan for the period 1992-1997, as revised (A/47/6/Rev.1).

7. They also fall under the following programme component and activities of section 21 (Human rights) of the programme budget for the biennium 1994-1995:

Subprogramme 2. Elimination and prevention of discrimination and protection of minorities and vulnerable groups

Activities: 1. Parliamentary services

(b) Technical services: servicing of the session of the Commission on Human Rights and sessions of the working groups and of the United Nations Voluntary Fund for Indigenous Populations.

C. Activities by which the requests would be implemented

8. In accordance with paragraph 9 of resolution 1995/17, the Working Group would hold two sessions, each for a two-week period, in April and September 1995 respectively, to formulate its recommendations for submission to the Commission at its fifty-second session. That would constitute one additional session with regard to the single annual session contemplated by the Commission at the time of the establishment of the Working Group, in 1993.

9. Accordingly, additional travel expenses and subsistence allowance, as well as conference services, for one additional meeting of 10 working days annually would be required.

D. Modification of the programme of work

10. No modification of the programme description is necessary.

E. Additional requirements at full cost

11. The estimated full cost of the above activities is itemized as follows:

F. Potential for absorption

12. It will be recalled that, pursuant to Commission on Human Rights resolution 1994/21, an additional annual session of the Working Group was held in 1994. The additional requirements of this additional session (\$45,000) were met, at that time, from the existing appropriation.

13. As noted above, for 1995 the requirements related to the holding of one additional session are estimated at \$46,800. These costs represent the net additional resources required for 1995 over and above the resources already allocated in the programme budget for the biennium 1994-1995 in connection with the Working Group. At this stage, it is not anticipated that these requirements could be absorbed within the provision under section 21 of the programme budget for the biennium 1994-1995.

14. The conference-servicing costs relating to this draft resolution are dealt with in paragraph 49 below.

G. Indication of additional requirements

15. Should the Economic and Social Council decide to approve this resolution, it is estimated that additional requirements of \$46,800 would arise under section 21 of the programme budget for the biennium 1994-1995.

H. Contingency fund

16. With regard to the possible use of the contingency fund for the implementation of this resolution, see paragraph 48 below.

Resolution 1995/28. International Decade of the World's Indigenous People

A. Requests contained in the resolution

17. In paragraph 5 of resolution 1995/28, the Commission on Human Rights took note of the request of the General Assembly for the establishment of a unit within the Centre for Human Rights to support its activities related to indigenous people, in particular to plan, coordinate and implement activities for the Decade.

18. In paragraph 6 of the same resolution, the Commission also took note of the recommendation of the General Assembly that a second technical meeting on the planning of the Decade should be convened immediately prior to the thirteenth session of the Working Group on Indigenous Populations of the Sub-Commission and of the decision to consider at a later session the convening of meetings for planning and review purposes at appropriate intervals during the Decade.

B. Relationship of requests to the programme of work

19. The activities referred to above fall under programme 35 (Promotion and protection of human rights), subprogramme 2 (Elimination and prevention of discrimination and protection of minorities and vulnerable groups) of the medium-term plan for the period 1992-1997, as revised (A/47/6/Rev.1).

20. They also fall under subprogramme 2 (Elimination and prevention of discrimination and protection of minorities and vulnerable groups) of section 21 (Human rights) of the programme budget for the biennium 1994-1995.

C. Activities by which the requests would be implemented

21. With regard to paragraph 5 of resolution 1995/28, it will be recalled that, pursuant to the recommendations of the Vienna Declaration and Programme of Action (A/CONF.157/23), provisions have already been made in the 1994-1995 budget for two additional temporary posts (one P-4 and one General Service) in order to assist in the coordination of the programme of activities for the International Decade of the World's Indigenous People.

22. In accordance with paragraph 6 of the resolution, it is envisaged that a second technical open-ended meeting of the Commission on Human Rights on the planning of the Decade be convened by the Centre for Human Rights on 17 and 18 July 1995, immediately prior to the thirteenth session of the Working Group on Indigenous Populations.

D. Modification of the programme of work

23. The description of the programme of work under subprogramme 2 of section 21 would be modified through the addition of a reference to "technical meetings on the planning of the International Decade of the World's Indigenous People" in subparagraph (c), "Ad hoc expert groups ...", under "Activities: 1. Parliamentary services".

E. Additional requirements at full cost

24. The substantive servicing of the technical meeting would be provided by the Centre for Human Rights and its costs would be absorbed from existing resources of section 21 (Human rights) of the programme budget for the biennium 1994-1995. The estimated full cost of conference-servicing to be provided to the Working Group is as follows:

Resolution 1995/32. Establishment of a working group of the Commission on Human Rights to elaborate a draft declaration in accordance with paragraph 5 of General Assembly resolution 49/214 of 23 December 1994

A. Requests contained in the resolution

26. In paragraph 1 of resolution 1995/32, the Commission on Human Rights decided to establish, as a matter of priority and from within existing overall United Nations resources, an open-ended inter-sessional working group of the Commission on Human Rights with the sole purpose of elaborating a draft declaration, considering the draft contained in the annex to resolution 1994/45 of 26 August 1994 of the Sub-Commission on Prevention of Discrimination and Protection of Minorities, entitled draft "United Nations declaration on the rights of indigenous peoples" for consideration and adoption by the General Assembly within the International Decade of the World's Indigenous People.

27. In paragraph 3 of the same resolution, the Working Group was requested to meet for 10 working days at the earliest possible date in 1995.

B. Relationship of requests to the programme of work

28. The activities referred to above fall under programme 35 (Promotion and protection of human rights), subprogramme 2 (Elimination and prevention of discrimination and protection of minorities and vulnerable groups) of the medium-term plan for the period 1992-1997, as revised (A/47/6/Rev.1).

29. They also fall under subprogramme 2 (Elimination and prevention of discrimination and protection of minorities and vulnerable groups) of section 21 (Human rights) of the programme budget for the biennium 1994-1995.

C. Activities by which the requests would be implemented

30. The Centre for Human Rights would organize an open-ended working group of the Commission on Human Rights for 10 working days in the autumn of 1995.

D. Additional requirements at full cost

31. The substantive servicing of the Working Group would be provided by the Centre for Human Rights and its cost would be absorbed from existing resources of section 21 (Human rights) of the programme budget for the biennium 1994-1995. The estimated full cost of conference-servicing to be provided to the Working Group is itemized as follows:

Resolution 1995/91. Situation of human rights in Rwanda

A. Requests contained in the resolution

33. In paragraph 19 of resolution 1995/91, the Commission on Human Rights decided to extend the mandate of the Special Rapporteur, as set out in resolution S-3/1 of 25 May 1994, for an additional year, and requested the Special Rapporteur to make recommendations concerning situations in which technical assistance might be appropriate.

34. In paragraph 20 of the same resolution, the Secretary-General was requested to provide all necessary resources to the Special Rapporteur, taking into account the operational plan for the human rights field operation in Rwanda and the need to deploy a sufficient number of human rights field officers to assist the Special Rapporteur to fulfil his mandate.

35. In paragraph 21, the Secretary-General was requested to take appropriate steps to ensure adequate financial and human resources for the delivery of programmes of technical assistance and advisory services, especially in the field of the administration of justice as requested by the Government of Rwanda.

B. Relationship of requests to the programme of work

36. The activities referred to in paragraphs 19 and 20 of the resolution fall under programme 35 (Promotion and protection of human rights), subprogramme 1 (Implementation of international instruments and procedures) of the medium-term plan for the period 1992-1997, as revised (A/47/6/Rev.1).

37. They also fall under the following programme component and activities of section 21 (Human rights) of the programme budget for the biennium 1994-1995:

Subprogramme 1. Implementation of international instruments and procedures

Activities: 1. International cooperation

(a) Settlement of disputes, special missions, good offices, fact-finding, emergency and humanitarian relief services, legal services:

(i) Assisting special rapporteurs, representatives or other designees (thematic and country-oriented) dealing with human rights violations and investigations or fact-finding into reported situations and cases and reporting to the Commission on Human Rights or the General Assembly.

C. Activities by which the requests would be implemented

38. During the course of 1995, the Special Rapporteur would undertake four trips to Geneva, each for a period of five working days, to hold consultations at the Centre for Human Rights, to review documentation and other pertinent materials received, to meet representatives of Governments as well as intergovernmental and non-governmental organizations, and to prepare his report. He would also travel to New York in November for five working days to present his report to the General Assembly.

39. The Special Rapporteur, accompanied by one staff member of the Centre for Human Rights, would undertake three visits to the area (Rwanda and neighbouring countries), each for a period of 10 days.

40. Provisions would be made for the continuation of the resources approved in 1994 for the substantive servicing of the Special Rapporteur, which includes a team of six human rights field officers stationed in Rwanda and two locally recruited secretaries.

41. The requirements related to the implementation of a comprehensive programme for technical cooperation in the field of human rights, including advisory services in the administration of justice, are expected to be met from extrabudgetary resources. To this end, an appeal has recently been launched by the United Nations High Commissioner for Human Rights for contributions to the Voluntary Fund for Technical Cooperation in the Field of Human Rights.

D. Additional requirements at full cost

42. The estimated full cost of the above activities is itemized as follows:

E. Potential for absorption

43. At its forty-ninth session, the General Assembly approved additional resources in the amount of \$539,700 under section 21 (Human rights) of the 1994-1995 programme budget to finance the additional requirements resulting from Commission on Human Rights resolution 1994/S-3/1, which was endorsed by the Economic and Social Council at its special session in June 1994 in decision 1994/223 concerning the appointment of the Special Rapporteur on Rwanda.

44. The above resources cover the requirements for the period July 1994 until the end of February 1995. Therefore, no resources have been budgeted in the 1994-1995 programme budget to finance the additional requirements of \$549,500 related to the extension of the mandate of the Special Rapporteur for one additional year. At this stage, it is not anticipated that these requirements could be absorbed within the provisions under section 21 (Human rights) of the programme budget for the biennium 1994-1995.

F. Indication of additional requirements

45. Should the Economic and Social Council decide to approve this resolution, it is estimated that additional requirements of \$549,500 would arise under section 21 of the programme budget for the biennium 1994-1995.

G. Contingency fund

46. With regard to the possible use of the contingency fund for the implementation of this resolution, see paragraph 48 below.

II. SUMMARY

47. The requests contained in the resolutions referred to above would give rise to additional requirements totalling \$596,300 under section 21 (Human rights) and \$412,000 under section 25E (Conference services) of the programme budget for the biennium 1994-1995.

Requirements of the Centre for Human Rights (Section 21)

48. Under the procedure approved by the General Assembly in its resolutions 41/213 of 19 December 1986 and 42/211 of 21 December 1987, a contingency fund is established each biennium to accommodate additional expenditures derived from legislative mandates not provided for in the programme budget. Under the same procedure, if additional expenditures are proposed that exceed resources available from the contingency fund, these activities can be implemented only through redeployment of resources from low priority areas or modification of existing activities. Otherwise, such additional activities will have to be deferred until a later biennium. No activity has been identified for termination, deferral, curtailment or modification under section 21 of the programme budget for the biennium 1994-1995 to accommodate the new or expanded mandates. Should it not prove possible to meet the costs relating to those mandates from the contingency fund, the implementation of the resolutions and decisions may have to be postponed, as provided for in the guidelines for the use and operation of the contingency fund adopted by the General Assembly in its resolution 42/211 of 21 December 1987.

Conference-servicing costs (section 25E)

49. As stated above, the requirements for conference-servicing costs amount to \$412,000. This amount is based on the theoretical assumption that no part of the conference-servicing requirements would be met from within the permanent conference-servicing capacity under section 25E of the approved programme budget, and that additional resources would be required for temporary assistance for meetings. The extent to which the Organization's permanent capacity needs to be supplemented by temporary assistance resources

can be determined only in the light of the calendar of conferences for 1994-1995. However, it should be noted that the 1994-1995 level of resources for temporary assistance for meetings was estimated on the basis of previous experience to accommodate not only meetings known at the time of budget preparation but also meetings that would be authorized subsequently, provided that the number and distribution of meetings and conferences in the biennium 1994-1995 were consistent with the pattern of meetings in past years. On that basis, it is estimated that no additional resources would be required under section 25E of the programme budget for the biennium 1994-1995.
