IV. Advances by new Member States to the Working Capital Fund for the biennium 2002-2003 and contributions to the United Nations regular budget for the year 2002

A. Advances to the Working Capital Fund for the biennium 2002-2003

2. In its resolution 56/257 of 24 December 2001, the General Assembly resolved that the "Working Capital Fund shall be established for the biennium 2002-2003 in the amount of 100 million United States dollars". In accordance with paragraph 16 of Assembly resolution 57/4 B of 20 December 2002, the advances for the new Member States whose rates of assessment have not yet been incorporated in a 100 per cent scale of assessment are:

B. Contributions to the United Nations regular budget for the year 2002

3. The basis of assessment for the year 2002 was \$1,110,441,650 (being the amount assessed on Member States of \$1,286,710,550 less staff assessment income of \$176,268,900) under General Assembly resolution 56/254 C of 24 December 2001. In its resolution 57/4 B, the Assembly decided that the contributions of Switzerland and Timor-Leste for the year 2002 should be calculated on the basis of one twelfth of their relevant rates of assessment for the year 2002 per full calendar month of membership and that Switzerland should be credited with a corresponding proportion of its non-member State assessment for the year 2002.
