Security Council Committee established pursuant to resolution [2127 \(2013\)](#) concerning the Central African Republic

Note verbale dated 2 April 2014 from the Permanent Mission of Latvia to the United Nations addressed to the Chair of the Committee

The Permanent Mission of the Republic of Latvia to the United Nations presents its compliments to the Chair of the Security Council Committee established pursuant to resolution [2127 \(2013\)](#) concerning the Central African Republic.

In accordance with paragraph 42 of Security Council resolution [2134 \(2014\)](#), Latvia is hereby transmitting its national implementation report (see annex). In the event that further information on the matter is needed, the Government of Latvia stands ready to provide it.

National implementation report

The Republic of Latvia and the other member States of the European Union have jointly implemented the travel ban and financial restrictions imposed by the Security Council in its resolution [2134 \(2014\)](#) by taking the following common measures:

- *Council Decision 2014/125/CFSP of 10 March 2014 amending Decision 2013/798/CFSP concerning restrictive measures against the Central African Republic.*¹

The Council decision sets out the commitment of the European Union to the implementation of the following measures:

- Freezing of funds and economic resources of entities and individuals
- Travel restrictions

The Council decision also reconfirms and extends the arms embargo established under Security Council resolution [2127 \(2013\)](#), in accordance with Security Council resolution [2134 \(2014\)](#).

- *Council Regulation (EU) No. 224/2014 of 10 March 2014 concerning restrictive measures in view of the situation in the Central African Republic.*² The Council has adopted this regulation in order to implement measures provided for in Council Decision 2014/125/CFSP as regards the freezing of funds and economic resources of entities and individuals.
- *Council Regulation (EC) No. 539/2001 of 15 March 2001 listing the third countries whose nationals must be in possession of visas when crossing the external borders and those whose nationals are exempt from that requirement*³ (and its subsequent amendments). The regulation requires nationals of the Central African Republic to be in possession of a visa when entering the European Union. Therefore, the respective restrictions of admission are to be implemented through the visa application process.
- *Council Common Position 2008/944/CFSP of 8 December 2008 defining common rules governing control of exports of military technology and equipment.*⁴ The provisions of the common position have been implemented in the national legislation through Regulations of the Cabinet of Ministers of the Republic of Latvia No. 657 Procedure of Issuance of Licenses for Goods of Strategic Significance and the Related Documents to Circulation of Goods of Strategic Significance, adopted on 20 July 2010.

- *Law on the Circulation of Goods of Strategic Significance* of the Republic of Latvia,⁵ adopted on 21 June 2007. The law stipulates export authorization requirements for the sale, supply, transfer or export of arms and related materiel to third countries, and authorization requirements for services related to military activities.
 - The penalties determined by the Republic of Latvia as regards infringements of the restrictive measures imposed by international organizations are set out in *Criminal Law*⁶ of the Republic of Latvia, adopted on 17 June 1998, in particular section 84.
