Addendum

1. In the report of the Secretary-General on the implementation of General Assembly resolutions [55/235](#) and [55/236](#) ([A/79/318](#)), illustrative information was provided in annex III on the effective rates of assessment for peacekeeping operations for the period from 1 January 2025 to 31 December 2027. Those tables were based on the updated composition of levels of contribution for peacekeeping operations and the regular budget scale of assessments for the period 2025–2027, included in the report of the Committee on Contributions on its eighty-fourth session ([A/79/11](#) and [A/79/11/Add.1](#)), which used the scale methodology employed for the scales of assessments for the periods 2001–2003, 2004–2006, 2007–2009, 2010–2012, 2013–2015, 2016–2018, 2019–2021 and 2022–2024, as well as new gross national income and other data.

2. Following the adoption of a new scale of assessments for the period 2025–2027¹ and the endorsement of the updated composition of levels for the period 2025–2027,² the effective rates of assessment for peacekeeping operations in 2025–2027 are set out in the annex to the present report.

^a At the time of the adoption of General Assembly resolution [79/250](#), the Chair of the Fifth Committee and the President of the General Assembly stated the understanding that, on an exceptional basis for the 2025–2027 scale period only, three countries in level B – the Bahamas, Bahrain and Saudi Arabia – would be afforded discounts of 7.5 per cent to their assessment rates and that those discounts should be borne on a pro rata basis by the permanent members of the Security Council.
