#### Annotations

#### 1. Election of officers

In accordance with rule 18 of the rules of procedure of the Economic and Social Council, each year, at the commencement of its first meeting, the Committee elects its Chair and four Vice-Chairs. In accordance with rule 19, Bureau members are eligible for re-election. One Vice-Chair is later designated also to serve as Rapporteur.

#### 2. Adoption of the agenda and other organizational matters

In accordance with rule 13 of the rules of procedure of the Council, the Committee, at the beginning of each session, after the election of its officers, adopts the agenda for that session on the basis of the provisional agenda. The provisional agenda for the current session was approved by the Council in its decision 2024/341.

## 3. Applications for consultative status with the Council and requests for reclassification received from non-governmental organizations

#### (a) Deferred applications for consultative status and requests for reclassification

The Committee will consider applications and requests for reclassification deferred from the sessions of previous years.
