### Operational activities of the United Nations for international development cooperation

**Draft resolution submitted by the Vice-President of the Council, Albert Ranganai Chimbindi (Zimbabwe), on the basis of informal consultations on draft resolution [E/2023/L.18](#)**

### **Progress in the implementation of General Assembly resolution [75/233](#) on the quadrennial comprehensive policy review of operational activities for development of the United Nations system**

*The Economic and Social Council,*

*Reaffirming* General Assembly resolution [75/233](#) of 21 December 2020 on the quadrennial comprehensive policy review of operational activities for development of the United Nations system, including its general guidelines,

*Reaffirming also* General Assembly resolution [72/279](#) of 31 May 2018 on the repositioning of the United Nations development system in the context of the quadrennial comprehensive policy review of operational activities for development of the United Nations system and Assembly resolutions [73/248](#) of 20 December 2018, [74/238](#) of 19 December 2019, [76/220](#) of 17 December 2021 and [77/184](#) of 14 December 2022 on operational activities for development of the United Nations system, as well as Assembly resolution [76/4](#) of 28 October 2021 on the review of the functioning of the reinvigorated resident coordinator system, including its funding arrangement,

*Recalling* its resolutions [2019/15](#) of 8 July 2019, [2020/23](#) of 22 July 2020 and [2022/25](#) of 22 July 2022, in which the Council reviewed the progress in the implementation of General Assembly resolutions [71/243](#) of 21 December 2016 and [75/233](#), respectively, on the quadrennial comprehensive policy review of operational activities for development of the United Nations system,



1. *Takes note* of the report of the Secretary-General on the implementation of General Assembly resolution [75/233](#) on the quadrennial comprehensive policy review of operational activities for development of the United Nations system;<sup>1</sup>

2. *Welcomes* the ongoing efforts of the Secretary-General on the repositioning of the United Nations development system, and acknowledges the progress achieved thus far in advancing all reform mandates contained in General Assembly resolutions [71/243](#) and [72/279](#);

3. *Recognizes* that the presence of the entities of the United Nations development system at the country level should be tailored to meet the specific challenges and needs of programme countries, and reaffirms that the resident coordinator system should continue to support government efforts, including to achieve the 2030 Agenda for Sustainable Development,<sup>2</sup> and that the focus of the resident coordinator system should remain sustainable development, with the eradication of poverty in all its forms and dimensions as its overarching objective, consistent with the integrated nature of the 2030 Agenda and in line with the United Nations Sustainable Development Cooperation Framework and national leadership and ownership;

4. *Welcomes* the progress made in strengthening the United Nations development system's oversight, system-wide evaluations and results-based management and reporting to the General Assembly and the Economic and Social Council, as well as the efforts made on providing more detailed and timely information, and encourages the continued strengthening of such evidence-based reporting, in compliance with General Assembly resolution [75/233](#);

5. *Notes* the establishment of the United Nations Sustainable Development Group System-wide Evaluation Office, re-emphasizes the need to ensure the independence, credibility and effectiveness of the Evaluation Office, and in this regard looks forward to receiving reports to the Economic and Social Council on the functioning and work of the Office, especially its findings, recommendations and follow-up;

6. *Welcomes* the update on the funding compact and its indicators, takes note of the progress made in the fulfilment of the funding compact commitments while expressing concern that such progress remains uneven, continues to note the voluntary nature of the funding compact and to urge the full implementation by Member States and entities of the United Nations development system of commitments made in the funding compact, and further looks forward to the upcoming inclusive dialogue to be launched by the Chair of the United Nations Sustainable Development Group on the best way forward regarding the funding compact;

7. *Emphasizes* that core funding provides United Nations entities the flexibility to allocate funds to priority areas in their strategic plans, including underfunded areas, and in this regard stresses the urgent need to address the continued imbalance between core and non-core resources by meeting the funding compact commitment of 30 per cent core resources by 2023;

8. *Urges* Member States and other contributors providing non-core contributions, to the extent practicable, to make them more flexible and aligned with the United Nations Sustainable Development Cooperation Framework, as well as the strategic plans of United Nations funds, programmes and specialized agencies, to

reduce transaction costs, and to give priority to pooled, thematic and joint funding mechanisms, in particular the Joint Sustainable Development Goals Fund, applied at all levels;

9. *Urges* the entities of the United Nations development system, through their governing bodies, to continue taking concrete steps to address on a continuous basis the decline of the share of core contributions and the growing imbalance of core and non-core resources, including but not limited to those set out in paragraph 56 (a) to (c) of General Assembly resolution [75/233](#);

10. *Re-emphasizes* that adequate, predictable and sustainable funding of the resident coordinator system is essential to delivering a coherent, effective, efficient and accountable response in accordance with national needs and priorities, and re-commits to providing sufficient funding for the resident coordinator system, in line with General Assembly resolution [76/4](#), expresses concern regarding the continual shortfall of funding to the resident coordinator system, looks forward to the report of the Secretary-General to the General Assembly with recommendations for its consideration, taking note of the report entitled “Review of the functioning of the resident coordinator system: rising to the challenge and keeping the promise of the 2030 Agenda for Sustainable Development”<sup>3</sup> and the recommendations therein, notes the critical importance of dialogue with Member States about the resident coordinator system, and in this regard looks forward to the launching of a transparent and inclusive consultation process as mentioned in the report of the Secretary-General to the 2023 operational activities for development segment of the Economic and Social Council,<sup>4</sup> before a formal proposal is submitted to the General Assembly;

11. *Requests* continued efforts to improve the performance of personnel of the United Nations development system, including the resident coordinator system, at all levels, and in this regard reaffirms the importance of the full implementation of the Management and Accountability Framework;

12. *Takes note* of the report of the Chair of the United Nations Sustainable Development Group on the work on the Development Coordination Office,<sup>5</sup> including on the operational, administrative and financing aspects of the activities of the Office, as well as the report on the system-wide contribution to the advancement of the Sustainable Development Goals, and looks forward to receiving on an annual basis an evidence-based, comprehensive, analytical and more detailed report to the Economic and Social Council at its operational activities for development segment, to include detailed financial, budgetary and expenditure data on the results of the work of resident coordinators on the ground in all future reporting on the implementation of the reinvigorated resident coordinator system;

13. *Welcomes* the contributions of the resident coordinator system to the results of the repositioned United Nations development system and takes note with appreciation of the resident coordinator system results framework that emerged from the consultative process conducted by the Chair of the United Nations Sustainable Development Group, and urges the Development Coordination Office to continue to use the framework to report on the work and performance of the resident coordinator system at all levels and to adjust it, as necessary, in line with the quadrennial comprehensive policy review mandates;

14. *Notes* the findings of the report of the Chair of the United Nations Sustainable Development Group on progress made in gender balance among resident

coordinators,<sup>6</sup> requests that gender balance continue to be ensured, and that further measures be taken to enhance geographical representation with a view to improving representation of developing countries, and in this regard re-emphasizes the need for resident coordinators and resident coordinators pool members to have adequate, diverse and relevant expertise and skill sets, and sufficient leadership, prerogative, impartiality, management tools, ongoing training and mentoring to effectively fulfil their mandate, as referenced in paragraphs 88, 90 and 92 of General Assembly resolution [75/233](#);

15. *Stresses* the need to continue to improve the transparency, accountability and responsiveness of the United Nations development system to the priorities and needs of programme countries, including building the capacity of the United Nations development system, and ensuring its ongoing, adequate and tailored capacity development at country level;

16. *Reiterates its request* to the entities of the United Nations development system that have not already done so to consolidate their annual reporting on the implementation of the quadrennial comprehensive policy review within their annual reporting on the implementation of their strategic plans and to continue to improve the quality of their annual reports to the Economic and Social Council, including to reflect their respective contributions to the work of the United Nations development system;

17. *Urges* entities of the United Nations development system with operational activities for development that have not done so to fully align their strategic plans and their strategic planning and budgeting cycles with the quadrennial comprehensive policy review, taking into account their respective mandates;

18. *Takes note* of the progress in realizing efficiency gains, and encourages all entities of the United Nations development system to strengthen work in implementation of harmonized business practices and realizing efficiency gains, including through the establishment of common premises, where possible;

19. *Also takes note* of the checklist<sup>7</sup> on the implementation of General Assembly resolution [72/279](#) by United Nations development system entities, circulated by the Chair of the United Nations Sustainable Development Group as a tool to facilitate the oversight role of the governing bodies of the United Nations development system entities in line with paragraph 14 of General Assembly resolution [76/4](#), and encourages those United Nations development system governing bodies that have not yet done so to consider and decide on the use of the checklist for regular updates on the implementation of General Assembly resolution [72/279](#);

20. *Requests* the United Nations development system to continue supporting programme countries to leverage robust partnerships, in accordance with national development policies, plans, priorities and needs, with development partners and relevant stakeholders, including international financial institutions, civil society and the private sector, that can positively support national development efforts and contribute to the achievement of the Sustainable Development Goals;

21. *Notes* the Secretary-General's call to ensure that the regional architecture is fit for purpose, and stresses the importance of leveraging regional assets in order to scale up, inter alia, country-level impact and ensuring that expertise is accessible across the United Nations system, including expertise of non-resident entities;

22. *Also notes* the forthcoming quadrennial comprehensive policy review in 2024, and in this regard requests the Secretary-General to provide status reporting on the implementation of all provisions and mandates contained in General Assembly resolution [75/233](#), including integrating and mainstreaming provisions and mandates, such as those outlined in the quadrennial comprehensive policy review monitoring framework and those on the acceleration of the 2030 Agenda and its Sustainable Development Goals, in advance of the quadrennial comprehensive policy review negotiations, and following open and inclusive informal consultation with Member States, which could be done through, inter alia, briefing notes, informal briefings, and case studies with emphasis on development results to inform on possible gaps and challenges to be considered by Member States, with a view to optimizing their engagement with and provide guidance to the United Nations development system;

23. *Welcomes* the discussions at the 2023 operational activities for development segment, and requests the Secretary-General to continue to provide briefing notes and informal briefings on progress in the implementation of General Assembly resolution [75/233](#) in preparation for the General Assembly resolution on the operational activities for development of the United Nations system to be negotiated at the seventy-eighth session of the General Assembly, ahead of the 2024 operational activities for development segment.
